### SUBJECT: SET A PUBLIC HEARING FOR THE FISCAL YEAR 2023-2024 SANITARY SEWER SERVICE AND USE CHARGE AND STORM SEWER SERVICE CHARGE ASSESSMENTS

### **RECOMMENDATION**

Adopt a resolution:

- (a) Setting a Public Hearing for <u>Tuesday, August 8, 2023, at 1:30 p.m.</u>, or as soon thereafter as the matter may be heard to approve the placement of the 2023-2024 annual Sanitary Sewer Service and Use Charge and Storm Sewer Service Charge assessments on the 2023-2024 Santa Clara County Secured Property Tax Roll based upon the annual Sanitary Sewer Service and Use Charge and Storm Sewer Service Charge reports of the Director of Finance;
- (b) Directing the Director of Finance to file the Fiscal Year 2023-2024 annual Sanitary Sewer Service and Use Charge report with the City Clerk on or before July 14, 2023, instead of July 5, 2023; and
- (c) Directing the City Clerk to publish notice of the filing of the Director of Finance Reports, and the time and place of the Public Hearing.

#### **SUMMARY AND OUTCOME**

Adoption of the proposed resolution will facilitate the scheduling and public notification of a public hearing to be conducted by the City Council on Tuesday, August 8, 2023, whereby the Sanitary Sewer Service and Use Charges (SSSUC) and Storm Sewer Service Charges (SSSC) assessments may be approved for placement on the 2023-2024 Annual Santa Clara County (County) Secured Property Tax Roll, and allow additional time necessary to provide the most complete and current listing for compiling the 2023-2024 SSSUC report to be approved.

### **BACKGROUND**

Section 15.12.550 of the San José Municipal Code requires the Director of Finance to file a written report with the City Clerk on or before the fifth day of July of each year, or such other date or dates as the City Council may specify by resolution, regarding the assessment of the annual SSSUC. Section 15.16.1410 of the San José Municipal Code requires the Director of Finance to file a written report each year with the City Clerk, at least 15 days in advance of the Public Hearing on the assessment. These reports provide a list of all parcels located within the City subject to SSSUC and SSSC, including the annual service and use charges to be placed on the County Secured Property Tax Roll for the respective fiscal year. Sections 15.12.550 and 15.16.1430 of the San José Municipal Code require the City Clerk to cause notice of the filing of the Director reports, and the time and place of the Public Hearing on the assessments to be published in a newspaper of general circulation within the City.

### ANALYSIS

Staff recommends the filing date for the SSSUC assessment report be moved from July 5, 2023 to July 14, 2023, to accommodate the City Customer Information System billing process and to allow staff additional time to prepare the most complete and current SSSUC listing. The SSSC assessment report will also be filed on or about July 14, 2023, prior to publication by the City Clerk.

The Finance Department requests the Public Hearing regarding the placement of the 2023-2024 SSSUC and SSSC assessments on the County Secured Property Tax Roll be set for <u>Tuesday, August 8</u>, <u>2023, at 1:30 p.m.</u>, or as soon thereafter as the matter may be heard. The final report of the 2023-2024 SSSUC and SSSC assessments is due to the County Tax Assessor no later than August 18, 2023, to ensure placement on the 2023-2024 County Secured Property Tax Roll.

#### **EVALUATION AND FOLLOW-UP**

The Director of Finance will file both the Fiscal Year 2023-2024 annual SSSUC and SSSC reports with the City Clerk on or before July 14, 2023. The Finance Department will prepare a memorandum for the August 8, 2023 City Council meeting recommending City Council conduct a Public Hearing and approve the Fiscal Year 2023-2024 annual SSSUC and SSSC assessments, as presented in the reports for purpose of placement on the 2023-2024 annual County Secured Property Tax Roll, with any modifications City Council may make based on public testimony heard on August 8, 2023.

## **COST SUMMARY/IMPLICATIONS**

This action will result in the placement of approximately \$215 million of SSSUC and SSSC assessments on the 2023-2024 County Secured Property Tax Roll. The annual SSSUC and SSSC reports of the Director of Finance will be published on or before July 14, 2023 and include a more precise revenue estimate.
