## **RESOLUTION NO.**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE (1) APPROVING THE WILLOW GLEN COMMUNITY BENEFIT AND IMPROVEMENT DISTRICT ANNUAL **REPORT FOR FISCAL YEAR 2023-2024 AS FILED OR** MODIFIED BY THE CITY COUNCIL, AND CONFIRMING AND LEVYING THE INDIVIDUAL ASSESSMENTS AS PROPOSED OR MODIFIED BY THE CITY COUNCIL; AND (2) DIRECTING THE DIRECTOR OF PUBLIC WORKS TO DELIVER THE ASSESSMENT ROLL TO THE COUNTY OF SANTA CLARA FOR COLLECTION WITH THE **PROPERTY TAXES** 

WHEREAS, the Willow Glen Community Benefit and Improvement District (hereinafter "Willow Glen CBID") was approved by property owners and adopted by the Council of the City of San José (hereinafter "City Council") on December 8, 2008 to raise funds for sidewalk operations, beautification, order and parking, district identity and streetscape improvements, and marketing and promotion services for the downtown Willow Glen area; and

WHEREAS, pursuant to Chapter 14.31 of Title 14 of the San José Municipal Code which incorporates and modifies the California Streets and Highways Code "Property and Business Improvement District Law of 1994", and the agreement between the City of San José (hereinafter "City") and the Willow Glen Business Association, the Willow Glen Community Benefit Improvement District Annual Report for Fiscal Year July 2023-June 2024 (hereinafter "Assessment District Report"), was submitted to the City Council; and

WHEREAS, the Assessment District Report recommends an increase in the assessment of five percent (5.00%) for Fiscal Year 2023-2024 to keep pace with increases in the San Francisco-Oakland-Hayward, CA Consumer Price Index; and WHEREAS, as a property owner within the Willow Glen CBID, the City's assessment will be approximately \$12,637, which funds are included in the City's proposed Fiscal Year 2023-2024 budget; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

- 1. The Willow Glen Community Benefit Improvement District Annual Report for Fiscal Year July 2023-June 2024, as filed or modified by the City Council, is approved.
- 2. The individual assessments as proposed or modified by the City Council, including the assessment on City-owned property of approximately \$12,637, are confirmed.
- 3. The levying of assessments in the Willow Glen CBID for Fiscal Year 2023-2024 in accordance with this Resolution is hereby authorized.
- 4. The Director of Public Works is directed to deliver the assessment roll to the County of Santa Clara for collection with the property taxes.
