RECOMMENDATION

- 1. Direct the City Clerk to set a City Council Study Session entitled City Council Governance: Developing Norms and Procedures in August or September 2023.
- 2. Direct the City Manager and City Attorney to develop an agenda and facilitate the Study Session with the objectives and goals mentioned below.

DISCUSSION

The City Council can be proud of the work we have accomplished in the first five months of this year. We've worked through the budget together and tackled complex public policy questions, all while our new councilmembers and new mayor have transitioned into their roles, set up their offices, and set priorities for their staff. The pace has sometimes been hectic, but it's evident that as a Council we are willing to work hard and are deeply committed to serving our community.

As the budget process draws to a close, we believe that our work as a Council can be enhanced further by taking a moment to consider how we can work together most effectively. In any workplace, it's important to have norms that establish shared expectations for how colleagues will work with each other. The same is true for the City Council—shared norms and procedures can help us conduct our business efficiently and effectively, deliberate and make decisions on challenging issues, and work collaboratively with City staff—all critical to organizational success.

We recommend that the City Council hold a study session in August or September for the purpose of discussing shared norms and procedures that can enhance our work. The City

Manager and City Attorney should develop an agenda for this study session and facilitate the discussion. The bullet points below highlight some of the areas the study session should cover and the importance of developing City Council norms and procedures:

- 1. Ensures Consistency and Efficiency: By establishing clear norms and procedures, the City Council can operate with consistency and efficiency—helping ensure all meetings and decision-making processes are carried out in a timely and orderly manner, and that everyone involved knows what to expect.
