The tracks as a visual barrier do not end the public nuisance which consist of fires, disturbances, dumped vehicles, crime, accumulation of trash, generators and hazardous material.

The EIH in our area is taking public service away because where they were built there was nothing before. Now the police and EMS are on site daily, sometimes twice a day to address issues in the EIH community. Where are the "enhanced services" we were promised?

You admitted the encampment predated the Eih which reflects the fact that the city is lacking a plan for public nuisance in the known hot spots and instead letting a public nuisance perpetuate.

The combination of ongoing encampments and lack of public services surrounding the EIHs is clearly not improving the area as we only see the opposite happening. Therefore you need to abate the public nuisances in the area, create a plan to fix the problem and provide us with enhanced services as promised.

Attached are additional pics of the surrounding area to show everyone that the conditions around the Eih are not what is being presented or promised. This includes pics of the large encampment that eventually caught fire this last summer.

I am writing to let you know that I support council member Jimenez's memo 8.4 item with regards to the over-concentration of EIH sites in the D2 and D10 area.

South San Jose has already provided and continues to offer multiple solutions to assist and now it is time for the rest of the council districts to do their part.

According to the city website there are a total of 6 Bhc/EIH communities:

 5. Eih #3 D6 121 Beds
 6. Eih #4 D3 96 Beds
- Total 598 beds of which 51% are in D2

In addition we will have Rv Safe Parking at Santa Teresa Vta. We also have had an overnight warming center and safe parking at Southside Community Center.

The community does NOT approve the sites suggested by the City Manager Omar Passons (Cottle Vta, Via Del Oro and Bernal). Instead we are asking that you find alternate sites in council districts that are not bearing their weight (D1, D5, D8 and D9).

I would like to see the council recommend new and back up sites in districts that currently do not offer Eih or Bhc, in other words NO more sites (new or backup) in South San Jose period until all districts do their part. Our first responders (Firehouse #27) and the Beautify crew are already overwhelmed.

The city needs to focus on creating equitable distribution throughout the ENTIRE city.

I support councilmember Jimenez's memo and are asking you to do the same.



I am writing to express my concerns regarding the cost associated with the proposed RV site at 1300 Berryessa Road. According to the Memorandum of item 8.4, "the total cost to lease, operate and maintain the site over a five-year period exceeds \$24 million." With 85 RV lots planned on site, the cost per RV lot is estimated to be over \$56,000 per year, or over \$4,600 per month. With that monthly budget, you can rent a luxury 2B+ apartment in San Jose. I strongly doubt that is an efficient way to use the tax money. If investing in this RV site, why wouldn't the city just rent real apartments for the homeless individuals living in RVs, for they are looking for long term housings? Not even to mention the potential negative impact this site RV could bring to the nearby community.

I support Sergio Jimenez's recent memorandum to eliminate additional EIHC sites because D2 residents deserve to have certainty that NO additional emergency interim housing will be developed in our neighborhoods.

We currently already have a total of 500 units of emergency interim housing already built, planned, or under construction in District 2. I stand with Sergio Jimenez to firmly oppose over-concentrating emergency housing in South San Jose. I also believe this housing should be located equitably among all the districts that make up San Jose, particularly in neighborhoods that currently do not provide any shelter for the unhoused and in areas that are safer than freeway on ramps. I wanted to express 100% of my support for CM Jimenez's memo about the over-concentration of EIH sites in South Jose and the difficulties. As mentioned by CM Jimenez, D2 has hosted multiple temporary solutions already.

We need more equity in distributing temporary sites/ solutions because it is a public service. People should be able to utilize the EIH in their communities and not have to go to a different area or city to access these services.

We also need more quick-build communities that are permanent solutions since we lack public vacant land for these projects and conventional affordable housing takes years to be built.

Austin developed quick-build permanent housing communities and we can do it. Shelters do not solve homelessness but permanent housing options do.

And “enhanced services” should be included in the operational cost for each community. The residents should be allowed to stay until they find permanent housing solutions based on their needs. (51% housed, 39% uncertainty).

Priority should be given to seniors who should not end up on the streets and rental assistance should be available. No senior should be left in the streets.

As stated by multiple community leaders, the lack of the promised “enhanced services” and “neighborhood preference” is causing issues in the South San Jose Area. Our area is considered a “low priority area” by BeautifySJ. The concept of equity in public services may be unclear in our area due to “low priority”.









Let the area absorb and acclimate to those additions before planning additional sites in the immediate area. This concentration of interim units in such a small area of the South San Jose is contrary to the original intent by the City to spread these sites throughout San Jose and is not a recipe for overall success of the program long-term. It is also important to note that when the Council focuses so much on District lines, it obscures the fact that just because a site is in a different District across the District line, it still can have impacts in both Districts. There should be a buffer of time and space before introducing additional EIH's in an area, not based solely on district lines.

Second, supporting the Mahan, Kamei, Cohen, Foley Memorandum as it pertains to ***"Prioritizing calls in the immediate vicinity of interim housing and safe parking sites to provide enhanced neighborhood services through BeautifySJ."*** I strongly believe that these sites should be examples to the rest of the City to show how they can thrive in neighborhoods and over time, be more acceptable in all areas of the City. Allowing the surrounding areas to fall into blight tarnishes the reputation of the interim communities, whether the blight is related or not. The average resident driving by will not understand whether blight is a direct result of the EIH or not, but the reputation will still be tarnished and they will associate the two. Don't give them the opportunity to associate blight with the interim solutions by keeping areas around the interim sites blight-free.

Third, supporting Councilmember Batra's Memorandum as it pertains to ***including an analysis of the costs for providing enhanced cleanup services in a one-mile radius of the perimeter of the site with the goal to make the EIH sites more welcome by the local residents rather than being rejected by the neighboring communities.*** Also, to explore innovative solutions to provide individual bathrooms in each movable cabin. Studies have shown that units with individual bathrooms have led to more successful outcomes than those without bathrooms.

Finally, in the Staff Memorandum, I support (a) ***Pursue the 1300 Berryessa Road site for a new Recreational Vehicles Communities Supportive Parking Program***; and (c) ***Pursue the Valley Water Cherry Avenue site for Emergency Interim Housing*** for the Governor's State Small Home Initiative.

I live around the corner from the Branham and Monterey Road site that is currently under construction to house over 200 unhoused persons. In addition to the neighborhood being impacted by the ongoing construction we are also seeing an increase of homeless people setting up unsightly encampments in the residential neighborhoods, shoplifting from the local stores, stealing groceries and the grocery carts, panhandling on the street corners, harassing the school children on their way to and from school and the increase of crimes (per SpotCrime report). The amount of garbage dumping has increased, even with the city's code enforcement being used. Our neighborhood has become a place where security is on drastic decline.

Why has the burden of housing the growing unhoused population been thrust upon District 2 and South San Jose? We pay property taxes, we are registered voters, we take pride in our homes and our neighborhood!
