SUBJECT: PROPOSED CHANGES TO THE SPENDING PRIORITIES AND PERCENTAGE ALLOCATION OF MEASURE E REAL PROPERTY TRANSFER TAXES

#### RECOMMENDATION

- (a) Adopt a resolution related to estimated 2023-2024 Measure E revenues:
  - (1) Approving by two-thirds (2/3rds) affirmative vote the following percentage allocations as included in Manager's Budget Addendum #2 of the 2023-2024 Proposed Operating Budget for the spending of Measure E revenues totaling \$50.0 million anticipated to be received in Fiscal Year 2023-2024:
    - (i) 5% for administration with the remaining revenue allocated as follows:
    - (ii) 0% for the creation of new affordable housing for extremely low-income households;
    - (iii) 0% for the creation of new affordable housing for low-income households;
    - (iv) 0% for the creation of new affordable housing for moderate-income households;
    - (v) 20% for homeless prevention, gender-based violence programs, legal services and rental assistance; and
    - (vi) 80% for homeless support programs including shelter construction and operations.
  - (2) In the alternative to (a)(1), approve by majority vote to maintain the current allocation under Council Policy 1-18, Section 22, of Measure E spending priorities for the 2023-2024 Proposed Budget for the spending of Measure E revenue totaling \$50.0 million anticipated to be received in Fiscal Year 2023-2024;
  - (3) In the alternative to (a)(1) or (a)(2), approve by two-thirds (2/3rds) affirmative vote an alternative allocation for Measure E spending priorities for the 2023-2024 Proposed Budget for the spending of Measure E revenue totaling \$50.0 million anticipated to be received in Fiscal Year 2023-2024;

- (b) Adopt a resolution related to prior year Measure E revenues:
  - (1) Approving by two-thirds (2/3rds) affirmative vote the following percentage allocations as included in Manager's Budget Addendum #2 of the 2023-2024 Proposed Operating Budget for the combined spending of uncommitted Measure E revenues totaling \$87.0 million, comprised of \$17.1 million from Fiscal Year 2020-2021, \$20.4 million from Fiscal Year 2021-2022, and \$49.5 million from Fiscal Year 2022-2023:
    - (i) 22% for administration, which is inclusive of a revenue stabilization reserve to protect funding commitments from an anticipated revenue shortfall, with the remaining revenue allocated as follows:
    - (ii) 21% for the creation of new affordable housing for extremely low-income households;
    - (iii) 57% for the creation of new affordable housing for low-income households;
    - (iv) 0% for the creation of new affordable housing for moderate income households;
    - (v) 4% for homeless prevention, gender-based violence programs, legal services and rental assistance; and
    - (vi) 18% for homeless support programs including shelter construction and operations.
  - (2) In the alternative to (b)(1), approve by two-thirds (2/3rds) affirmative vote the following percentage allocations as included in the Mayor's June Budget Message for Fiscal Year 2023-2024 for the combined spending of uncommitted Measure E revenues totaling \$87.0 million, comprised of \$17.1 million from Fiscal Year 2020-2021, \$20.4 million from Fiscal Year 2021-2022, and \$49.5 million from Fiscal Year 2022-2023:
    - (i) 17% for administration, which is inclusive of a revenue stabilization reserve to protect funding commitments from an anticipated revenue shortfall, with the remaining revenue allocated as follows:
    - (ii) 20% for the creation of new affordable housing for extremely low-income households;
    - (iii) 31% for the creation of new affordable housing for low-income households;
    - (iv) 0% for the creation of new affordable housing for moderate income households;
    - (v) 4% for homeless prevention, gender-based violence programs, legal services and rental assistance; and
    - (vi) 45% for homeless support programs including shelter construction and operations.
  - (3) In the alternative to (b)(1) or (b)(2), approve by a majority vote to maintain the current allocation under Council Policy 1-18, Section 22, of Measure E spending priorities for the combined spending of uncommitted Measure E revenue totaling \$87.0 million, comprised of \$17.1 million from Fiscal Year 2020-2021, \$20.4 million from Fiscal Year 2021-2022, and \$49.5 million from Fiscal Year 2022-2023.
  - (4) In the alternative to (b)(1), (b)(2), or b(3), approve by two-thirds (2/3rds) affirmative vote an alternative allocation to the 2023-2024 Proposed Budget, for the combined spending of uncommitted Measure E revenue totaling \$87.0 million, comprised of \$17.1 million from Fiscal Year 2020-2021, \$20.4 million from Fiscal Year 2021-2022, and \$49.5 million from Fiscal Year 2022-2023.

#### **SUMMARY AND OUTCOME**

Approval of the actions included in this memorandum will result in the allocation of Measure E revenues to support affordable housing development, homeless prevention, homeless support, and related program administration costs.

## **BACKGROUND**

On March 3, 2020, San José voters approved Measure E which established a transfer tax on real estate transactions in which the purchase price exceeds \$2 million. All revenues received from Measure E are deposited into the General Fund and can be used for any governmental purpose. In June 2020, the City Council amended City Council Policy 1-18 to include a new Section 22 that specifies the spending priorities and percentage allocations for Measure E revenue, along with a process for making changes to the percentage allocations. Any modification of the percentage allocations requires:

- 60-day public notice in advance of the effective date of the proposed allocation change;
- At least two public hearings prior to City Council action; and
- Two-thirds vote of the City Council.

Following the above procedure, on April 19, 2022, the City Council approved modifications to the spending priorities and the allocation percentages of Measure E revenue under Section 22 of Council Policy 1-18 as detailed in the table below:

Measure E Spending Priorities (Does not include 5% Administration	n)

Homeless Support Programs Including Shelter Construction and Operations	15%

Measure E also allows 5% of the revenue to be used for administrative purposes. This percentage is taken before the percentage allocations are applied.

City Council's approval of the Mayor's March Budget Message for Fiscal Year 2023-2024 included direction to the City Manager to explore the use of uncommitted Measure E resources for reallocation to homeless prevention, support, and management to fund various programmatic

initiatives in the March Budget Message to reduce unsheltered homelessness, including the doubling of the 2023-2024 homelessness prevention category on a one-time basis.

Consistent with City Council Policy 1-18, Section 22, the Housing Department posted a <u>public</u> notice on May 2, 2023, 60 days in advance of the proposed changes to the spending priorities becoming effective. The first City Council public hearing was Tuesday, May 16, 2023, and the second City Council public hearing will be held on Monday, June 12, 2023.

## **ANALYSIS**

The Administration has interpreted "uncommitted" Measure E revenues as resources that have been allocated to the various spending categories identified in City Council Policy 1-18, but not yet formally committed to a specific project or use by the City Council. The total amount of Measure E revenue subject to reallocation is \$137.0 million: \$87.0 million of revenues received in 2022-2023 and earlier, and \$50.0 million anticipated to be received in 2023-2024.

The 2023-2024 Proposed Operating Budget response to City Council direction for the consideration of the reallocation of Measure E is further detailed in Manager's Budget Addendum #2, One-Time Changes to Measure E Revenue Percentage Allocations<sup>1</sup>, which includes a reallocation of both prior year revenues and 2023-2024 revenues. In accordance with City Council Policy 1-18, approval of the Measure E allocations included in the 2023-2024 Proposed Operating Budget would require a two-thirds vote of the City Council. Two-thirds approval of Recommendations (a)(1) and (b)(1) would approve the allocation of Measure E revenues as included in the 2023-2024 Proposed Operating Budget.

The Mayor's June Budget Message for Fiscal Year 2023-2024<sup>2</sup> recommends an alternative spending plan for Measure E revenues that would include a reallocation of prior year revenues (Fiscal Years 2020-2021, 2021-2022, and 2022-23), but the allocation of 2023-2024 revenues would remain in accordance with existing policy. Approving the Measure E spending allocation recommended in the Mayor's June Budget Message would require a two-thirds vote for prior year allocations, but only a simple majority vote for allocation of 2023-2024 revenues. A simple majority approval of (a)(2) and a two-thirds approval of (a)(2) would approve the allocation of Measure E revenues as included in the Mayor's June Budget Message.

A memorandum authored by Councilmembers Davis, Torres, and Ortiz<sup>3</sup> regarding the June Budget Message recommends an allocation of both prior year and 2023-2024 Measure E revenues in accordance with existing policy. Approving the spending allocation recommended

by Councilmembers Davis, Torres, and Ortiz would only require a simple majority vote for both prior year and 2023-2024 allocations. A simple majority approval of (a)(2) and (b)(3) would approve the allocation of Measure E revenues as included in the memorandum from Councilmembers Davis, Torres, and Ortiz.

A memorandum authored by Councilmembers Cohen and Jimenez<sup>4</sup> regarding the June Budget Message recommends a reallocation of prior year revenues and 2023-2024 revenues. Approving the Measure E spending allocation recommended by Councilmembers Cohen and Jimenez would require a two-thirds vote for prior year allocations and a two-thirds vote of 2023-2024 revenues. A two-thirds majority approval of (a)(3) and a two-thirds approval of (b)(4) would approve the allocation of Measure E revenues as included in the memorandum from Councilmembers Cohen and Jimenez.

Should other City Councilmembers submit a memorandum on the June Budget Message that would impact the allocation of Measure E revenues, the Administration will issue a replacement memorandum so that all alternatives can be considered within this memorandum.

### **EVALUATION AND FOLLOW-UP**

Regardless of City Council action on this agenda item, spending percentages for 2024-2025 would be unaffected and continue under the existing percentages in City Council Policy 1-18, absent future City Council direction.

## **COST SUMMARY/IMPLICATIONS**

The amount of uncommitted Measure E resources received in 2020-2021, 2021-2022 and 2022-2023 totals \$87.0 million, and the Measure E revenue estimate for 2023-2024 is \$50.0 million. The total amount of Measure E revenues subject to allocation is \$137.0 million. The spending allocation for each plan is summarized below, ordered from left to right by date of publication, with additional detail and percentage allocations provided in Attachments 1-4.

#### COMMISSION RECOMMENDATION/INPUT

As described in more detail in Manager's Budget Addendum #47, Housing and Community Development Commission as Measure E Oversight Committee<sup>5</sup>, at its meeting on May 11, 2023, the Housing and Community Development Commission voted to reject (11-0 with 3 commissioners absent) the one-time revisions to the spending priorities and percentage allocation of Measure E real property transfer taxes as included in the 2023-2024 Proposed Operating Budget. At that meeting the Commission also approved drafting a letter to the City Council regarding its opposition to reallocating funds, reflecting comments given during the
