**Re: Opposing Proposed Changes to the Spending Priorities and Percentage Allocations  
Measure E Real Property Transfer Taxes (Item 3.5 on June 13, 2023 Agenda)**

Dear Mayor Mahan and Members of the City Council,

On behalf of the Santa Clara County Democratic Party, which represents over 500,000 Democratic voters in Santa Clara County, I am writing to urge you to maintain the current spending priorities and percentage allocations of Measure E Real Property Transfer Tax proceeds.

The ballot description for Measure E promised the funds would be used for “providing affordable housing for seniors, veterans, disabled, and low-income families and helping homeless residents move into shelters/permanent housing.” The proposed diversion of Measure E proceeds to fund only or primarily short-term housing would break this promise.

Furthermore, such a diversion would be short-sighted and would ignore evidence that demonstrates clearly that an adequate supply of affordable housing, including permanent supportive housing, is essential to meaningfully address homelessness. Non-profit housing developers and government agencies need a consistent and reliable stream of funding to ensure we have an adequate supply of affordable housing in the years ahead.

If we fail to invest in affordable housing, consistently over time, many community members moved into short term housing will return to experiencing homelessness, as recent experience has shown, and others will be at greater risk of becoming homeless.

I am attaching a resolution adopted by the Santa Clara County Democratic Central Committee on June 1, 2023, opposing the proposed reallocation of Measure E proceeds to fund homeless services and short-term interim housing at the expense of continuing to invest in affordable housing required to provide increased housing security in the long term, including permanent supportive housing.

Please continue to use Measure E funds to provide affordable housing, as the voters were promised.

## **RESOLUTION OPPOSING DIVERSION OF MEASURE E HOUSING FUNDS**

WHEREAS, in 2020 the voters of the City of San José passed Measure E to “fund general City of San José services, including providing affordable housing for seniors, veterans, disabled, and low-income families and helping homeless residents move into shelters/permanent housing”; and

WHEREAS affordable housing in San José continues to fall far short what is needed to protect residents at risk of becoming homeless while also being able to transition those currently experiencing homelessness into stable, permanent housing, and Measure E specifically states that funds will be used to provide affordable housing; and

WHEREAS diverting Measure E funding entirely to interim housing will gravely harm the ability of the City of San José to provide permanent, affordable housing for seniors, veterans, disabled persons, and low-income families, thereby undermining a core promise of Measure E;

NOW THEREFORE BE IT RESOLVED that the Santa Clara County Democratic Party urges the San José City Council to reject the Mayor’s proposal to divert Measure E funds to solely fund interim housing in the 2023-2024 city budget, and to instead ensure that Measure E funds continue to be used to fund both interim housing and affordable permanent housing, as contemplated by voters when they passed Measure E, as part of an integrated approach to transition those experiencing homeless to stable, permanent housing while providing long term housing security for all residents.

Hello again,

I sent the email below the separator on May 18 in support of using Measure E funds for quick-build interim housing to bring our unhoused neighbors indoors sooner rather than later. They cannot wait for permanent housing to be built. They will continue to deteriorate and some will die on the streets. Don't sacrifice the good for the perfect. Measure E funds for the humane treatment of our unhoused neighbors.

Allow me to share with you one more story of another unhoused neighbor in my neighborhood. Daniel [REDACTED] is 41-years-old. He has the mental acuity of a 6-year-old. You cannot converse with him. That's because he's been addicted to illegal drugs for 25 years. His family tried to help. Repeatedly. They have given up. He mostly lives on the street – when he's not in jail. He prefers jail in the winter when it's cold so he breaks the law so that he can be taken indoors. A couple of months ago, he was in the porch of the Five Wounds Rectory Office and would not leave when asked. His erratic behavior led the pastor's assistant to call the police. When they arrived, Daniel kicked one of the officers in the leg. It took six officers to hold him down to hook him up. He is small but had superhuman strength from whatever he was high on. He was locked up for a day or two before being dumped back on the street to make his way back to Little Portugal. Daniel doesn't just need a roof over his head. He needs rehabilitative services. Intensive rehabilitation. Even with help, will he ever be able to function in society? He deserves a chance. He needs to be compelled to receive the services that could afford him a chance. And a roof over his head -- now.

Hello, my name is Davide Vieira and I am a resident of East San Jose in favor of quick-build housing as a way to house our unhoused neighbors sooner rather than much later. I also volunteer at St. Isabel's Kitchen at Five Wounds Church.

Please allow me to introduce you to some of our unhoused neighbors who live on the streets near Five Wounds Church.

Bruno has lived on the street in our neighborhood for many years. He was bitten on his foot by a spider this year. The bite got infected. He couldn't wear a shoe, so he limped around with just a sock on his injured foot. That's because someone stole his bike. He went to Valley Medical Center and spent 12 hours there to no avail. They sent him away after having lost him for three hours when he was in plain sight all along. He had no money to get back to the neighborhood. A kind nurse got him an Uber. Bruno's foot only got worse. He went to Regional Medical Center and was admitted for three days. He was treated and recovered. He could have lost his foot.

Angel is a senior who has lived in her pickup in the neighborhood for years ever since she was injured on the job and couldn't work anymore. She has serious health problems. This past winter, she was admitted to the local OWL. That was great because she could at least get some sleep indoors out of the cold. But the OWLs closed at the end of April. Angel is back on the street in her pickup. What's unique about Angel is that, even though she has nothing but her pickup and monthly SSI, she goes around collecting leftover food from local nutrition programs in the neighborhood to distribute at the encampments in the area. She collects and passes out clothes and toiletries too. That's how she spends her days. She's been waiting for a housing voucher for years. But she still holds out hope. When she gets a house, she plans on sharing it with others.

Anthony looks like Moses. He is dirty and disheveled. I cannot even venture a guess as to the last time he bathed. His legs are dry and chapped. He is constantly scratching his skin. But he is as polite a person as you will ever meet. It's obvious that he has mental health issues. But all he needs and all he asks for is the food that he receives at our soup kitchen.

Carlos is bipolar. His parents have a TRO against him because he can become aggressive and even violent when he's not on his medication. Which is often. He has caused serious property damage in the area over the years. He stalked a female employee at a local community center. Another TRO. When he is on his medication, though, he is approachable and considerate. Someone stole his shoes while he slept recently. He was walking the neighborhood in stocking feet. I saw him with new shoes the next day.

Michael rides his bike. He rides his bike everywhere. All day. We give him a couple of lunches because that's all he will eat all day. He has bad teeth, so he can't eat fruit like apples or pears.

These are our neighbors. They deserve shelter. If that's what quick-build housing can provide them, then that's a start. They have already lived on the street for far too long. Don't let them die there. The perfect is the enemy of the good. Please use Measure E funds to more quickly house our unhoused neighbors.

Re: Fiscal Year 2023– 2024 Budget for Animal Care & Services (“Animal Services”)

Dear Honorable Mayor and City Council:

The Community & Companion Animal Project (“CCAP”) supports the Mayor and City Manager’s proposed Fiscal Year 2023-2024 budget increases for Animal Services and appreciates how the budget reflects the recognition of challenges facing Animal Services and responds to the concerns voiced over the past year.

Converting the temporary overstrength position of Supervisor Shelter Operations to permanent status, and adding more full-time positions, a night shift and a dedicated senior resource for facilities repair and maintenance will improve the shelter’s ability to provide greatly needed support to our community and increase live outcomes for the animals.

The night shift is a critical addition, as it will enable the shelter to provide care for underage kittens, the highest volume and most vulnerable animals at the shelter. The allocation of monies for support of adoption and rescue outcomes is also essential. It will allow more animals in need to move to organizations that can provide the specialized care necessary for such animals to be placed for adoption.

While the proposed budget for Animal Services represents substantial progress, we believe the following matters are still in need of additional funding and attention.

- The data produced and used by the shelter to direct its operations, measure its performance and predict future community needs is incomplete and/or inaccurate. The shelter needs a dedicated IT Business Analyst to review and develop systems and

processes for the collection, use, and transparency of data, including the collection of critical missing data integral to development of a long-term strategy, such as the number of animals turned away at intake and the reasons admission was denied.

- Expanding and staffing the Trap, Neuter & Return (TNR) program for community cats is mandatory. During May the shelter accepted 743 kittens and as of June 6th was holding 340 kittens, representing the majority of the animals in the shelter. The shelter, rescue organizations, and fosters are at or over capacity and animals are being turned away. Friendly community kittens are being found throughout San Jose; there is no place for them to go and it is still the beginning of “kitten season”. This problem results directly from the reduction in TNR services in 2019 by Animal Services and its termination of all TNR services in May 2022. It has recently reinstated TNR, but on a very limited basis, relying heavily on rescues and volunteers to transport cats outside of the county for spay and neuter services. Since the reduction of TNR service began, the cities served by Animal Services have been experiencing an increasing cat population that will continue to grow exponentially unless a robust TNR program is established and maintained.
- Reinstating low cost spay/neuter and vaccination services is also essential. Pet overpopulation results in unwanted animals that are abandoned or otherwise become strays. Unvaccinated animals spread disease. The economy and the shortage of vets has made it difficult for many people to neuter and vaccinate their pets. The reinstatement of low cost spay and neuter services will greatly reduce animal suffering. It will also reduce the number of animals brought to the shelter, which will increase the live release rate. Fewer animals in the shelter increases an animal’s probability of adoption and the shelter’s ability to house the animal. This effect was recognized by John Cicirelli when he was Assistant Director of Public Works. The following is his quote from a May 31, 2016, article in sanjoseinside entitled “San Jose Councilman Proposes No-Kill Shelter”:

“One of the most significant contributors to our high save rate has been preventing animals from being born through low cost and free spay-neuter services. We have learned that this is one of the best ways to invest in our community and achieve our goal of reducing the number of stray animals.”

- The shelter needs a full time animal behaviorist. A dedicated position would enable the shelter to structure enrichment, socialization, and behavior modification programs to offset the stressful conditions of the shelter environment on the animals. An animal behaviorist would also provide post-adoption support and owner-retention programs, increasing positive outcomes.

The challenges facing the shelter will not be resolved overnight. The proposed budget increases represent positive forward movement, but much more needs to be done. Animal Services requires oversight at the City Council level, and your participation in making sure Animal Services meets the current and future needs of the community is vital.

We urge you to approve the proposed increases for Animal Services.

Today at 4:00pm my neighborhood once again is covered in smoke, a fire from the brushes located in the encampments off the freeway. This happens numerous times in District 7.








District 7 has one of the largest homeless population, shelters, centers, and so much more. We have to clean up District 7.

Reinstating low cost spay/neuter and vaccination services is also essential. Pet overpopulation results in unwanted animals that are abandoned or otherwise become strays. Unvaccinated animals spread disease. The economy and the shortage of vets has made it difficult for many people to neuter and vaccinate their pets. The reinstatement of low cost spay and neuter services will greatly reduce animal suffering. It will also reduce the number of animals brought to the shelter, which will increase the live release rate. Fewer animals in the shelter increases an animal's probability of adoption and the shelter's ability to house the animal. This effect was recognized by John Cicirelli when he was Assistant Director of Public Works. My North Star in this debate is how can we offer anybody who wants to get off the streets alternatives that are better than congregate shelters ASAP. One option is Quick Builds—accommodations that provide shelter from the elements and relieve someone from spending all their mental energy on basic survival. Another option is sanctioned RV parking.

Measure E revenues would probably take more than 30 years at the current revenue to cost ratio to give all the unsheltered folks permanent housing. (Back of the napkin calculations: Measure E revenues=\$50M/year, cost of unit=\$625K, need for about 2500 units for about 5000 unsheltered ppl). That is just too long and cannot be the answer for people living on our streets.

The alternate spending plans that peanut butters Measure E revenues over everything to try and make all stakeholders happy is not rising to meet the urgency of the moment.

I ask you all to have the courage to vote and help our fellow unhoused San Jose residents as quickly as we can.

Dear Mayor and Councilmembers,

It has come to our attention that the Santa Clara County Association of Realtors has been circulating false allegations about the peaceful protest that some of us held at their office on June 7.

As one of the organizers, let me explain why we decided to target SCCAOR. It was clear that SCCAOR was one of if not THE main organization that was mobilizing to support Mayor Matt Mahan's poorly crafted proposal to slash Measure E affordable housing funds. SCCAOR has no connection with the various constituencies that depend on San Jose's affordable housing, no expertise in affordable housing and homelessness issues, and in fact has a history of not supporting affordable housing measures in San Jose and Santa Clara County.

The protest was a peaceful picket line of about 35 tenants, currently or formerly unhoused people, and community residents. We confess that we were in fact loud, but we did nothing to "terrorize", harass, intimidate, or threaten anyone, and we have video available if anyone wants to see it. SCCAOR accuses us of calling them names. We are not sure what they are referring to. Perhaps it was one of our chants: "Hey realtors, you can't hide, we can see your greedy side."

SCCAOR is apparently not used to receiving this level of public scrutiny and criticism. But if they are

going to participate in what many feel is a political attack on San Jose's low-income and BIPOC communities, they should be prepared for more nonviolent protests in the future.

Hello Mayor and Councilmembers,

I urge you to adopt the memo authored by Councilmembers Davis, Torres and Ortiz. My preference is to leave the Measure E percentage allocation untouched. However, of all the options to address homelessness and the need for affordable housing at all income levels, this is the most practical one. I was part of the Measure E campaign with my picture featured prominently in print, tv and social media ads. I feel personally betrayed by the proposal offered by the Mayor and administration. I heard so many times that this was a general tax and that council members could not be trusted. I responded noting the adopted Council Policy. I urged support for Measure E noting that the percentage allocation could be tweaked but it would not be abandoned. I was horrified to see that not only was the entire category of affordable housing zeroed out, there is now a proposal to move to a majority vote. This will greatly damage any future attempt to pass a general tax measure. I will not support a general tax measure if this Council betrays the voters by adopting a council policy change by a simple majority. I am also a parks and open space advocate. 



This letter was prepared by members of the Race Equity Action Leadership (REAL) coalition.

### **Background**

The REAL Coalition has been deeply engaged throughout the budget process, discussing our proposals to advance racial justice and economic equity with the Mayor and every councilmember at least once.

We appreciate the inclusion of a pilot program to establish non-police responses to interpersonal violence (as well as several other items we'll delineate later), and are grateful to Vice Mayor Rosemary Kamei and Councilmembers Pam Foley, David Cohen, and Sergio Jimenez for their thoughtful efforts to preserve money for permanent affordable housing.

However, with the release of the Mayor's June message we see there are still several shortcomings in the proposed budget and call on Council to make these changes:

### **Measure E**

We have always been supportive of "an all of the above" approach to end our homelessness crisis. The city needs to invest in emergency interim shelter but it must not shy away from its commitment to affordable and permanent supportive housing by even a single dollar. The REAL Coalition supports the memo from Councilmembers Davis, Ortiz and Torres that preserves Measure E, taps more of the excess fund balances, and outlines a plan to expand emergency interim

shelter in collaboration with other partners. This memo should be adopted as-is as part of the FY 23-24 budget.

### **BEST Programs**

We are disappointed to see no additional funding for Bringing Everyone's Strengths Together (BEST) programs. As we stated in our March letter, council should double down on the city's investment in prevention and intervention of violence by adding \$5 million to the BEST appropriation. Whereas the mayor has acknowledged the importance of prevention and intervention in his message, the budget should express this stated value.

### **Recovery Task Force**

The pandemic may be considered over but the needs identified by the Recovery Task Force persist. We appreciate the use of unspent money to continue progress in workforce development but there should be further allocation to continue the task force's work in health equity, early childhood education and housing. The city should budget an additional \$2 million to further high priority and high impact recommendations. As staff and council committees assess which priorities to move forward, task force members should be consulted as appropriate.

### **Racial Equity Work**

Although the Mayor's Message spoke to racial equity, we need to put our money where our mouth is. We should advance racial equity work in the City of San José by ensuring that City positions dedicated to this work are filled. In light of failure to hire key positions in Parks, Recreation, and Neighborhood Services; Planning, Building, and Code Enforcement; and Transportation, those positions should be converted to permanent Program Manager positions.

### **City Manager's Budget Addenda and Council Budget Documents**

We are glad to see the following items included in the mayor's June message:

- Extension of the Eviction Help Center
- Additional staff to raise money for Vision Zero and manage Vision Zero projects
- Tree canopy projects in Calle Willow and Luna Park

- Investments in digital equity programs
- Investment in pedestrian safety projects
- Enhanced traffic and pedestrian safety through road and intersection design
- Investment in youth education and afterschool programs
- Investments to serve our LGBTQ+ residents
- Investing in cultural spaces including the Vietnamese Heritage Garden and African American Community Services Agency
- Enhanced lighting for safety

Further, with the extension of the automated license plate reader program, the City needs to acknowledge that its data management and transparency policy is inadequate and convene relevant stakeholders to write a stronger and more equitable policy.

Lastly, we are interested in the references in the March message to divert calls from 911 and other possibly innovative ways to move away from unnecessary policing and carceral approaches. We call on the City to involve the community at a deep level in these conversations. The REAL Coalition stands ready to participate in these dialogues and to support the City in bringing the voices of community members with relevant lived experiences to the table.

We appreciate the Council offices that engaged in dialogues with Coalition members during this process and all of the offices and staff for their hard work on the budget.

### **About the REAL Coalition**

The REAL community of nonprofit leaders and allies has been meeting since June 2020 to use our positional power to advocate for a more racially-just and equitable society; to establish a peer network of leaders committed to fighting white supremacy and systemic racism in ourselves and our institutions; and to hold each other accountable to the promises we made in the Nonprofit Racial Equity Pledge. Dear Mayor and Councilmembers:

Thank you all for the incredible amount of work and thoughtfulness that each of you have put into the Fiscal Year 2023-2024 Budget process and for your willingness to engage the community and working families on these important questions. As representatives of over 100,000 workers and their families across Santa Clara County we know the enormous needs facing San Jose and believe we need a budget that takes a comprehensive approach to solving our biggest problems: housing, homelessness and public safety.

After reviewing the memos submitted by Councilmembers we would encourage the Council to pass a June Budget Message and FY23-24 Operating Budget which:

Adopts the 6/8 memo by Councilmembers Davis, Ortiz and Torres to keep the current allocation of Measure E dollars, which already balances funding interim shelter spending and permanent housing, and using additional funds from the General Fund Excess Fund Balance to support the funds needed for construction and operations of all of the City's FY23-24's planned interim shelter sites.

Directs staff to find additional resources to fund the additional staffing and/or interim shelter needs identified in Councilmembers Cohen and Jimenez's 6/9 memo.

Adopts the 6/9 memo from Councilmembers Davis, Ortiz, Torres, Batra and Doan to not accept the reduction in Med 30 recommended by staff, and to fund portion of MBA #21 identified in their memo through a reduction in the future deficit reserve.

Additionally, we encourage the City Council to vote no on the 6/9 memo from Mayor Matt Mahan to break with the City's promise to voters who passed Measure E in 2020, and to a broad coalition of labor, faith, community and developers who came together working with Mayor Liccardo and City Council to reach a difficult agreement to require any changes to the spending allocation of those funds to require super majority support by future Councils. We believe unraveling this requirement would be a major blow to our community's faith in this Council and future ballot measures.

Mayor, Council, and Former City Colleagues,

Thank you for your dedicated service to our community.

I regret that the debate over the allocation of Measure E dollars has become so divisive. Our city faces a crisis of homelessness, and we'll need everyone working together—neighborhood residents, non-profit providers, affordable housing developers, community leaders, the Council, City staff, and many others—to address this crisis.

I write because I'm concerned that some context has been lost in the debate over Measure E. I have some insight into that context, because of my deep level of engagement in the process three years ago. Most relevant to the current discussion, my staff and I drafted the language that serves as the basis of the Measure E funding allocation in the form of [a November 26, 2019 memorandum, which I co-signed](#) along with Councilmember Pam Foley and two former colleagues. That was adopted by the Council on December 10, 2019. I also drafted [the November 15, 2019 memorandum proposing a supermajority Council voting requirement](#) and other “guardrails” to change Measure E funding allocations. That memo was also co-signed by two former colleagues, and the Council adopted that direction at its November 19, 2019 hearing.

A few observations seem worth making about those Council-adopted memoranda:


- The establishment of “**guardrails**” —the council policy requiring a supermajority vote and multiple public hearings— **emanated wholly from a concern that future councils might spend Measure E dollars on purposes other than affordable housing and homelessness.** The most vocal critics of the measure, Councilmembers Johnny Khamis and Dev Davis voted against putting Measure E on the ballot at the December 3, 2019 Council meeting because they asserted that as a general tax, Measure E's language alone could provide no assurance that future city councils wouldn't spend Measure E revenues on purposes unrelated to housing and homelessness. The public debate focused on that issue, as captured by the online title of a November 19, 2019 *Mercury News* story, “*San Jose officials say new property transfer tax will fund affordable housing. But will it?*”
- In short, **we inserted the guardrails solely to assure the public** that future Councils would more likely focus Measure E revenues on homelessness and affordable housing, **not to create a rigid allocation formula that would require the functional equivalent of a constitutional amendment** In my view, the critical issue is to keep the faith of the voters by restricting Measure E spending to homelessness and affordable housing. Council's discretion within those broad categories should remain unhindered.
- Further evincing this desire for flexibility, we crafted the ballot language to provide that measure's revenue will serve for “**...helping homeless residents move into shelters/permanent housing.....**” This broad mandate would, in my view, enable the City to remain consistent with the will of the voters while **allocating Measure E dollars**

**flexibly on homelessness solutions** along the spectrum from shelter to permanent housing.

- Our November 26th memorandum provided an allocation of **“45% for permanent supportive and affordable rental housing for extremely low-income (ELI) households-defined as earning less than 30% of area median income (AMI)...”** At the time that I wrote that, I fully intended and expected that innovative models for housing extremely low-income residents –such as motel conversions, quick-build housing, and other interim solutions – could be funded from this ELI pot.
- In subsequent budget processes, the Housing Department disagreed when I encouraged the use of this Measure E ELI funding allocation for interim housing, seizing on the word “rental” as precluding interim models. We avoided “calling the question” on the issue, however, because the Housing Department was able to identify other sources of funding in 2022 to achieve our goal of constructing 1,000 quick-build prefabricated units, Those alternative sources—such as federal pandemic-related funding, and state Homekey and HHAP allocations—were ephemeral, however.. Accordingly, **it seems appropriate for every city council to “call the question” for itself on how best to reduce homelessness among our ELI residents within that 45% category of funding. The mere deletion of the word “rental”—without any reallocation of funding—would serve this purpose.**
- I understand that there are also disputes over the use of Measure E funds for the San Jose Bridge program, which provides previously unhoused residents with jobs cleaning and beautifying the city, and housing. **We have previously used Measure E dollars to support San Jose Bridge,without controversy.** In repeated polling conducted in recent years, few City programs have been more strongly supported by our residents.

I hope that this letter sheds some light on the origins and purpose of these regulations. My best to each of you in your important deliberations.

My name is Alfredo Villasenor from District 5. I know everyone wants permanent housing for all.



Re: Comments to 2023-2024 Budget

Dear Mayor and City Council of San Jose,

We, Silicon Valley De-Bug, are writing this letter regarding the San Jose City Council Budget Hearing and Mayor Mahan's proposed budget, specifically relating to housing and police. For over a decade now, De-Bug has been active around both issues of police and housing because our communities have been directly impacted by both. For reasons explained below, we are opposing any reallocation of Measure E funds and any increase to the Police Department budget. We would like to call attention to the Mayor's budget priorities of defunding permanent affordable housing and increased policing while using catch phrases like "common sense" or "back to basics." The mayor's budget proposal is, in fact, a continuation of City leaders before him who have also defunded permanent housing and increased police budget. This is a continued pattern of the City of San Jose not prioritizing affordable housing and funding a scandalous and unaccountable SJPD to further arrest and incarcerate its communities. We are calling on the Mayor and the City Council to stop this budget pattern. We want homes, not more police. We want cribs, not cops.

**WE OPPOSE ANY REALLOCATION OF MEASURE E FUNDS.**

San Jose is never short of market rate housing for those who can afford it, but year after year we do not meet our affordable housing goals. The Mayor's proposal to reallocate Measure E funds from permanent solutions into temporary housing takes us even further away from

reaching those goals. Taking one of the only City sources of funding for affordable housing shows us affordable housing continues to be deprioritized in practice and demonstrates an abuse of power by the Mayor to undermine the will of San Jose's voters when we made Measure E a reality to help our communities have access to permanent housing.

Our question for Mayor Mahan's "common sense" budget proposal is: Why do the poorest and most vulnerable of our community have to choose between permanent and temporary housing? The proposed reallocation of Measure E funds is out of touch with the local community who has worked on housing issues for decades, to the point where organizations who are commonly on opposite sides of proposed housing solutions are now unified to preserve permanent housing funding. We are observing a near unanimous opposition to the reallocation by both current and former unhoused persons and the organizations that have supported these communities. Those who have supported the reallocation have almost predominantly been from the land owning class of San Jose, including the associations that represent them. Those affected and the organizations that support them are closest to the solutions, not the ones who have never experienced these realities.

Our ask is not to make us decide between temporary and permanent housing when the proposed allocation is millions of dollars from an over 5 billion dollar budget. Instead, we ask you to fund the absolute need for immediate housing solutions by reallocating from our City's yearly half a BILLION dollar police budget.

- 2023-2024 Proposed Police Budget: 497.5 Million Dollars
- 2023-2024 Expected income from Measure E: 50 Million Dollars

We urge the Mayor and the council to look elsewhere in our City's budget to meet the needs of immediate temporary housing solutions rather than taking money away from the only long term answer: permanent affordable housing. An obvious source of this needed funding is the bloated Police Budget. Such reallocation could be achieved through an amended version of the memo proposed by Councilpersons Ortiz, Torres, and Davis.

### **WE OPPOSE ANY INCREASE IN THE POLICE DEPARTMENT'S BUDGET PROPOSAL.**

De-Bug families whose loved ones have been killed by San Jose police oppose any increase in the San Jose Police Department's budget. For years now, these families have been healing, supporting, and organizing with each other through Silicon Valley De-Bug, and have been pushing for accountability for the harm and death of their loved ones. It is in their names that this demand is made.

The proposed increase by Mayor Matt Mahan is not based on statistics but rather bending to the political rhetoric of the San Jose police. One of the Mayor's proposals is to add 17 more police officers, 2 police sergeants, and 1 police lieutenant to the field patrol unit, citing that the Department's priority is:

"public safety and calls-for-service, response time goals, and lowering overall crime, which in turn drive how these resources are allocated. In consideration of the Department's staffing needs, the most immediate need is to focus on calls for service and response time."

However, upon a review of the statistics, the proposed budget does not support this:

- In reviewing the calls for service to San Jose police, we compared the calls in 2022 and 2023 at the same point in the time (up to June/ July of the respective years). **There**

**were approximately 24% less calls for service in June 2023 compared to June 2022.**

- The types of calls received were approximately the same.

Priority Level	June 2022	June 2023
1 and 2	34%	37%
3 - 6	66%	63%

- According to the San Jose Police, ***the crime rate from January to March 2023, compared to the same time in 2022, was 8.3% less.***

Beyond the math that does not support the addition of more police officers, the escalating, well-documented incidents of police abuse calls for a reduction of their budget rather than an increase. For three years in a row after the racial reckoning after the murder of George Floyd, one out of every three officers out of the 1,100 police officers received a complaint. As De-Bug families have always said - it's not about a few 'bad apples'. The culture of San Jose policing allows officers to skirt accountability. In fact, just last week four officers were arrested for violating the law. The Council approving funding to an unaccountable department means the City co-signing this culture violence, abuse of power, and impunity.

The recent scandal involving the Executive Director of the San Jose Police Officers Association has further devolved any trust between the community and the police. While spewing the dangers of fentanyl, the SJPOA's own Executive Director was involved in the distribution of it – while using resources of the POA's office. Furthermore, no local agencies have held these actions accountable. If this were a Black or Brown member of our community, they would not be afforded this kind of grace or call to the withholding of judgment. .

Lastly, Santa Clara County rolled out different crisis interventions, including 988, peer support resources, and TRUST - a non-law enforcement response to crisis. These programs need time to be fully implemented before any additions to the current police department.

For the reasons explained above, we fully oppose the destructive budget proposed by Mayor Mahan, which only avoids the dire need for long term permanent housing and safety from police violence. We urge you as our elected officials to support a San Jose Budget that responds to realities and future of all in our city.
