



2023 Traffic Fatalities





• 49 total fatalities in 2023 is a 25% reduction from 65 in 2022 (peak), and the lowest year since 2020 (tie), and 2017 (46)



2023 Traffic Fatalities

49 fatalities (47 crashes)

- 42 (86%) on major roadways with posted speed limits of 35 mph or higher
- 32 (65%) in dark hours
- 31 (63%) on Priority Safety Corridors
 - 4 (8%) on Monterey Rd, White Rd
 - 3 (6%) on Blossom Hill Rd, Jackson Av, Capitol Ex
- 27 (55%) people walking
 - 6 (12% of total/22% of peds) unhoused
- 16 (33%) speeding as a contributing factor



2023 Traffic Fatalities: By Mode







Cumulative Bike Fatalities by month



Cumulative Motorcycle Fatalities by Month




Cumulative Motor Vehicle Occupant Fatalities by Month

Pedestrian Safety Pilot: Monterey/Curtner

Installed on May 22, 2022

 Intersection was chosen based on citywide collision data

Assists in hit and run and fatal collision investigations

Saratoga Avenue (Fall 2023 - Spring 2024) from Williams Rd to Lawrence Expressway/Quito Rd








Priority Safety Corridor Quick Build Projects

Leading Pedestrian Intervals (LPI)

- As of the end of 2023, 100% (848) of City of San José operated traffic signals that have a crosswalk with a pedestrianvehicle turn conflict have a LPI of 4 seconds or more installed.
- LPIs have been found to reduce pedestrian-vehicle crashes by 58.7%

Walk Safe San Jose: Pedestrian Safety Plan

- Funded by 2021 Caltrans Sustainable Transportation Planning grant
- In February 2024, DOT and our consultants held pop-up demonstrations to show the community what future redesigns could look like, with support and collaboration with VTA.
- Help understand project benefits/impacts.
- 5 more pop-up demonstrations are being planned for August-September, using funding from the California Office of Traffic Safety









Sunsetting of Vision Zero Task Force

- The San José Vision Zero Task Force was created in September 2020.
- On February 29, 2024, Vision Zero Task Force Chair Pam Foley announced sunsetting the Task Force at the end of 2024.
- Future Vision Zero engagement at City Hall will continue at:
 - Transportation and Environment Committee: proposed twice a year
 - Bicycle and Pedestrian Advisory Committee: proposed twice a year

Grant Funds Awarded

- In 2023, DOT was awarded over \$81.3M in grant funding.
- \$12.9M US DOT Safe Streets for All (SS4A) Implementation Grant:
 - Curtner Ave near VTA Light Rail (Canoas Garden Ave - 87 Fwy)
 - Capitol Expy and Senter Rd
 - Monterey Rd and Curtner Ave-Tully Rd
 - E Santa Clara St and 11th St







Speed Safety Systems: Speed Enforcement Cameras

- Governor Newsom signed Assembly Bill 645 in October 2023: 5-year speed safety system (speed enforcement cameras) pilot program.
- Up to 33 speed safety systems on state-defined safety corridors, in school zones, and in areas with a history of street racing or sideshows.
- Planning to return to City Council in September 2024 to present the Speed Safety System pilot project status update.
