WRATES* welcomes the opportunity to strongly encourage the full San Jose City Council to take up the subject proposed by Councilman Rocha in his Memorandum on San Jose Water Company dated 8/17/17. I believe we are the group of advocates that Councilman Rocha refers to in the Comments section of that Memorandum. With three members of the steering Committee from San Jose, one from Campbell, and three from Saratoga, and over four hundred concerned customers signed up as members to date, we are a loose consortium acting individually but consistently on behalf of all of San Jose Water Company's customers including the more than 80% residing in the City of San Jose. Further information is available on James Hunter's blog at http://sjwc-rate-increase.blogspot.com/ and Rita Benton's website at http://sjwfacts.weebly.com/.

Last September, Rita put together a petition on Change.org entitled "Outrageous Water Bills?! Let CPUC know that SJWC's unfair billing practices need to STOP!". It was addressed to 56 potential government, water company executives, other decision-makers, journalists, etc. and obtained 8219 signatures to date. There was one response, a thank you.

We soon realized that lack of responses equated to a lack of valid corrective suggestions. This was due to the complexity and lack of public information available. On March 10, 2017, WRATES met with the Office of Ratepayer Advocates (ORA is a Division of the CPUC tasked with advocating for all of its utility customers) to determine what we, as customers, could do to address this situation (see attachment 2 for more details). Their first answer was that customer participation in public hearings is extremely helpful in getting earlier information, facts, and perspective to the Commissioners before the rate increase requester alone influences the decision.

San Jose Water Company (SJWC) is currently in proceedings with the CPUC regarding their Cost of Capital application. In this application, SJWC is requesting an increase in their Rate of Return. This increase, if approved, will allow SJWC to increase their future rates to achieve their new rate of return. This will directly affect and increase our rates on January 1, 2018 and in the upcoming 2019, 2020, 2021 General Rate Case application. The ORA and WRATES has requested that the CPUC approve a Public Participation Hearing to be held in San Jose. The Administrative Law Judge (Karl Bemesderfer) overseeing the Cost of Capital application, informed Rita Benton on July 29, 2017 via email that he will shortly be issuing a formal ruling setting the time and place for the San Jose Public Participation Hearing. ORA, WRATES, SJWC customers, and hopefully city council members in the affected cities will speak at the hearing requesting a decrease in SJWC's Rate of Return and not an increase.

San Jose City Council can help its affected constituents effectively by alerting them to the upcoming meeting as soon as details are available. According to ALJ Bemesderfer, SJWC must also publicize the meeting to its customers via bill inserts or other means. I spoke to Councilman Khamis last week and he promised to alert his District's 100,000 constituents. WRATES will provide a write-up to all of San Jose Water Company's customers encouraging them to attend, listen, question, and comment

In his memorandum, Councilman Rocha asked the City Manager to acquire certain information in a week that I have been trying to acquire accurately for up to 2 years. Perhaps I can share what I've found on the 7 specific pieces of information requested.

- a. San Jose Residents who are customers of San Jose Water Company- I have not found an accurate answer to be available from public sources. The only way I've reached a probable range of 850,000 to 900,000 is through Annual Report information, historical census information, other San Jose based water companies' service data and areas served, assumptions, estimates, and calculations. There is no transparency on this issue.
- b. The amount the City of San Jose pays for water service should be available from the City Manager. Please remember that SJWC is also a source of revenue to the City through the City of San Jose 5% utility user's tax. In response to a request for this information, Councilman Khamis's office stated on July 3, 2017 that "Total 2017-2018 estimate is \$14.85 million in revenue to the City". That includes all three water retailers providing water for the residents of San Jose. San Jose Water Company probably provides about 85% of that total.
- c. The total increase in cost for water services from San Jose Water Company is an extremely difficult number to pin down for numerous reasons, too many to discuss here. WRATES has recently determined the difference in cost between a customer's bimonthly bill using 15ccf/monthly (11,220 gallons). In January 2013 (the beginning of the drought) a customer using 15ccf/month was charged \$125.42 on their bi-monthly bill. As of June 2017, a customer using 15ccf/month was charged \$227.42 on their bi-monthly bill. This is an 81% increase over a 4½ year period. This does not include the 3.66% SCVWD pass through increase that became effective July 1, 2017. Incidentally, this is an increase nearly six times as great as the local region increase in the cost of living (CPI).
- d. The total amount paid in drought surcharges is \$37,368,000 over the 19 ½ months the surcharge was collected. These values can be obtained by adding the amounts in the 2015 and 2016 SJW Group annual reports and their Q1/17 SEC 10-Q filing. This is the total company collection, the only information publicly available.
- e. A list of all rate changes from San Jose Water Company will be difficult to accurately determine because any information concerning advice letters is no longer available after disposition on either the SJWC or CPUC websites. WRATES has attempted to reconstruct the type information you requested at http://sjwfacts.weebly.com/advice-letters.html. However only underlined Advice Letters were accessible to be linked to the actual documents. This is about half of those going back to # 430 in 2011. And most of them don't contain the work papers used to calculate the rate change. These are all issues WRATES is requesting State Senator Beall to address by sponsoring a bill to correct the present deficiencies in the Advice Letter process.
- f. and g. Requesting estimates of refunds due to Advice Letter 510 is premature. SJWC's Advice Letter 510 requested CPUC approval to refund almost \$1.8 million to all its customers. WRATES and many SJWC customers, the Office of Ratepayer Advocates (ORA), and the City of Cupertino filed protests against Advice Letter 510. Advice Letter 510 was ultimately rejected on August 11, 2017 given the fact that on June 22, 2017, the CPUC served SJWC with the formal complaint filed by Rita Benton et al over the readiness to serve charge rate changes and docketed as proceeding C.17-06-009 (Complaint).

A copy of the CPUC's rejection letter can be found at http://sjwfacts.weebly.com/overcharges.html by clicking on "rejected Advice Letter 510". It states on the rejection letter that the CPUC is in the process of conducting a thorough investigation and audit of SJWC's past and present billing practice to determine the proper dollar amount to be refunded.

The formal complaint process has begun and could take over a year to be resolved. The ORA has also requested an Order Instituting Investigation (OII) of SJWC's billing practices. WRATES has found over 30 historical instances where the service charge rate was increased before the effective date authorized by the CPUC. The very rough estimated refund amount WRATES believes is appropriate exceeds \$13 million. This does not include the city utility tax or the PUC tax collected on the incorrect amount charged.

<u>Subject</u>: Concerned San Jose Water Company Customers – Here's how you can help.

<u>Body</u>: Now that the surcharges have ended, effective February 1, 2017 some of you will be getting relief from the extremely high bills incurred from surcharges alone. The rates for all SJWC customers will continue to increase, and given that California enters a drought every 5 to 7 years, the return of mandatory drought conservation in the future, including surcharges, remains a threat (remember, Almaden has not yet received our normal annual rainfall for the full 2016/2017 rainfall year).

WRATES (Water Rate Advocates for Transparency, Equity, and Sustainability) started by Rita Benton (along with the petition that over 7900 upset customers have signed to date) has and will continue to remain active to achieve the goals in the group's name. On Friday, March 10, 8 WRATES members representing Saratoga, Monte Sereno, Los Gatos, Campbell, and Cupertino, along with those of you in the Almaden community shared information with 3 representatives of ORA (the Office of Ratepayer Advocates) for over 4 ¼ hours. ORA is part of the CPUC and is dedicated to advocating for all of its utility customers. Kudos to Rita, Mary Robertson who arranged the meeting, and everyone else who had input at that meeting. We presented many of the detailed issues that have contributed to the sudden unsustainable and inequitable increases in your water bills. We also heard exactly what ORA can and cannot achieve and how WRATES and all of you can assist them in their efforts.

Several WRATES representatives will be meeting with State Senator Jim Beall on April 11 to a): present our findings and request an investigation into all the issues we have uncovered concerning SJWC's billing practices and the enabling relationship the CPUC has with the utilities and b): to encourage legislation for CPUC reform and for correcting the bad bills, laws, and tools that helped cause the present situation.

We asked for and received specific ideas from the ORA on how individuals can influence rate increases. Unfortunately, most of the advice letters now affecting rates are based on past decisions by the PUC Commissioners and just involve implementation of those decisions. We should, however, continue our efforts on filing written protests on future advice letters to keep our concerns in the forefront of the CPUC. Plus your help will be most useful in future General Rate Cases (GRC). Specifically:

- 1) Customer participation in public hearings is extremely helpful in getting earlier information and perspective to the Commissioners before the rate increase requester alone influences the decision. WRATES will continue to advocate for clear and widespread early announcements of these hearings but you also need to attend. The 2018 GRC for the rate setting three year period of 2019, '20, and '21.is supposed to start development in the next few months. ORA indicated that they are cautiously optimistic concerning the 2 new Commissioners who were just appointed.
- 2) ORA is most helped when the ratepayer presents facts, rather than emotion, opinion, or hearsay.
- 3) You can help by writing letters to the CPUC Commissioners and the Department of Water and Audits with copies to ORA. If no specific address is given with the document you're commenting/protesting on, email addresses can be found at: 'www.sjwfacts.weebly.com/contactsemails.html' As much as the ORA is dedicated to advocating for the ratepayer, the voice of the ratepayer carries the greatest influence. There is power in numbers. Generally voices from hundreds of customers saying essentially the same thing are heard.

- My husband and I do not want to pay for a project that will cost \$1 billion before cost over runs and that will not provide the District with additional water supply. I do not believe that Staff estimates of increased water supply are accurate. They need to consult the CA WaterFix website and look at climate change modeling done by environmental NGOs.


The Negative Impact of SJWC on Ratepayers A Position Paper

1. Rate Increases

SJWC has increased its rates 73% since 2014 for the typical customer with a 3/4" meter using 15ccfs per month (30ccf bi-monthly). To compound this further, the quantity Tier allotments have been reduced by 77% pushing ratepayers into higher tiers with higher rates. SJWC has some of the lowest tier allotments within SCVWD service area.

Water is a basic human right. In 2012, Governor Brown signed AB685, historic legislation establishing a state policy that every Californian has a human right to safe, clean, **affordable** and accessible drinking water. SJWC's 73% rate increase in just 3 years is not affordable.

Increase in SJWC Bill for a Typical (30 CCF) Customer March 2014 to March 2017




2. Additional Rate Increases are Achieved through Advice Letters


SJWC states that their General Rate Case (GRC) rate increases go through a rigorous 12 month approval process every three years with the CPUC. What they don't state is that they continually request additional rate increases throughout the year via the Advice Letter process. The CPUC approves these additional rate increases within 30 days, not 12 months. This accounts for nearly 50% of SJWC's rate increases.

Additionally, the CPUC only allows 20 days for the ratepayer to research, formulate and submit a protest letter. SJWC has filed multiple Advice Letters within a 20 day period overwhelming the ratepayer and the CPUC resources.

For example, the average rate increases approved by the CPUC through the GRC (including the SCVWD pass through increase) for years 2014, 2015, and 2016 is 11.24%. The actual rate increases achieved through additional Advice Letters averages over 20% per year.



Comparing Source of Increased Revenue Requirements (2011-2013) for CWS Districts filing 2013 Escalation Increases




3. SJWC customers pay the highest price of the 13 SCVWD's retailers.

The raw cost of water is the same, but charges to customers are very different.

- -SJWC rates are 74% higher than Great Oaks Water, an Investor Owned Utility regulated by the CPUC that services residents in San Jose.
- SJWC rates are 150% higher than City of Morgan Hill, a Municipality.

(These percentage do not include Drought Surcharge amount.)




4. Service Charge Overcharges

SJWC has been overcharging all of its customers on the service charge rate for decades. Rita Benton et al, on behalf of all SJWC Customers, is currently in formal proceedings with the CPUC and SJWC regarding the amount of the overcharges and possible penalties that SJWC owes its customers. Office of Ratepayer Advocates (ORA) requested that the Commission institute an Order Instituting Investigation. WRATES believes the overcharges are in excess of \$13 million. WRATES has counted over 20 instances where SJWC has overcharged the ratepayer when the service charge was increased. WRATES also contends that SJWC double billed its customers during the transition billing cycle when they switched from billing in advance to billing in arrears.

In an email dated February 21, 2017 addressed to Rita Benton, Reminder Kahlon and Richard Rauschmeier from John Tang, Tang states, "SJWC's past practice was to bill the service charge in **advance**." and "SJWC *recently modified* its practice in order to treat the service charge, like the quantity charge, as billed in **arrears**."

In a letter dated March 1, 2017 addressed to Tayeb Mogri from John Tang, Tang states, "SJWC determined that Rule No. 9 allows flexibility for SJWC to treat its readiness to serve charge as billed either in advance or in arrears..."


In a letter dated March 16, 2017 addressed to Tayeb Mogri, Reminder Kahlon and Rita Benton from John Tang, Tang states, "No change has occurred on January 1, 2017 in SJWC's established practice of billing both quantity charges and the readiness to serve charge in arrears."



5. <u>Discriminatory Drought Surcharges</u>

The total amount paid in drought surcharges over the 19 1/2 month period was \$37,368,000. This money was only collected from 60% of SJWC customers (single family residences). This money was recognized as revenue to offset under-collected revenue. All customers, even those that already paid for the shortfall through the drought surcharges, were then billed a WCMA (Water Conservation Memorandum Account) surcharge to collect the remaining under-collected revenue.

ORA gave testimony that the drought surcharge is neither just nor reasonable, and in violation of California Public Utilities Code Section 728.1 and it is unlawful, unreasonable, discriminatory and preferential....ORA notes that, in April, 2015, before the implementation of the Monthly Drought Allocation and Drought Surcharge program, SJWC customers reduced consumption by 25.3 percent from 2013 levels for the corresponding month. SJWC customers were already meeting Gov. Brown's water conservation percentages.



- Monies collected from the Drought Surcharge program were placed in a balancing (holding) account.
- Due to conservation, SJWC did not sell projected amounts of water and therefore did not meet their annual revenue targets.
- CPUC allowed SJWC to be compensated for the under-collected revenue.
- Drought surcharge monies were recognized as revenue to offset under-collected revenue.
- CPUC allowed SJWC to add a temporary line item (WCMA) to customer bills to collect remaining under-collected revenue for each of the drought years.

Bottom Line:


SJWC was allowed to transfer millions and millions of dollars from 60% of customers paying drought surcharges to subsidize rate increases for ALL customers, including classes of customers not subject to mandatory conservation.

60% of customers paid **BOTH** drought surcharges and additional surcharges that the drought surcharges did not cover in the revenue shortfall.

6. SJW Group (Parent Company of SJWC) has made huge profits


SJW Group saw a stock price gain of 89% in 2016, a drought year; the stock price nearly doubled in one year. The tech industry doesn't see gains like this. Apple and Alphabet, the two largest and most valuable companies in the world saw comparable stock price gains of 35% and 15% in 2016. SJWC accounts for about 90% of SJW Group's revenue.

Investors reward such money-making stability: 1 year stock price gain of 89%. Nearly doubled in one year.



Investor Owned Water Utilities Cannot Lose

- → Rate of Return guaranteed.
- → If water consumption goes down, SJWC is allowed to "be made whole" through extra charges or rate increases.
- → SJWC has made huge profits, even for drought years!



7. Age of SJWC's pipes

SJWC states that the rates are increased because the age of its pipes are 150 years old. Exactly ZERO miles of pipe are 150 years. In fact, 94% (or 2243.1 miles) are less than 70 years old, 5% (or 112.1 miles) are 70-99 years old, and 1% (or 36.4 miles) are 100-139 years old. Pipe replacement has been a part of SJWC expenses for decades and our rates did not increase at this unsustainable rate.

ORA documents indicate the average life of pipelines is 90 years.





FIGURE 8-C - SJWC's existing pipelines by age

8. SJW Group and its subsidiaries

SJW Group is the holding company for SJWC, SJW Land, SJWTX Inc. and TWA. Only SJWC is regulated by the CPUC.



- → SJWC is regulated by the CPUC but SJW Group and SJW Land are not.
- → SJW Group directors and officers are shared between the utility and its affiliates.
- → These Tariffed and Non-Tariffed companies muddy the waters for transparency.
- → In the past, SJWC reported revenue and expenses to the CPUC as a single entity. Today it is unclear how information is reported to the CPUC.

SJWC transfers property to SJW Land before selling to a third party, by doing this, monies do not get recorded as SJWC revenue. If SJWC makes a land sale, monies are to be utilized for infrastructure. The same rules do not apply to a land transfer.

Example:

APN# 529-31-041 - SJWC first transfers property to SJW Land. Then within 5 months SJW Land sells to Sienna Oaks.

- 2005 Recorded Land Value when transferred to SJW Land \$45,228
- 2006 Recorded Land Value when sold to Sienna Oaks \$4,200,000





Dear Councilmember Rocha,

We have had the opportunity to meet with many of the San Jose Councilmembers and Staff over the last week and a half and we would like to extend our appreciation for accommodating us on such short notice and taking the time to listen to the SJWC issues plaguing the ratepayers. Council member Rocha's memo dated August 17, 2017 has started the conversation to bring about change to SJWC. We are hopeful that the WRATES Position Paper has provided you with additional and compelling information to help you render a decision regarding future involvement concerning issues surrounding SJWC. WRATES would like to request the following of the San Jose Council.

The community would like to see San Jose Council take an active role to:

- Engage in letter writing campaigns with the CPUC regarding Advice Letter protests and influence the resolution of General Rate Case and Cost of Capital applications filed by SJWC. WRATES has found that the CPUC responds much more quickly to requests, protests, responses etc. from city agencies.
- 2. Encourage the CPUC to do a proper investigation into SJWC's billing practices.
- 3. Participate in and/or initiate a Formal Complaint when wrongdoings by SJWC are detected. Offer legal guidance to the ratepayers in the current formal complaint C.17-06-009 regarding the Service Charge Overcharges.
- 4. Challenge Rulemaking policies such as, but not limited to, the implementation of the Drought Surcharges (Schedule 14.1).
- 5. Engage with WRATES to become knowledgeable about the SJWC water bill and all the quantity charges, service charges, surcharge mechanisms such as the WRAP, WCMA, 2013 and 2016 Interim Rate True-up and how they are implemented.
- 6. Open dialogue and band together with Council members from adjacent cities also negatively affected by SJWC. i.e.: Campbell, Cupertino, Los Gatos, Monte Sereno and Saratoga.
- 7. Persuade the media to do an investigative report on SJW Group and its subsidiaries.

- 8. Open dialogue with Senator Beall's office regarding legislation for CPUC reform.
- 9. Research and investigate SJW Group and its subsidiaries through the SEC, County Records and any other means available to the city to expose the questionable land transfers, leasing fee agreements, sales and acquisitions between SJW Group and its subsidiaries.

We are writing to pass along Greenbelt Alliance's thanks to Councilmember Rocha for your active participation and questions at the Environmental Sustainability Plan study session on August 21, clearly indicating a preference for including open space protection in the ESP. We have had follow-up communications with City staff - it's not yet clear whether the needed improvement to address natural and agricultural lands will be included, but they are considering it. We very much appreciate any follow-up from the Councilmember to the Mayor's office and city staff.

We wanted to give a head's up about another study session coming up on October 6, regarding the City's planned switch from analyzing Levels of Service to analyzing Vehicle Miles Traveled in CEQA analysis. We are very supportive of the switch and hope the Councilmember feels the same way, but we will also look for opportunities for improvements in the City's plans. We will be in touch about this - we think it could help significantly in showing that Coyote Valley is an inappropriate place for development, and it would be wonderful if the Councilmember would point that out.

Jose Water Company

The city of San Jose was only required to reduce its water usage by 20 percent, per the California State Water Board. The Santa Clara Water District, the Mayor, and the San Jose City Councilmen increased this amount to 30 percent. THAT WAS ESSENTIALLY A 50 PERCENT INCREASE OVER WHAT THE STATE MANDATED. Instead of allowing each customer to cut 30 percent, based on their own consumption, the San Jose Water company averaged residential use from all its customers for the year 2013 and cut 30 percent from that. As a result, San Jose Water Company gave every single-family residence the same monthly allotment of water. This affected about 1 million customers. They did not factor in that many customers were already voluntarily cutting back on their usage. No consideration was given to the number in the household or lot size. More than 1,000 people appealed to the CPUC, saying their water bills had shot up hundreds of dollar a month even though they had cut their water usage.

A state consumer agency, the Office of Ratepayer Advocates, also appealed, calling the rules. discriminatory, unfair, and unreasonable" because they applied only to single-family homes and not to businesses, apartments or condominiums. Essentially the conservation (cutbacks) fell upon the backs of the single-family homeowners. Unfortunately the Office of Ratepayers Advocates reports to the CPUC and their complaints fell upon deaf ears. And no relief came.

We have personally reduced our water usage by about 43% since 2013, yet our bills have been steadily increasing and are higher than we have ever paid. In addition we have CC&R's on our property that require us to maintain foliage on a large portion (hill) of our property to avoid erosion. We wrote to the water company to request an additional allotment for this purpose, but we did not even get the courtesy of a reply. We continued to water and maintain this hill area and paid a steep price to do it.

Now the Mayor and the City Councilmen who approved this increased water reduction to 30 percent, instead of the 20 percent that was mandated, have realized that the City of San Jose has also been paying immense, unfair, and regular increases on their own water usage. And, who ultimately pays for this? The taxpayers. The Mayor and Councilmen also pretty much let the San Jose Water Company make all the rules, with no oversight. We all understood that we were in a drought and most of us made significant cuts to our water usage. Letters and complaints to the CPUC, San Jose Water Company, and the Santa Clara Valley Water District once again, did not warrant the courtesy of a response.

The CPUC is a big culprit in what the San Jose Water Company has gotten away with, by regularly rubber stamping any increase they request. As a result when many homeowners have been stretched to the limit to pay their water bills, and have let their yards die and turn to weeds, the water company has experienced record profits. Not only has the water company profited, but in so doing they fostered the downtrodden, slummy look of our city. Drive down any street and see yard after yard, comprised of dirt, dried grass, and weeds. People cannot continue to pay the high rates and even hope to re-landscape their yards and maintain them.

It is hard to believe that record profits can be made when there is a drought and water consumption is drastically cut! First we are told to conserve and then we get increased rates for doing so! There were rate increases of 73% from 2014 to 2017. Not only does a stop need to be made to the continuous, unjustified increases, but these rates need to be rescinded. Refunds should be due to all the San Jose Water Company customers. And, those who were discriminated against by the way the allotments were given, also need to be reimbursed.

Insult to injury, the employees of the water company do not have to pay for water. They are free to use all they want.

The WRATES group has worked diligently on behalf of all the San Jose Water Company customers to bring the flagrant practices of the San Jose Water Company to the public. The statistics they have prepared expose the San Jose Water Company's practices. Each and every member of the City Council needs to read the material that they have researched and verified. This group cannot handle this issue alone, they need the support of the City of San Jose in representing its residents.

I am writing this letter to express my concerns/dissatisfaction regarding the negative impact of San Jose Water Company's charges on its ratepayers to be discussed during the city council meeting on September 12th (Agenda Item 7.2).

SJWC'S predatory rate increases (primarily done through Advise Letters to the CPUC) has resulted in a non-sustainable burden on its ratepayers not to mention the extraordinary profits realized by the San Jose Water Group. Due to the fact that no competitive alternative source of water is available to San Jose residents, the company's mode of operation is classically that of a monopoly out of control. As you well know, in a competitive environment, competitive forces in the market place would prohibit such pricing. Regulatory bodies (such as the CPUC) are specifically established to prevent predatory practices and price gouging, but my conclusion is that the CPUC is nothing more than a rubber stamp on price increases requested by SJWC. I have personally written countless letters to the CPUC and their Consumer Advocate Division as well as the Santa Clara Valley Water District to no avail. In fact, the Consumer Advocate Division, which organizationally reports to the CPUC, makes no sense whatsoever since there is no separation of power and decision making.

The San Jose Water Company is by far the largest subsidiary of four subsidiaries of the San Jose Water Group and financially accounts for the majority of the Group's revenue and profits. I only mention this, since the San Jose Water Group Financial Statements do not include "Segment Reporting", but rest assured that these Statements are driven by the results of the San Jose Water Company itself. San Jose Water Company is also the major element of the Santa Clara Water District in terms of service connections and revenue. San Jose Water Company, in other words, is the two ton bully gorilla in both cases!

As a retired financial executive with 40 years of experience, I can assure you that the Holy Grail of both public and private companies is to increase shareholder value through dividend payouts and stock appreciation. As you will see later on in this letter, San Jose Water Group gets an A+. Sadly, their success was made on the backs of the consuming public as well as the City of San Jose through price gouging and predatory pricing! Compounding this issue, was the City Council decision to reduce water usage by 30% even though the state mandate for San Jose was only 20%. This action provided an avenue for the SJWC to charge exorbitant rates per CCF on anything greater than the allotment to individual households based on a 30% reduction from "Average" household usage in 2013. Additionally, SJWC along with the SCWD, decided that apartments and businesses were not part of the reduction, which reduced the pool of revenue for SJWC, resulting in higher rates to individual households than would otherwise been the case. Insult to injury, the allocation used was an average for 2013 and did not consider the size of the property nor adequately account for the number of people in a household.

Keeping in mind, as mentioned above, San Jose Water Company is the major driver in the above results. I've only chosen the base year of 2013 (on which the water allocations were based) compared to 2016 for space reasons. Additionally I have not included the first two quarter of 2017 since I sopped tracking the company in 2016. However, I do know that several Advise letters for rate increases in the first six months of their fiscal year 2017 have been approved by the CPUC. I do have all years between 2012 and 2016 which can be provided upon request.

Please note that the pre-tax income and net income increased by 128% and 137% respectively over this four year period or an average 32% and 34% respectively per annum. I would consider this as extraordinary performance that is atypical. As a benchmark, I've included some pre-tax rates including GE (one of the best run companies in America) as well as a three additional utility companies. None of these companies even come close to SJWC profitability.

On a personal basis, here are the statics of our household. Please note that even though our water consumption in 2016 was 57% lower than the base year of 2013 (or a 43% reduction), my average 2016 monthly bill of \$352.25 was significantly higher than 2013 even though we attained a 43% reduction. As the chart below illustrates, the issue is due to a 213% increase in the cost per CCF. If the cost per CCF remained constant at 2013 levels, our monthly bill would approximate \$165.56 compared to the average monthly bill of \$352.25 or \$186.69 lower. On an annual basis, this equates to \$2,240.28. It is obvious why SJWC's profit margins have ballooned. Allowing the SJWC's rates to grow from \$4.54/CCF to \$9.65/CCF is unacceptable. I am sure the city is dealing with this exact issue.
