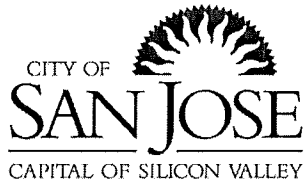

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Boys & Girls Club grant announcement event will be held on September 21, 2017 at the Alviso Youth Center Clubhouse and sponsored by Councilmember Lan Diep. This special event will highlight the City of San José, Council District 4 support of an innovative after-school and summer program to advance the educational enrichment of Alviso students. The event is free and open to the public.
