Two major points for SJC to solve south flow noise issues:

- 1) Take quick and smart actions to conquer SFO southward expansion and side effects of NextGen;
- 2) Adopt landing configurations that are in sync with SFO.

## Details:

I have been living in Sunnyvale for 6+ years. I clearly witnessed that the SJC's south flow path has shifted southwestward to above my neighborhood since last year and there were more than ever flights, one after another, along almost the exactly same flight path at a very high pace. This has broken my neighborhood's quiet nights and mornings!

I urge the council to take proactive actions to address the noise issue. To my knowledge, in addition to NextGen's noise concentration side effect, SJC's airspace is being pressed by SFO's southward expansion. Note that the SFO expansion is promoted by many officials and politicians of Santa Clara county in Palo Alto area. SJC needs to take quick and smart actions!

Subject: Public input for 10/3/2017 City Council Meeting, item 6.1 SJC South Flow

I am unable to attend the Oct 3<sup>rd</sup> 2017 San Jose City Council Meeting where the formation of the Ad Hoc Advisory Committee on South Flow Aircraft Arrivals (item 6.1 on the agenda) will be discussed.

I urge the City Council to support the creation of the Committee.

The FAA created a severe airplane noise problem for many residents when the FAA made unilateral changes to the SJC south flow without any proper consultation with affected communities such as Sunnyvale, Cupertino, Mountain View, and Palo Alto to name a few.

We need a transparent and robust process to address the issue and force the FAA to correct the problem that they created in the first place.

The FAA decided to concentrate traffic over a narrow corridor and use a new waypoint for SJC South Flow. As a result, residents of communities that developed over decades based on well-established flight patterns are now living under a barrage of noisy jets flying at low altitudes (2,000 ft is a common occurrence over my house in Palo Alto). This new and insane airplane concentration is unbearable to the residents living under this new "runway". One does not get used to this type of noise –it is not a white noise; it is a brutal, excessive, intermittent noise that comes back every few minutes.

By the way, asking for solutions is <u>not</u> asking to shift noise to other communities. The current noise distribution should not be considered the baseline –it should be pre-FAA changes. Communities were not consulted when the FAA shifted the noise to residents who were living just fine before.

Solutions exist (obviously, planes landed at SJC in a South Flow pattern for decades before the FAA changed things). The Ad Hoc Committee can evaluate possible changes using criteria such as respect of historical patterns, noise reduction, and level of airplane noise concentration. For transparency purposes, all Santa Clara cities should be invited to participate. For efficacy purposes, voting should be limited to affected cities (either cities severely and negatively impacted by the recent changes or cities who would be by any proposed changes). Most likely the set of cities currently affected or potentially affected would be the same. A simple majority vote should suffice. Severe and negative impacts can easily be defined through the combination of factors such as number of airplanes, above-ground-level altitudes, and aircraft speeds.

Thank you for your consideration and leadership in addressing the SJC South Flow noise problem.
