It is so easy to say "Yes" to this small infill project - particularly when you see the strength of the neighborhood support from 38 of my neighbors.

I hope you will support this project, and vote YES to allow this infill subdivision and my efforts to create family-friendly homes in a walkable urban neighborhood. I look forward to hearing your decision at the City Council meeting on October 24.
