The future Iris Chang Park would be located in North San José, the district that I represent. I assure you that nobody is pushing to build a well on the park site, as that would require revisions to the plan and a return to the planning commission for approval. This is the potential delay you speak of.

The River Oaks Neighborhood Association objects to the consideration of Iris Chang Park as a possible location for the well associated with the Microsoft development covered by agenda item 17-094. We request delay of approval of the agenda item until a site for the required well has been determined. Approval of the agenda item before identifying the well location could lock in impacts to Iris Chang Park before there has been any community input.

Dear Honorable San Jose Mayor and honorable San Jose Councilmen:

We are Paul Keane and Eamonn Kerley, residents of Parkside and Millbrook in North San Jose. Firstly, we would like to say that our neighborhood is very grateful to all of you who voted unanimously in 2015 to approve the new park named after our neighbor Iris Chang.

We wanted to discuss with you the progress of Iris Chang Park, on which our Resident's groups have worked closely with Department of Park and Recreation in planning and designing since 2015.

The park was scheduled to open this year, but unfortunately it has been delayed due to some soil problems – as such, the residents of North San Jose are anxiously awaiting the completion of the park, given the delays are now approaching the one-year mark.

Recently, it has emerged that the land designated for Iris Chang Park has been associated with the new Microsoft project located at the north side of Highway 237. We are told that the City of San Jose Municipal Water System has considered plans to dig a well at the site of Iris Chang Park. We do not understand why the Municipal Water System has thought of Iris Chang Park as an appropriate location to site a well.

In Page 14 of the EIR appendix the following is stated:

"The City has required, as a condition of approval for the project, the purchase and dedication of a 2,500 square foot property for SJMWS's future construction of a potable water well. This agrees with the 2015 UWMP plan Table 6-8 for future water projects to support future demands by the installation of groundwater wells in the NSJ/Alviso service area."

As we understand it, the EIR did not specifically say the well has to be located in Iris Chang Park; and it does seem that there are plenty of sites elsewhere in the general North San Jose or Alviso area.

Being a layman man lacking expertise in the characteristics of water sources, it does seem disintuitive to place 3 wells so close to each other – is this not a case of "*placing all eggs in one basket*", in that if there is any future incident that affects one well, then would all 3 not be impacted?

If the project needs quality water, and the City of San Jose are comfortable locating such in this area, it does seem there are more logical options, including but not limited to:

-- Liaise with the Santa Clara Water District to site the new well on Coyote Creek Trail, similar to Well's Ovation Ct #2-785 and Ovation Ct #1-785.

-- Liaise with the owners of the vacant lot south-east of Iris Chang Park, between Epic Way and Coyote Creek Trail, to locate the well on land that has not been used in many years.

In this manner, one expects that any proposed new well should be able to tap the same water table as that beneath Iris Chang Park, without impacting existing plans for Iris Chang Park.

We would have expected that a large Industrial project such as this would have sufficient resources to identify a specific water source, without driving what appears, for want of better words, a "land-grab" of land that has significant meaning for the residents of North San Jose.

At face value, there appears no logical reason why Iris Chang Park would be the preferred location to site a well. The change of the land use, even only a small portion of the Park, will effectively change the approved design of the park. We are told that this would require a reapproval of the Park, with further approval cycles potentially delaying the opening of the Park for another 9-12 months.

Since the Park has been already delayed a year, and the neighborhood is patiently awaiting its completion, this would appear an unnecessary and unfair burden to both the Department of Park and Recreation and the Residents of North San Jose.

In closing, we would note that we are disappointed that conversations related to modifying and appropriating a portion of Iris Chang Park have taken place without the specific involvement of the River Oaks community.

We sincerely request that you either:

A) Direct the exclusion of Iris Chang Park from any future consideration as a Well Site location associated with the Microsoft project, or

B) Alternatively delay the agenda item approval until a Well Site location is selected.
