ACTIONS RELATED TO THE PURCHASE ORDER FOR AIRPORT

**ELECTRIC BUSES** 

#### **RECOMMENDATION**

Adopt a resolution authorizing the City Manager to:

- 1. Execute a purchase order with Proterra, Inc. (Burlingame, CA) for the purchase of ten new electric passenger shuttle buses for the Mineta San José International Airport, in an amount not-to-exceed \$7,598,238, excluding applicable sales tax and license fees.
- 2. Approve a contingency of \$760,000 for any unforeseen changes or modifications to the design of the vehicles, subject to the appropriation of funds.
- **3.** Approve the purchase of additional buses for up to five years from the initial purchase date, subject to the appropriation of funds.

#### **OUTCOME**

Replace ten shuttle buses at the Airport that are fueled by compressed natural gas (CNG) with zero emissions electric buses.

#### **BACKGROUND**

Mineta San José International Airport is currently leasing CNG buses as a mode of transportation for Airport passengers to terminals, rental car garage, and parking areas. With the purchase of ten new electric buses to replace the existing CNG buses, the Airport will reduce green gas emissions, improve air quality, and comply with clean air initiatives.

### **ANALYSIS**

A competitive Request for Bid was facilitated by the Finance Department to procure the buses. Two bids were received from Proterra, Inc. and BYD Coach & Bus LLC, who submitted bids of \$759,824 and \$969,498 per bus, respectively. Staff recommends award to Proterra, Inc. as the lowest, responsive, and responsible bidder pursuant to the formal bidding procedures of the San José Municipal Code, Section 4.12.310B.

This purchase is funded by a Zero Emission Vehicle Grant from the Federal Aviation Administration (FAA).

#### **EVALUATION AND FOLLOW-UP**

There is no anticipated City Council follow-up for this action.

#### **COORDINATION**
