- 3. Halloween Festival will be held on Tuesday, October 31, 2017 at Tully Library Community Room and sponsored by Friends of Tully Library, San Jose Public Library and Councilmember Tam Nguyen. The event will provide the community with a safe and fun way to enjoy Halloween. The event is free and open to the public.
- 4. Dumpster Day at Alma Neighborhood will be held on Saturday, December 2, 2017 at Alma Community Center and sponsored by the Alma Neighborhood Association and Councilmember Tam Nguyen. The event will provide bins for residents to dump their junk and learn about city services. The event is free and open to the public.
- 5. Richardson Park Grand Opening Celebration will be held on Saturday, December 9, 2017 at Richardson Park and sponsored by Councilmember Tam Nguyen. The event will open a new park for the community and give opportunity for residents to voice concerns and learn about city services. The event is free and open to the public.
- 6. Clean Up with Tam will be held on Saturday, December 16, 2017 at Tolbert Drive and Lanai Avenue and sponsored by Councilmember Tam Nguyen. The event will give opportunity for residents to beautify the neighborhood. The event is free and open to the public.

#### **ANALYSIS**

Approval by the City Council of the events will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Tam Nguyen will report any cash or in-kind donations received
