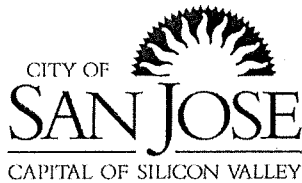

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Dumpster days will be held on November 11, 2017 on Macadam Court and on December 9, 2017 on Avenida Grande both locations are in South San Jose. Councilmember Jimenez is the sponsor of these events. These special events will allow residents to discard unwanted items legally and safely. The event is free and open to the public.


