## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517, which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Coleman Undercrossing has been a long anticipated project that has taken almost five years to complete. The numerous users to Almaden Lake Park, one of San José's well used regional parks, will now be able to walk completely around the lake, without having to cross at the busy intersection of Coleman Road and Almaden Expressway.

On Saturday, December 2, 2017, the District 10 office, in conjunction with Parks, Recreation, and Neighborhood Services, will host a Ribbon Cutting Ceremony, and launch the inaugural walk along the undercrossing, and around the entire lake.
