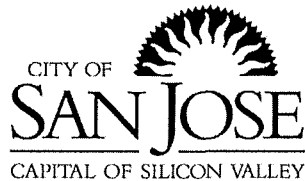

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

1. The Norwood Neighborhood Association was held on Tuesday, November 7, 2017 at Cedar Grove Elementary School. This event brought the neighborhood together to address concerns about their community. The event was free and open to the public.

2. The Norwood Neighborhood Association was held on Tuesday, December 5, 2017. This event will bring the neighborhood together to address concerns within their community. The event is free and open to the public.
3. The Creekside Neighborhood Holiday Lights Celebration will be held on Friday, December 8, 2017 at the Yerba Buena Bridge and Cabana Club. The event will bring the community together through a neighborhood stroll to enjoy the holiday lights. The event is free and open to the public.
4. The Norwood Neighborhood Association Holiday Celebration was held on Saturday, December 9, 2017. This event will bring the neighborhood together to celebrate the holidays, build community, and support public safety by connecting neighbors. The event is free and open to the public.
5. The Holiday Sidewalk Stroll and Celebration was held on Saturday, December 9th at Silver Creek Plaza. The event will bring the community together to celebrate the holidays and community. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Sylvia Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 8, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
