I want to become a member of the Human Services Commission to ensure the San José Human Rights Policy is actively implemented. If selected, I have 3 specific objectives: 1) Ensure communities in San José who are being targeted by the President's administration receive as much protection by helping them connect more closely with City Council. I would specifically focus on working within immigrant communities, with Muslim community groups, and with LGBT organizers. - Why: San José was built by immigrants. From the tribes that we now call Ohlone to Father Fermin Francisco de Lasuen's missionaries to Chinese and Japanese immigrants to Mexican families to Vietnamese refugees to professionals from India and Pakistan, San José's culture is a glorious patch-quilt. It is impossible to pull part of us away from that guilt without tearing all of us--as we saw by the damage the internment camps of the 1940s did to the community where I lived for the last year, in Japantown. We cannot live fully without protecting each other. - How: Communities under threat most often know-best what they need; and what each community needs will be different. If selected, my role as commissioner would be reaching out aggressively to leaders of each community and letting them set the agenda for my work, ensuring that through me they have one more access point to City Council and other policy-makers. Some of these acts might be strongly symbolic (participation in the 4/29 pilgrimage to Manzanar with Japanese and Muslim communitymembers) and some might be thoroughly technocratic (working with the airport to improve reporting protocols if refugees get trapped in another iteration of the odious travel ban). But they will be at the direction of members of the communities being targeted. 2) Increase the number of women and people of color in public safety professions by evaluating whether the equal employment opportunity policies and practices are being followed enthusiastically by the police and fire departments. - Why: After a year and a half in the Attorney General's Executive Office, I've seen how vital representation is. As someone who has served on hiring committees, I know how important informed and active implementation of equal employment opportunity policies is--and how difficult it is to do well. As friends within the disability rights movement say: Nothing about us without us. - How: Learn how hiring happens in the SJPD, meeting with relevant officers and staff over a year to get an in-depth understanding of the process and build buy-in. Report back regularly to the committee and stakeholders and with them, develop an improved process and plan. Work with city council to fund what initiatives we develop in that process. 3) Study the physical accessibility of public spaces and how to improve the movement-independence of mobility-challenged residents to ensure equal access to our civic spaces regardless of difference or ability. - Why: In caring for my grandmother, I saw how difficult it was for someone using a walker to get around downtown Willow Glen. Around the city, I had to nearly-carry her around obstructions on the sidewalk and lift her over fractured sidewalks. ADA-implementation is a federal issue mostly left to individual lawsuits, but there may be a role the city could play in making our wonderful city more friendly to people like my grandmother. More generally, buses could be more women-friendly with bag hooks and Diridon Station could use more seating for people who get tired quickly. - How: Implement a hash-tag-based reporting system for physical public accessibility issues (#CantGetThere), market and monitor it, feeding reports into the formal reporting system. If the system is popular, work with city council to fund the work as part of the official issue reporting protocol.

Each of the 3 objectives I listed above are close to my heart. For the objective to connect the commission even more closely to targeted communities: I've been to a third of the countries in the Middle East and have friends in all of them; I have friends whose families were impacted by the travel bans -- attacks on Middle Eastern immigrants and Muslim-Americans feel personal to me. I was at the interfaith day at the Evergreen Mosque and at SFO during the protests against the first travel ban. I want to help more. I'm passionate about representation in public safety because I grew up in East Palo Alto (1988 - 2000) before moving to San José. It wasn't until I started working in the Attorney General's office that I started to have close friendships with members of law enforcement: before that point, I had shared the learned-wariness of most of my neighbors from back home. I want to help make sure others who grew up in similar communities have the chance to trust law enforcement who has earned their trust. I am committed to improving accessibility not only because of my grandma, but my little brother. Paul was born with significant learning differences and he is why I work to improve access of excluded people to society. In college, I lead a project to record dozens of commonly assigned pieces of literature so that dyslexic, ESL, and vision-impaired students would have access to the materials they needed to succeed-and then I posted them on YouTube for free. I want to help my home city be as accessible, fair, and welcoming as possible, and I believe this commission is a good place to do it.


