# **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Literacy Month Event was held on November 30, 2017 at Dr. Roberto Cruz Alum Rock Library and sponsored by Vice Mayor Carrasco. This special event is to promote literacy among kids and families. The event was free and open to the public.

# ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Vice Mayor Carrasco will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
