#### **RECOMMENDATION**

- 1. Retroactively approve the Public Safety Town Hall Meeting scheduled on January 18, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the February 13, 2018 Council Agenda for action.

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Public Safety Town Hall Meeting was held on January 18, 2018 at the Willow Glen Community & Senior Center and sponsored by Councilmember Dev Davis. This special event addressed public safety concerns in District 6. The event is free and open to the public.

## ANALYSIS
