## **RECOMMENDATION**

a) Consider a motion to reconsider Council Action on January 30, 2018 regarding Item 3.6 Station Area Advisory Group (SAAG) Membership

b) If the motion for reconsideration is approved, consider approving the Station Area Advisory Group (SAAG) membership as part of the community engagement for development of the Diridon Station Area.

### **BACKGROUND**

Pursuant to the Rules of Conduct Resolution No. 78145:

Any action taken by the City Council is subject to reconsideration if the motion to reconsider is made by a Councilmember who voted with the majority. A motion to reconsider may only be made at the Council meeting where the original vote was taken or at the next Council meeting that meets the notice requirements of the Consolidated Open Government and Ethics Resolution. If the motion to reconsider is to be made, a member of the Council who voted with the majority must submit a memo to the City Clerk no later than noon of the third day after the original action requesting that the motion be placed on the City Council agenda. In addition, notice of the item must comply with the requirements of the Brown Act and the additional rules of procedure as described in the Consolidated Open Government and Ethics Resolution. If a timely request for reconsideration is made pursuant to this Rule 5(c), the waiver of noticing requirements set forth in Subsection 2.3.2.1.E of the Consolidated Open Government and Ethics Resolution does not apply.
