BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Traffic Safety Meeting was held on January 29, 2018 at New Seasons Market Evergreen and sponsored by Councilmember Arenas. This special event brought community members together to discuss the important issues of traffic and vehicle safety. The event was free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events.
