WHEREAS, the Innovation and Impact Symposium is co-hosted by the Mayor's Office and directly aligns with top City priorities and policies around its Smart City vision, technology and innovation, transportation, and sustainability; and

WHEREAS, the City finds that the Innovation and Impact Symposium will greatly advance the City's efforts at advancing a Council-approved goal of becoming the most innovative city in America by 2020; and

WHEREAS, the City further finds that the Innovation and Impact Symposium will provide an unparalleled platform for the City of San José to demonstrate innovative work it has been doing in transportation and sustainability fields as well as other instrumental Smart City related workstreams; and
