A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING THE DIRECTOR OF HOUSING TO ACCEPT A GRANT FROM THE CALIFORNIA DEPARTMENT OF SOCIAL SERVICES FOR COYOTE CREEK FLOOD RECOVERY EFFORTS, AND CONDUCT ALL ACTIVITIES, AND EXECUTE AND NECESSARY SUBMIT ALL DOCUMENTS IN CONNECTION WITH THE GRANT FUNDS

**WHEREAS**, on February 21, 2017, parts of San José along the Coyote Creek were impacted by flooding, and the City Council declared the Existence of a Local Emergency on February 28, 2017; and

**WHEREAS**, as a result of the flood, hundreds of individuals were displaced from their homes and lost valuable personal property including vehicles, home furnishing, tools, and medical equipment; and

WHEREAS, on September 16, 2017, with advocacy and support from the Office of California Assembly Member Ash Kalra, the State Legislature passed Assembly Bill 130 (AB 130) which appropriated \$5,400,000 to the California Department of Social Services to provide a one-time grant to the City of San José for purposes of assisting homeless and low-income individuals displaced by the Coyote Creek flooding; and

**WHEREAS**, as a condition of receiving these grant funds, the City will be required to provide quarterly reports to the California Department of Social Services regarding the number of families served and the types of services they received, until all funds have been expended; and

**WHEREAS**, City staff have been informed by the California Department of Social Services, authorized by AB 130 to oversee the grant, that the scope of services

provided to impacted residents shall be for housing, neighborhood stabilization, disaster preparedness, employment, transportation, education, and community building; and

WHEREAS, grant funds will allow the City to continue to fund intensive case management and housing assistance until all the impacted residents are either able to return to their previous homes or locate new housing; and

WHEREAS, grant funds also be deployed to continue to restore and rebuild the housing stability and self-sufficiency of impacted residents going forward; and

WHEREAS, the City desires to authorize the Director of Housing to accept \$5,400,000 in AB 130 grant funds and to conduct all activities, execute, and submit all documents including, but not limited to, applications, agreements, amendments, reports and payment requests, which may be necessary in connection with this grant and to provide for the use of the grant funds;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The Director of Housing is hereby authorized to, as more specifically set forth in the Director of Housing's memorandum dated on or about February 20, 2018,:

- 1. Accept \$5,400,000 in AB 130 grant funds from California Department of Social Services.
- 2. Execute, and submit all documents including, but not limited to, applications, agreements, amendments, reports and payment requests, which may be necessary in connection with this grant or other documents necessary in connection with this grant or to provide for the use of the grant funds in
