Faith Leaders Panel will be held on March 9, 2018 at Sikh Gurdwara Sahib and sponsored by Councilmember Arenas. This special event brings together local faith leaders to discuss community issues. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
