



- \$1.3 million allocated in 2016-2017.
- Contract covers Oct. 24, 2017- April 30, 2024.
- System hardware delivered Feb. 1, 2018.
- Public Works developing installation schedule.
- IT Department developing proposal for redundant network connectivity required to ensure 24/7 operation.
 - Expected to include cellular connectivity leveraging FirstNet


- Launch public education campaign with Santa Clara County Office of Emergency Services. May 2018


