SUBJECT: APPROVAL OF LAKE CUNNINGHAM BIKE PARK GRAND OPENING CEREMONY SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the Lake Cunningham Bike Park Grand Opening Ceremony scheduled on Saturday, April 14, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the April 10, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Lake Cunningham Bike Park Grand Opening Ceremony will be held on Saturday, April 14, 2018 at Lake Cunningham Action Sports Park and sponsored by Councilmember Sylvia Arenas. This special event celebrates the opening of San Jose's new Bike Park at Lake Cunningham Action Sports Park and the expansion of the legendary skatepark into a 10-acre action sports facility.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Sylvia Arenas will report any cash or in-kind donations received


