Administration's Response to Auditor's Recommendation to Consider Eliminating Public Art from Environmental & Water Utility Capital Projects

### RECOMMENDATION

Close out the City Auditor's recommendation that the Administration should consider recommending that the City Council amend the public art ordinance to eliminate the public art requirement for "certain ratepayer-funded capital projects, including those related to underground utilities or the wastewater treatment process."

# In 2008, Council approved *Public Art Next! M*asterplan

- Involved the participation of 1,000 residents
- Reduced Public Art Ordinance from 2% to 1% of CIP, and broadened the pool of eligible projects to include EUS infrastructure (sewer and water utilities)
- Legality of approach confirmed

## **How Public Art Is Funded**

- 1% of City Capital Improvement Projects, excluding maintenance projects and non-construction related activities
- Public Art CIP allocation included in "Art In Public Places" Appendix in annual Capital Budget
- Capital Programs: Airport, Library, Convention Center, Parking, Parks, Community Facilities, Public Safety, Traffic, EUS Infrastructure
- Supports 2 FTE's

## **Objectives of EUS-Related Public Art**

- Stimulate education about environmental challenges; create public appreciation of infrastructure
- Mitigate the impact of EUS infrastructure in public places;
- Demonstrate innovation in environmental management; promote San José as an environmental leader
- Highlight the City's natural assets

## **Administration Considerations**

 High public value of art associated with environmental/infrastructure education and stewardship

 Extensive community and stakeholder input to 2008 Public Art Masterplan; integrity of existing Masterplan

3. City Attorney re-affirmed that public art ordinance is legal

#### Past Consideration of Auditor's Recommendation

- 2012 Administration considered the recommendation but did not pursue due to stated reasons
- 2015 Council included "Top 10" audit recommendations in Prioritization Process (Dec 2015). Council did not support this item to be added to list of Council Priorities.
- 2017 Council amended public art ordinance to exempt Regional Wastewater Facility Projects, eliminated \$2.8 million of public art funding over 5 years (40% of public art budget), and ongoing.

## Clarifications

- Auditor: 2017-2018 through 2021-2022 CIP allocates
  \$2.2 million to public art from EUS capital funds
- 2. Administration: 2018-2019 through 2021-2022 CIP allocates \$443,000 to public art from EUS (accounts for projects underway)
- 3. CAO recently re-affirmed legality of public art ordinance; nexus requirement is being followed
- 4. General Fund resources are constrained
