# BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Lake Cunningham Bike Park Grand Opening Ceremony will be held on Saturday, April 14, 2018 at Lake Cunningham Action Sports Park and sponsored by Councilmember Sylvia Arenas. This special event celebrates the opening of San Jose's new Bike Park at Lake Cunningham Action Sports Park and the expansion of the legendary skatepark into a 10-acre action sports facility.

#### ANALYSIS
