Another Friday letter, to help with some good thoughts, for over the weekend.

I have learned, to keep this sort of letter, shorter.

What may be, some helpful reference points, to look into.

- The Santa Clara County Surveillance and Technology Ordinance, and Supv. Joe Simitian,
- my 2nd letter, of last Friday, March 16, 2018,
- Your own years, of ideas, beliefs, and good work, in what is local democracy, sustainability, civil rights, civil protections, openness and accountability.
- Studies, reports, and legal precedents, from the U.N. the state of California, the ACLU, and the dept. of the navy.
- The work of the city of Oakland, Oakland Privacy Advisory Commission, OPAC.

Among these ideas, along with good legal precedents, created by the state of California, the past few years,

I feel it is a time, civil rights, civil protections, and social responsibility, can be a more open, helpful, and shared part, in the ideas of technological inventiveness, and its business practices.

And can happily begin, to work more as equals, and as a third leg in a stool, called technological innovation.

And with this, to create, more full, holistic definitions, in the ideas of sustainability, responsibility, democracy, community, and peace.

Organizational examples, and legal precedents, described above, have made it easier, to work toward these good concepts.

Dear VTA, city of San Jose, county of Santa Clara, sj. downtown assoc. and others,

It is my guess, we can treat the Big Belly smart trash can project, as an experiment in stages.

As this program began in mid February 2018, we can allow it, a 60-90 day trial period. Until around mid-May 2018, at the latest.

Within this time, you should already be preparing, with downtown advocacy, and with everyday people themselves,

the simple ideas in homeless counseling, drug counseling, and health programs, within downtown, and the St. James Park area.

This open, caring philosophy, is a 40 year tradition of downtown, that can more easily address, and better prepare for, the current future of downtown.

And work to treat, the random scattering of people, this smart trash can technology, has originally offered.

I feel, by the end of April, to mid May, you would have collected, over 90 days of all sorts of statistical data, from the surveillance technology, of the smart trash cans.

And have a few simple understandings, and parameters of how this technology can work.

This should be enough, to remove the smart trash can project, until a more complete public process, can start to be understood.

And to be able to study, analytical, statistical data, of many issues. From Broadband Emission, health and safety, to future downtown Bart questions, from law enforcement patterns, to personal habit patterns, of the area.

And, to put in the place of, this smart trash can project, the ideas of advocacy, open communication, counseling and health programs.

To make clear, your current quick fix, of scattering a few, of the local population, within a few weeks -

does not answer, the long term questions, of the health issues and civil rights, of this trash can smart tech.

To also make clear, I feel there is already good programs in place, and there is simply, not that much violent crime or gunfire, downtown,

Asking, exactly why do you need, all this surveillance tech, downtown, in the first place.

And asking, if honest questions, about the ideas of limiting gun use, and gun control, by local south bay govts., has grown out of hand, and out of control.

Overall, I hope this project can be labeled, an experiment. But please remember, this is an experiment, on innocent people.

People may become tired, lethargic, or somehow unhealthy, by its RF Broadband Emissions.

People may be apprehended, and their lives changed forever, because of its surveillance and law enforcement capabilities.

To pardon the expression, this project should be a watershed moment, in your lives as politicians, in the south bay.

And, to more fully understand, the health effects of broadband emissions, on a population.

Not to mention, very good ideas that are developing, in the future of peace, civil rights civil protections, sustainability and accountability, for a community .

Again, with all of this, I hope you can be open, to the concept of this project, being temporary, or short term.

In the spirit of, friendly words, and good thinking.

I hope we can all have an open mind, at this time. And you can somehow be open, to treat the Big Belly, as a short term project, and have it removed, in reasonable, short amount of time.

There are long term health effects, developing civil rights questions, and already well established, law enforcement and health programs, downtown.

These are well established concepts, in the life of downtown. And a part of the simple reasoning, why there is minimal violent crime, and minimal gunfire issues, downtown.

But please understand the urgency, in how I need to work, and try to continually ask, how you remove this project, as soon as possible.

We are playing, some guessing games, with ideas of RF radiation, its serious health issues, civil rights and civil protection questions, and the non-public, not fully thought out reasoning, of this current project.

This asks for your decency, to end this program, on a moments notice, if needed. I feel, you must be prepared, to think of this project, as harmful, short term, or experimental, if needed .

A simple, 90 day time period, for this project, and should make for a good amount of statistical data, to study and learn from.

From Broadband Emission, health and safety, to future downtown Bart questions, from law enforcement patterns, to personal habit patterns, of the area

By mid-May, this smart trash can project, can be phased out, as you should be currently planning ideas, of advocacy, open communication, counseling, and health programs,

and that should be thought of, to supplement the purposes, of the smart trash cans, in the first place.

To make clear, your current quick fix, of scattering a few, of the local population, within the first weeks, of the smart trash can project, does not answer, long term questions, of health issues and civil rights.

To also make clear, I feel there is already, good law enforcement programs in place, and because of this, there is simply, not that much, violent crime or gunfire, downtown,

To note, one, recent, out of the ordinary, instance of gunfire, at a downtown Walgreens, exactly why do you need, all this surveillance tech, downtown, in the first place ?

To also ask, if the sincere, honest intentions, by local south bay govts., about creating good gun control measures, and limiting gun use, in the south bay,

has grown, out of hand, out of control, persecutorial, paranoid, and thinly reasoned.

Why are local govts., being allowed to re-name, and to perhaps, simply expand ideas, of surveillance, local law enforcement, and the concepts, of the school to prison pipeline system. ?

And then be allowed, to have an almost war-time secrecy, to not have to talk about these programs, more openly, with the everyday community.

We are simply at a time, to begin to focus, on federal govt., white collar concepts, of the mass production, and movement of guns, across state and intl. borders.

We are also, at a time, it is more possible, to develop ideas of peace, openness, and accountability, for local democracy, in this country.

Overall, I feel you must be prepared, to think of this project, as possibly harmful, short term, experimental, and even unconstitutional.

This is thinking, that should be a part of, a respected, collective thought and reasoning, in this country. In this decency, of community, democracy, & its local government, you should be prepared, to end this program, on a moments notice, if needed.

The dangers of this project, make it clear, of good protocols and procedures, you may have not followed, in how to talk about this project.

And that we should talk about, this Big Belly smart trash can project, in terms of a short term experiment, that is possibly very harmful, and that should not be considered, a permanent edition to downtown, at this time.
