Councilmember Lan Diep requested a friendly amendment to include Items 1, 2, 4 and 5 from his memorandum dated November 13, 2017. Councilmembers Rocha and Khamis agreed to the amendment.

Also, including Items 1, 2, 4 and 5 from Councilmember Lan Diep's memorandum dated 11/13/17: (1) Allow the transfer of one's ownership of a licensed dispensary - in its entirety or by fractional share - to a new owner by sale, inheritance, or other legal means; (2) Limit any single entity from owning or having a controlling stake in no more than two licensed dispensaries within San Jose; (4) Return to Council by the autumn of 2018 (by way of an information memorandum) to provide an update on the impacts of the commercial cannabis program, such as revenues generated, associated illegal activities, code enforcement complaints, impacts to staff time and administrative resources; (5) Study the viability of an impact fee to counteract the adverse impacts of commercial cannabis, and the possibility of achieving the following with the revenue from such fees: (a) Campaigns educating minors about the dangers of cannabis; (b) More police staff to regulate the commercial activity of nonmedicinal cannabis and to combat the sale of marijuana from unlicensed sources; (c) More planning department staff to study and align San Jose's zoning with its general plan, as a prerequisite to considering the possibility of allowing the sale of cannabis outside of the currently designated areas. (11-0.)

#### 4.4 17-315

Approve an ordinance amending Part 12 of Chapter 17.23 of Title 17 of the San José Municipal Code modifying the definition of Rental Unit to exempt restricted affordable or government operated rental units, to remove the suspension of Part 6 and 7, and to modify the scope of the exception to the material or habitual lease violation of tenancy cause for eviction to:

- (a) Remove the exception for the addition of a brother or sister to a tenant household; and
- (b) Reduce the maximum occupancy limit on that protection to the greater of the number allowed by the rental agreement or two adults per bedroom.

CEQA: Statutorily Exempt, File No. PP17-030, CEQA Guidelines Section 15061(b)(3), No potential for causing a significant effect on the environment. (Housing)

Mayor Sam Liccardo recommending beginning the discussion regarding the Tenant Protection Ordinance (TPO), followed by the allowable rent increase/banking, Ration Utility Billing (RUBs), duplexes, the rent registry and pass through of the rent registry fees and related issues of the rent registry. Lastly, a discussion of staffing issues and a cleanup item on all the other recommendations. He noted that items could be voted on separately if needed.

Director of Housing, Jacky Morales-Ferrand, Program Manager, Rachel VanderVeen and Senior Deputy City Attorney Shasta Green, offered a presentation and responded to questions from Council.

Mayor Sam Liccardo opened the floor for public testimony.

<u>Public Comments</u>: Two hundred forty-three (243) members of the public spoke, offering their concerns, questions and recommendations.

#### TENANT PROTECTION ORDINANCE

<u>Motion</u>: Councilmember Donald Rocha moved approval of staff's recommendations, including Councilmember Sylvia Arenas memorandum dated November 13, 2017. Councilmember Sylvia Arenas seconded the motion.

<u>Substitute Motion</u>: Councilmember Dev Davis moved approval of Councilmember Sylvia Arenas memorandum of November 13, 2017 and including item #1 from the memorandum she co-signed with Councilmember Johnny Khamis and Councilmember Lan Diep, dated November 9, 2017. Councilmember Johnny Khamis seconded the motion.

The substitute motion failed. (5-6. Noes: Jimenez, Peralez, Carrasco, Nguyen, Arenas, Rocha.)

Councilmember Sylvia Arenas requested a friendly amendment, asking to include that staff return to the Neighborhood Services Committee on what a plan would look like to address the impacts of inadequate housing on children including the steps they could take to incorporate this into their upcoming Annual Action Plan, federal funding update. The friendly amendment was accepted.

Action: On a call for the question, the motion carried, and Ordinance No. 30031, entitled: "A Ordinance of the Council of the City of San José Amending Part 12 to Chapter 17.23 of Title 17 of the San José Municipal Code to Modify the Definition of Rental Unit, to Modify the Scope of the Exception to the Material or Habitual Lease Violation Cause for Eviction, and to Repeal Section 17.23.1290, Which Suspended Part 6 and Part 7 of this Chapter", was passed for publication, including Councilmember Sylvia Arenas' memorandum dated November 13, 2017 to: (1) Accept staff recommendation on Amendments to the Tenant Protection Ordinance with the following amendment: to add "minor in their care" to the list of allowed children, by editing TPO Section 17.23.1250.A.2.b.ii to end with the sentence: "The Landlord has the right to approve or disapprove a prospective additional tenant who is not a dependent child, foster child, minor in the tenant's care, spouse or domestic partner, or parent of a Tenant, provided that the approval is not unreasonably withheld."(2) Modify staff recommendation of the Apartment Rental Ordinance, Section 17.23.350.C's final sentence to read: "Provided that no increase in the Rent is allowed for a Tenant's dependent child, foster child, minor in the tenant's care, spouse or domestic partner, or parent which terms may be further defined in the Regulations." (3) Add "minor in the tenant's care" to any other place in the Apartment Rental Ordinance and Tenant Protection Ordinance which includes the other relevant family members who can safely join a tenant household, including ARO Regulations 5.02.3b and 10.02.

Additionally, direct Housing Staff to report back to the Neighborhood Services Committee on what a plan would look like to address the impacts of inadequate housing on children including the steps they could take to incorporate this into their upcoming Annual Action Plan, federal funding update. (10-1. Noes: Khamis)

(c) Accept the Staff Report and its recommendation not to include a one-year lease requirement or duplexes in this amendment to Chapter 17.23 of Title 17 of the San José Municipal Code. CEOA: Statutorily Exempt, File No. PP17-075, CEOA Guidelines Section 15061(b)(3), No potential for causing a significant effect on the environment. (Housing)
