Director of Housing, Jacky Morales-Ferrand provided a presentation and staff responded to questions.

Motion: Councilmember Dev Davis moved approval of the joint memorandum she coauthored with Mayor Sam Liccardo, Vice Mayor Magdalena Carrasco and Councilmembers Nguyen and Arenas, dated December 15, 2017 and the memorandum from Councilmember Donald Rocha, dated December 19, 2017. Councilmember Sylvia Arenas seconded the motion.

Councilmember Sergio Jimenez requested a friendly amendment to include item #2 from his memorandum dated December 19, 2017. The amendment was accepted.

<u>Public Comments</u>: Matthew Reed and Brian Darby offered support to staffs' recommendations.

Action: On a call for the question, the motion carried, and Staffs' recommendations were approved, with modifications as outlined in the joint memorandum from Mayor Sam Liccardo, Vice Mayor Magdalena Carrasco and Councilmembers Davis, Nguyen and Arenas, dated December 15, 2017, and amended in the memoranda from Councilmember Donald Rocha and from Councilmember Sergio Jimenez, indicated below.

- 1. Adopt a resolution amending the 2017-18 City of San Jose Schedule of Fees and Charges to establish an In Lieu Fee of \$125,000 per unit for rental development (based on the Housing Department's unit subsidy for the most recent funding commitments) subject to the Inclusionary Housing Ordinance Program effective January 1, 2018.
 - 2. Convene a Council study session prior to March 31, 2018 to discuss the aggregate impact of all of the fees to fund parks, affordable housing, transportation improvement, and other needs that the City imposes on housing development and construction. The study session should enable the Council to:
- a. Assess and compare fees across the most commonly constructed building types;
- b. Assess and compare fees from other comparative cities in the region or state;
- c. Identify and bring transparency to the pro formas of housing projects that developers report are "not financeable" or "won't pencil";
- d. Address the question of whether the City should assess fees including inclusionary fees on a square footage basis, rather than per-unit basis, to properly account for the substantial distinction between building 800 square foot studios and a 2,100 square foot single-family homes;
- e. Utilize financial information drawn from actual housing developers, lenders, and contractors, vetted by a trusted independent consultant. Given the concerns about proprietary financial data becoming a public record, explore working with a competent and trusted third party, such as SPUR or a local university, to guide the work and collect the data.

Also including Councilmember Donald Rocha's memorandum, dated December 19, 2017 to: Approve the memo issued by the Mayor, Vice Mayor and Councilmembers Davis Nguyen and Arenas with the following amendments:

1. Direct staff to clarify how the inclusionary rules apply to mixed use projects where the affordable requirement is built on-site. In particular, staff should clarify whether the deed restriction for affordable housing needs to be recorded against just the residential component of the mixed-use project instead of the entire site, and whether the affordable component needs to be completed prior to

4.6 (Cont'd.)

the commercial component of a mixed use project. These clarifications can be accomplished either through revised implementation guidelines or ordinance amendments.

- 2. Approve the revised fee level of \$ 125,000 as recommended by the Mayor and his cosigners, but only for the period between January 1 and June 30, 2019. Direct staff to analyze additional affordable housing projects that achieve construction closings during the next six months and return to Council through the budget process to recommend a revised fee number based on those construction closings that would take effect on July 1, 2019.
- 3. Direct staff to return to Council with an analysis of the municipal code section 5.08.470, which sets out the standards for satisfying the inclusionary requirement by building affordable units on site. Staffs analysis should provide additional information as to how they would interpret the provisions of this section and offer a recommendation as to whether it should be modified or clarified. In particular, it would be useful to understand whether affordable housing units that are in a separate building from market rate units, but still located on the same site, should qualify as on-site units.

And including Item 2 from the memorandum from Councilmember Sergio Jimenez, dated December 19, 2017 to extend the timeline for staff to bring back the analysis in the form of a Study Session to a date no later than June 30, 2018.

- (2) Remove Section 2.E.2 for the Expiration of Temporary Reduction and Deferred Payment, which incorrectly set a cap on the maximum number of units eligible for the Downtown High-Rise Incentive Program, as consistent with Council direction adopted on December 13, 2016.

As staff negotiates new contracts with solid waste contractors, pursue a modified living wage standard for customer service representatives, mechanics and MRF workers who work at the main facilities of residential solids waste contractors. The modified living wage would be based on the percentage of time a given classification spends on San Jose work.
