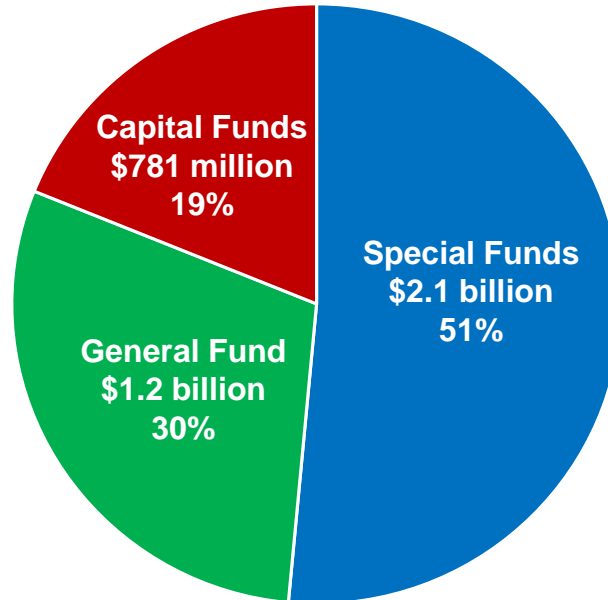

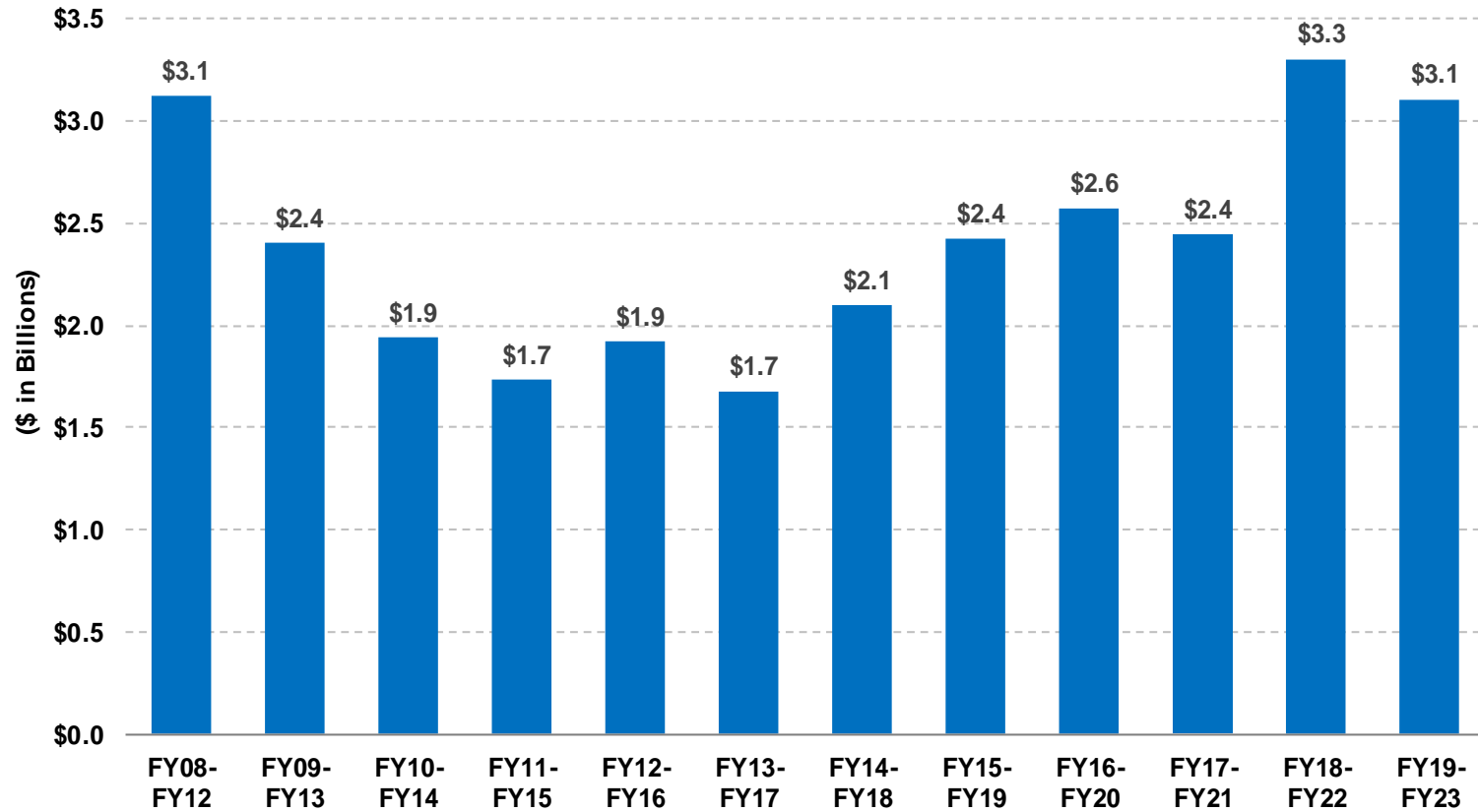
City of San José Budget Overview

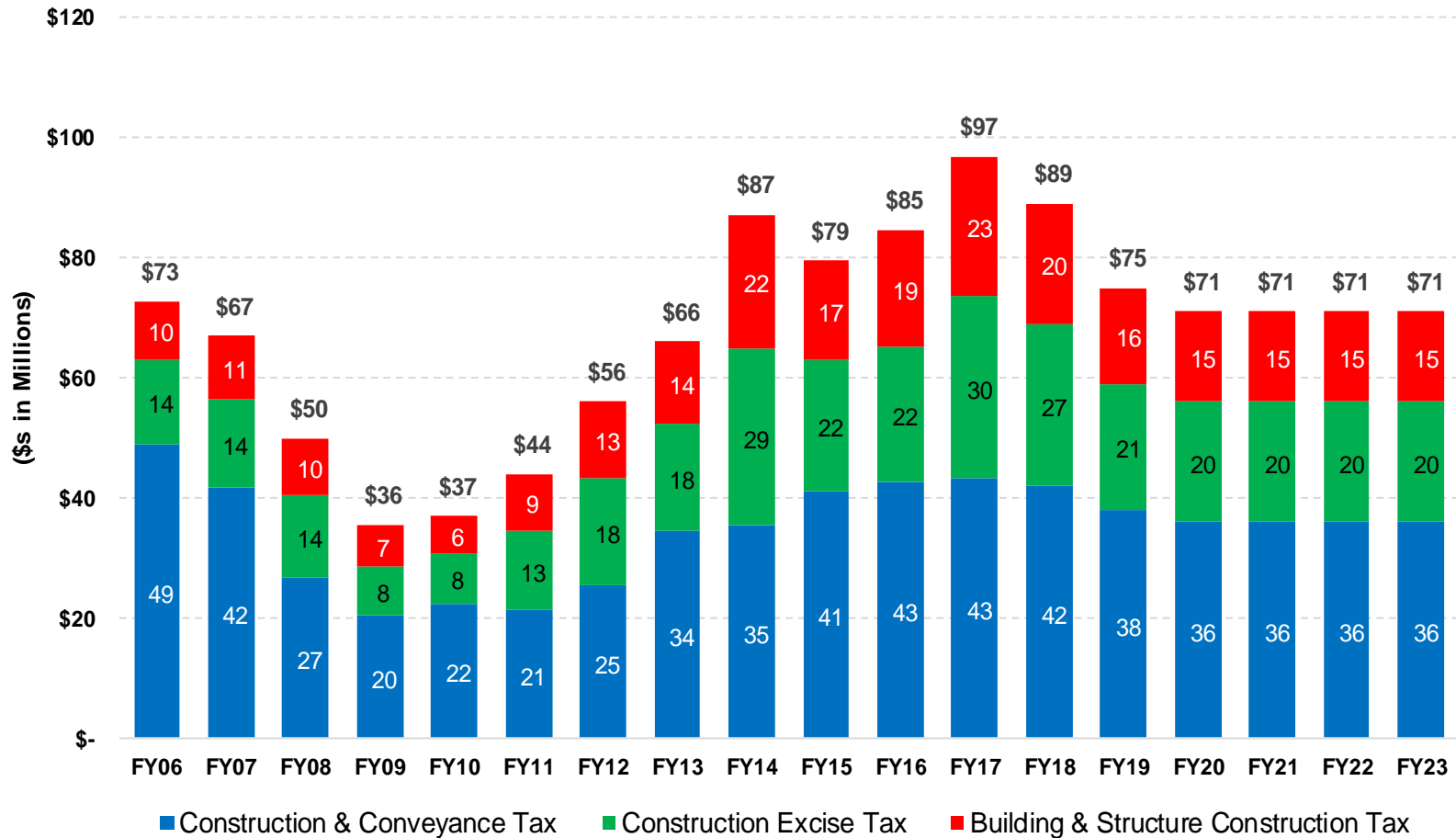

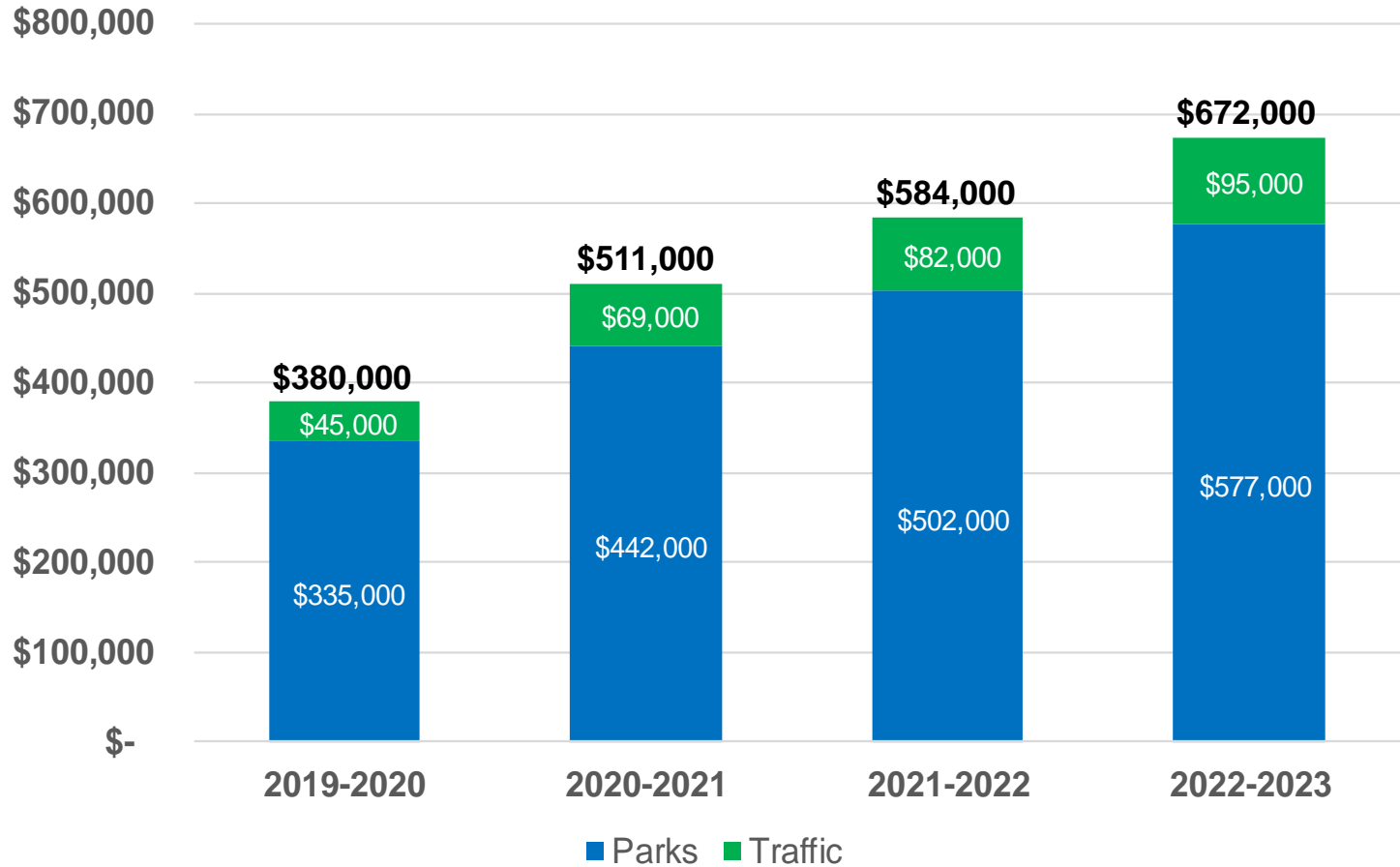

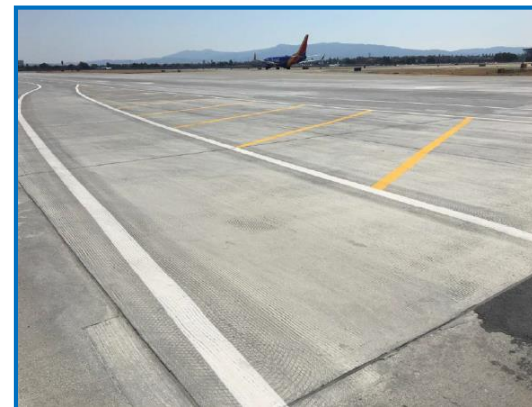
