# BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Beautification Event will be held on June 9, 2018 at the Santa Clara VTA (parking lot) and George Mayne Elementary School (Wilson Way) locations. The District 4 Dumpster Day Event will be held on June 16, 2018, at the Brooktree Elementary and Milpitas Christian Elementary School locations. Both events are sponsored by Councilmember Lan Diep. These special events are aimed at stemming illegal dumping and informing residents about free junk pickup. The events are free and open to the public.
