RECOMMENDATION

As recommended by Parks, Recreation and Neighborhood Services and the Parks and Recreation Commission, approve the name "Esther Medina Park" for the new City park on South 31st Street and Shortridge Avenue.

OUTCOME

Approval of the name "Esther Medina Park" for the new city park located on South 31st Street and Shortridge Avenue will honor the long-time resident and community activist.

BACKGROUND

The property is a new 1.65-acre park at South 31st Street between Alum Rock Avenue and East San Antonio Street, San José, CA, Assessor Parcel Numbers (APN) 481-14-103, in Council District 5. The park site was purchased from Caltrans on August 5, 2016. The South 31st Street neighborhood has many moderately older single-family homes east of Highway 101 and west of King Street. There is a mixture of light industrial and retail uses predominantly along Alum Rock Ave. to the north of the new park site. The property was formerly residential homes which were removed to provide right-of -way for Highway 101.

Esther Medina was a long time resident in San José who worked picking fruit in the Valley of Heart's Delight, and graduated from San José High School. She went on to become a social worker and worked with San José's Anti-Poverty Agency and the Commission on the Status of Women for Santa Clara County, California. Ms. Medina was best known as the executive director of MACSA (Mexican American Community Service Agency) where she worked from 1982-2003. Ms. Medina was a champion of social and economic justice.



ANALYSIS

Angel Rios Jr., Director of Parks, Recreation, and Neighborhood Services, submitted a nomination of "Esther Medina Park" located on South 31st Street. The Attachment describes the reasons for naming the new park Esther Medina Park. PRNS has confirmed this nomination conforms to the following criteria in Council Policy 7-5:

"3. Consideration shall be given to the naming of City-Owned land and facilities after an individual only if one of the following criteria has been met: a. The individual has been deceased for at least 5 years, and made significant contributions to the City through a long-term commitment to providing benefit to the residents and visitors to San José."

Specifically, the nomination form states that Esther Medina (12/15/1936 -10/17/2012, age 76) was a tireless advocate of the disenfranchised and legendary champion of the Latino community in San José. Her accomplishments were many, and she was best known as the executive director of the Mexican American Community Services Agency, Inc. (MACSA) for 22 years.

Council Policy Number 7-5, Naming of City-Owned Land and Facilities, establishes Council Policy regarding the determination of names to be given to City-owned land and facilities. Per the Policy, the City encourages naming that:

- Reflects the City's ethnic and cultural diversity;
- Recognizes individuals who have made a significant contribution to the local, national, or global community;
- Recognizes distinct geographic, environmental, or developmental features, or names of historical significance;
- Recognizes individuals for their service to the community;
- Naming as early in the capital planning and development process as possible; and
- Sponsorship through significant funding support from private donors for the construction and/or ongoing maintenance and operations of City lands and facilities in exchange for naming options.

EVALUATION AND FOLLOW-UP

Approval of this item requires no further action from the City Council.

COORDINATION

This memo has been coordinated between Parks, Recreation and Neighborhood Services staff and the Office of the City Clerk. The Parks and Recreation Commission, Angel Rios Jr., and the family of Esther Medina have been notified of the Council hearing.
