WHEREAS, Magical Bridge Foundation ("MBF") is a 501(c)3 non-profit organization that has unique expertise in designing and building all-inclusive playgrounds in the Bay Area; and

WHEREAS, Section 4.12.235 of the San Jose Municipal Code authorizes the City to forgo a competitive procurement for unique professional or other services when it is in the public interest to do so; and

WHEREAS, the City wishes to enter into an agreement with MBF to provide design services and fundraising for an all-inclusive play area at Emma Prusch Farm Park the terms of which are detailed in the memorandum to the City Council from Angel Rios, Jr., Director of Parks, Recreation and Neighborhood Services; and
