Since my high school days as Vice President of Student Council, I have worked to make my community better by taking on leadership roles in various groups and organizations. Currently, I am the Chair of the Law-Related Education (LRE) Committee for the Santa Clara County Bar Association (SCCBA), a position that I have held for the last three years. I came into this role during a time when there was a significant amount of conflict among our key partners that was jeopardizing the programs we sponsor. As Chair, I stepped up the communication, strengthened our relationships with our community partners (the Judiciary, the County Office of Education, Santa Clara County Sheriff's Office, lawyers, teachers and students) and I developed written procedures to clearly define our respective roles and responsibilities. The SCCBA recently recognized my commitment to the Santa Clara County Mock Trial program with Annual Johnny Gogo Award. In addition to serving as the Chair of the LRE Committee, I serve on the Judicial Evaluation Committee for the SCCBA. I am qualified to be a Planning Commissioner because my work experience, community involvement and personal interests have given me a well-rounded perspective on land use. As set forth below, I have the analytical abilities to make fair, well-informed decisions; the legal skills to make practical and feasible recommendations on legislative proposals; and the experience to manage emotionally charged situations. My legal training has taught me to make decisions by impartially applying the facts to the law. While many may think of an attorney as an advocate, much of my career has been focused on evaluating the legal merits of a given situation. From when I started out as a clerk writing judicial opinions, to my work in environmental litigation where I needed to understand the science behind contamination, or as a prosecutor evaluating whether the evidence rises to the level that criminal charges are appropriate, I have always approached the law from the perspective that one should understand the facts and the law first before making a decision and that any decisions should be consistent with the law. From negotiations with passionate defense counsel, to gathering information from reluctant witnesses, to prosecuting cases where emotions run high, I am skilled at diffusing difficult situations, communicating with members of the public and I understand that the system works best when people feel heard and when people in power have the courage to make decisions, even if those decisions are unpopular. If I were appointed to the Planning Commission, I would evaluate each individual case on its merits, not to advance a personal agenda. In my 14 years of practicing law, I understand how important it is for the language of our laws to clearly effectuate the intent of its drafters. I have spent countless hours analyzing the language of regulations, codes and statutes. I understand that small differences in drafting can create huge unintended consequences and that there are certain types of documents or statutes where flexibility is needed, such as a General Plan, and others, such as a Rent Control Ordinance or specific guideline on zoning, where it is important to be crystal clear. I have developed an understanding of land use and the planning process through my personal interest in real estate and my last two years as a Deputy District Attorney in the Real Estate Fraud Unit. On a personal level, I have managed several major renovation projects as an ownerbuilder and I am in the process of obtaining approvals for a complete rebuild of a home. For each of my projects (2 in San Francisco, 1 in San Jose and 1 in Los Gatos), I directly interacted with the Planning and Building Departments to obtain permits. I can read plans, I understand how to interpret and apply zoning regulations, how to comply with design guidelines, and, more generally, what is involved in planning and executing a construction project, including how to accommodate or mitigate neighbors' concerns. In the Real Estate Fraud Unit, I was recently tasked with evaluating whether various development projects within a local jurisdiction complied with the Subdivision Map Act, the Municipal Ordinances and more specifically, with the City's General Plan. Through this inquiry, I met with concerned citizens, gathered information from the City and discussed the development projects at issue with the City Attorney and then applied the information that I had gathered to the City's General Plan and specific planning ordinances. While other applicants may have more in-depth experience in land use, I am confident that my combination of personal and professional experience has given me the analytic skills, ability to communicate with the public, and sufficient subject matter expertise to manage public hearings and to make well-reasoned decisions as a Planning Commissioner.
