A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING THE ANNUAL BUDGET REPORT FOR MAINTENANCE DISTRICT 22 (HELLYER AVENUE - SILVER CREEK VALLEY ROAD) FOR FISCAL YEAR 2018-2019 AND LEVYING ASSESSMENTS

**WHEREAS**, the Annual Budget Report contains changes for the fiscal year, the proposed budget, the annual levy, the assessment roll and assessment diagram; and

**WHEREAS**, the City Council has considered the Annual Budget Report, remedied and corrected any errors or informalities in the Annual Budget Report and revised and corrected any of the acts or determinations of the various City officials as contained therein;

- The Annual Assessment in the Annual Budget Report does not exceed the average annual change in the San Francisco-Oakland-San José, CA Consumer Price Index.
- 2. The Annual Budget Report and each of the assessments therein as duly revised and corrected, are hereby approved, confirmed and adopted.
- City staff is directed to pay any required City contributions as set forth in the Annual Budget Report.
- 4. The Annual Budget Report together with the certification of the City Clerk as to the place and date of approval by the City Council, shall forthwith be delivered to the Director of Public Works of the City of San José who shall thereafter deliver the assessments to the officer of the County of Santa Clara designated by law to extend City taxes upon the tax roll, and the proper County officer shall cause to be posted to the tax rolls the assessments to be collected for the fiscal year as set forth in the Annual Budget Report as confirmed.
