The Public Safety, Finance, and Strategic Support Committee of the City of San José convened in Regular Session at 1:35 p.m. in Council Chambers, City Hall.

Fire Chief Curtis Jacobson, Fire Marshals Cheryl Westling, Diane Buchanan and John Caligari presented the Report and responded to Committee questions and concerns.

<u>Public Comments:</u> Tina Morrill offered comments and resources on communicating with the residents in community-speak. Suzanne Marione commented on all 45 citations arbitrarily forgiven by the City in negation of its laws and contrary to expectations.

Chief Deputy City Attorney Danielle Kenealey responded to questions and concerns on the dismissal of all the aforementioned citations and clarified the rationale.

Councilmember Sylvia Arenas left the meeting at approximately 3:36 p.m.

<u>Action</u>: Upon motion by Councilmember Sergio Jimenez, seconded by Councilmember Chappie Jones, and carried unanimously, the Committee accepted the report and cross referenced to the September 12, 2017 City Council meeting for full adoption, with directions to staff to provide informal, verbal status update before New Year's Eve that includes elaborating on plausible reasons why individuals may qualify for hardship waiver. (3-0-2 Absent: Carrasco, Arenas.)

Fire Chief Curtis Jacobson and Emergency Services Director Ray Riordan presented the Report and responded to Committee questions and concerns.

Councilmember Chappie Jones expressed the concern that constituents in his District 1 had no clue and wouldn't know what to do if a disaster happened tomorrow and imagined that addressing disaster ought to be of a high priority in terms of Emergency Services.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Chappie Jones, and carried unanimously, the Committee accepted the report and cross referenced to the September 12, 2017 City Council meeting for full adoption. (5-0.)
