As I understand it, the purpose of the Youth Commission is to alleviate the problems faced by youth in the city by working on various projects to improve the education, living conditions, and community understanding of youth.

1. Social Media Addiction - Many students become too occupied with social media in high school or even middle school, leading to negative views later in life about their own lives, and a preoccupation with how they are perceived by others. This can lead to an unhealthy frame of mind and a lack of focus on actually studying in school, which can hinder students' ability to do well in classes and make them unable to find meaningful employment later in life. The Commission can create programs to encourage healthy social interaction to create a healthier state of mind in our youth. 2. Addictive Substances - Because of exposure to addictive substances during youth, many students become more likely to end up without jobs or commit crimes in the future. By giving students more education related to addictive substances, the Commission can prevent these problems from happening, improve public health, and reduce deaths or crimes caused by addictive substances. 3. Dropout Rates - The dropout rate of San Jose students is high, which leads to a community that is less informed and educated. I am always eager to do everything I can to help my community and to make the lives of the people in my community better. A lot of the places I volunteer at are there to help low-income families, which is great because I love to help others in a hands-on way.

Some of the problems facing the youth of San Jose are lack of guidance, mental health, and stress from school. Most youth today have very little idea about what they want to do in their future or even what field they want to go into. It's stressful for teenagers especially because you usually have to choose your classes and extracurriculars based on what they want to go into since getting into colleges have become even more competitive. School counselors can help guide students, but most school counselors have hundreds of students. Also, keep in mind that schools in San Jose may lose counselors in the future as East Side Union School District has already shown interest in decreasing the number of counselors in school no matter how many students there are in the school. Students in San Jose also face the immense pressure to go into computer sciences and engineering because they live in the heart of Silicon Valley. Mental health and stress from school also heavily impacts youth in San Jose. Many teenagers have a diagnosable mental illness but do not receive treatment for them. I know in my community and many other communities in San Jose have the same attitude toward mental illnesses, which is that they aren't important. Schools do a little about mental health awareness for students at the beginning of the year but I think it's important to remind students that their health should be the most important thing in their life all year round and give students more opportunities to get help. Reaching out to parents and teaching them the importance of mental health and how to talk to their children about it is also important. Academic pressure is a common obstacle for youth. Many find stress in trying to balance academics, sports, clubs or other extracurriculars, and a social life, youth today feel like they're being pulled in 500 different directions. Helping students learn when too much is too much is another thing I think the Youth Commission can help with.

I am very passionate about community service and involvement and have a long history of giving back and getting involved with the community. - For example, I noticed that Evergreen, my community, doesn't have a dedicated Teen Center like many other communities do. This lead me to work with members of the City to incorporate a Teen Center at the Evergreen Community Center. This center provides an ideal location for Teenagers to get involved with their local community, and even give back to the community through the Teen Committee while staying out of trouble - something that didn't exist before. (Program Launches April 2018) - Through the YC, I helped pass a Graffiti Wall idea that would help boost tourism, and provide a location for Teenagers to demonstrate their artistic skills - effectively reducing vandalism. - I learned to give back to the community through my 8+ years of being a Boy Scout. I have over 250 hours of general scout volunteering (picking up trash, collecting food, soup kitchens, etc.), and am currently a Life Scout - the second highest rank in Boy Scouts. I have cleaned up beaches, built benches, tables, shades, and more at schools, community centers, and parks. - I founded a 501(c)-3 non-profit called Project enVision in 2015 to give Teenagers the platform to give back to the community. For over 2 years, our goal was to provide STEAM classes in community locations in San Jose (libraries, community centers, etc.). I provided a platform for any Teenager to easily give their skills to their community. Through my dynamic partnerships with the City, teenagers were able to easily teach classes such as programming, speech and debate, tutoring, robotics, and more. In 2018, I decided to take it a step further and started fundraisers for community causes, while continuing to create classes and events at community centers and libraries. I started book drives to start Libraries in 3rd world countries, purchased computers at discounted rates through partnerships with Google and Microsoft, to provide to lower-income schools. I have personally volunteered 1000+ hours, and have received the Presidential Gold Volunteer Award. - I am also a Congressional Award: Silver Medalist. From 2015 to 2016, I worked as a fundraiser for Asoddeca Dental Mission, a nonprofit in Arequipa, Peru, that provided free dental care to the local children in need. During that time I raised \$6,690 through crowdfunding. In the past, I have volunteered at the library, helped set up and waited tables at the Crab Feast, packaged food for the poor with Rise Against Hunger, and helped out at the senior center. In 2017 I was selected to serve in the Santa Clara Valley Water District Youth Stewardship Commission where I learned about California's water system, toured the Santa Teresa Water Treatment Plant, Water Quality Lab, and Silicon Valley Advanced Water Purification Center, and visited local waterways. I currently tutor math and science after school at Willow Glen High School.

In one paragraph, please explain your community interests.

I want San Jose to be a place where today's youth can thrive in the future. In order for that to happen, youth need to have safe schools and neighborhoods, a sustainable relationship with the environment, and a reliable water supply. San Jose has made headlines recently regarding its rise in violent crime, most disturbingly youth crime. Just in the past three months, my neighborhood has experienced a series of thefts and attempted break-ins, which, coupled with my growing fear of gun violence in schools, has convinced me that something has to be done to address these problems. Furthermore, what with global warming, climate change, and pollution, the relationship between humans and the environment is unsustainable and people throughout the world have been coming together to try to save the planet. I believe it is important to unite the people within the community to do what they can to help the environment on a local level. Reducing waste is key to reducing the impact that our community has on the environment, and, just by looking at the actions of youth around me at my own school, I can see that many do not take the benefits of simple recycling seriously. Although there is both a recycling bin and trash can in each class, the majority of both garbage and recyclables just go into the trash. I am interested in helping youth understand the mark that they leave on the environment and prompting efforts at waste reduction and environmental awareness throughout the community. In addition, my time with the Santa Clara Valley Water District Youth Stewardship Commission has made me aware of the importance of water supply reliability. Currently, 55% of our water is imported from the Sacramento-San Joaquin Delta, which faces many threats, such as land subsidence, sea level rise, climate change, ecosystem decline, and loss of natural habitat. Most of today's youth, and even adults, do not understand how vulnerable our water supply is.

As I described above, the youth of San Jose is faced with rising crime and gun violence, the need to confront global environmental issues and sustain the environment, and a fragile water supply system. Since 2012, there have been over 180 school shootings in the United States, and lately it seems that barely a month passes by before news of another school shooting reaches today's youths. The fear that a school shooting will occur at a school in San Jose is palpable and the need for gun control is stronger than ever. While school shooting has lately been a nation-wide topic, global warming and climate change have been prominent issues for some time, although the significance of these issues are harder for youth in San Jose to realize because their impacts are indirect. Actions need to be taken on a home and school scale to reduce waste and lessen our footprint on the environment. Global warming and climate change has already affected the citizens of San Jose - last year was the end of a 5 year long drought that seriously threatened our water system. Our reservoirs were depleted and, though the drought fortunately ended before jeopardizing our water supply drastically, had it continued then serious problems would have ensued. The drought made it clear just how unreliable our water system currently is. These are not the only problems facing today's youth. Homelessness is also a major issue in our creeks and waterways that impacts our water quality and stream habitat. The issue of homelessness is all the more urgent given the unaffordable housing market of Silicon Valley. With the median home price of San Jose above one million, many of today's youth might be unable to afford to live here in the future. Another related issue that is extremely important to youth is the quality of teachers in public schools, as it is getting harder to attract good teachers with the limited pay that is being offered.

# What do you feel the priorities of the Youth Commission should be?

The priorities of the Youth Commission should be to raise awareness of youth about these issues and link with youth and local agencies to develop plans and implement actions to address them. As a Youth Commissioner, I would reach out to more schools to inform students of the issues facing San Jose, of the efforts already being made by fellow youth to make a difference, and to help make their voices heard. There are many youth who do not understand the issues facing the community and it should be a priority of Youth Commissioners to provide them with an outlet to utilize the power of their opinions and actions. After engaging youth who are passionate about facing these issues, I would build up a strong and driven District 9 Youth Advisory Council (YAC), and together we would brainstorm policies that can protect schools from gun violence, develop systems to more effectively reduce waste, and educate youth about our county's water supply. The Youth Commission should also partner with local agencies to confront the issues stated previously. I have already contacted the Santa Clara Valley Water District (SCVWD) and found out that it has an outreach program with the goal of raising awareness of our water supply, and with the Youth Commission helping the SCVWD to connect with today's youth, we can tackle the issue of a fragile water supply system head on. By engaging as many youth as possible in making a difference in the community and actively solving issues throughout the community with the support of local agencies, the Youth Commission can truly turn San Jose into a place where today, and for generations after, youth can prosper.
