When I retired from the San Jose Mercury News in 2013, one of the primary reasons was to work with non-profit arts and community groups in San Jose. (As arts and entertainment editor of the paper, it would have been a conflict of interest to work with them while still at the paper.) Since my retirement, I have worked with a number of arts groups and joining the Arts Commission would be a next step in what I see as my being an advocate for a robust arts community in the city. Clearly, with the demise of such key arts organizations as the San Jose Rep and the Ballet San Jose, we now face a true challenge in both maintaining the rich, vibrant culture our city has and building on that foundation as we move forward. I would use my experience and energy to work towards that goal. Specifically, I would hope to solve the venue issues faced by many smaller companies, help to increase the collaboration between San Jose's diverse arts groups and raise public awareness -- particularly among our younger citizens -- of the arts and entertainment San Jose has to offer.

During my nearly 30 years at the Mercury News, I held a number of editing and writing positions including city editor, state editor and news editor which give me a knowledge of how the city of San Jose functions. But I spent the final 14 years of my Mercury News career as arts and entertainment editor for the paper and as an arts and entertainment writer. In those roles, I was able to build a broad knowledge of the city's culture, from street festivals and ethnic dance companies to Symphony Silicon Valley and Opera San Jose. I have been a member of the San Jose Arts Commission since February 2017 and feel I have contributed to the work of the commission during that time. Over the past four years, I have served on the boards of the City Lights Theater Company, the Happy Hollow Park & Zoo Foundation and the San Jose Downtown Association Foundation. All have very different issues facing them and I feel I have been able to contribute to the board's work on all three. At City Lights, I was voted president of the board in 2015-17. At Happy Hollow, I served as chair of the board's Government Relations Committee as well as working extensively on its signature fundraising event, Hoot and Howl.

My experience at UCI included organizing research and events (i.e, setting goals, funding, and administering) according to academic excellence and the University of California's policies of multicultural composition of California. I bring a skill set that includes, writing, supervising grant application, problem-solving in private-public funding negotiation, teaching, public speaking, and planning art in multi-cultural settings.

What is your understanding of the purpose of the Commission?

The Art Commission is an advisory board that provides the city council and the mayor with informed recommendations about art, how to make a connection between the arts and communities, and how to encourage artistic development and policies that would benefit the city at large.

Please list three issues facing the City that you feel the Commission should address.

In face of decreasing public funding, the city needs a comprehensive plan to encourage a combination of private and public efforts. This can turn to a positive process of building coalition across diverse communities and corporate sponsors. For instance, in my district (6), a few parents have formed a nonfor-profit organization that takes care of performing arts after school, which has proved to be a successful effort. Lessons learned from these existing efforts, not only in terms of funding but more importantly, in terms of emerging workable ideas, need to make their way to the decision making processes. Yet another issue is the way in which art is visible in the city, through galleries, museums, performance venues, and film screening. There is a lot of art around but it is not clear what impact they have and what role they play in the city. I think that the Sonic Runway project provided a good case for thinking through the issue of visibility and impact. This project positively involved participation by people as well as projecting the city's ambition, which makes the art scene commensurate with the vibrancy and stature of San Jose as the capital of Silicon Valley.

Describe recent San José arts activities you have participated in during the last twelve months (up to five activities) and what drew you to attend?

The Sonic Runway exhibition, 2017-18, Playa to the Paseo, is a positive example of public art that has had a great effect on the city. The impact is felt both locally and nationally and has been instructive in defining future art projects in the city. However, there are other important events that happen in San Jose and are equally crucial for the city's vibrancy. As a resident of the District 6th, I have participated in WG Dancing on the Ave and First Friday downtown. Willow Glen, Lincoln Ave events, particularly, are of interest to me because they address San Jose's diverse communities. Other events that include artistic activities are ethnic festivities. I can mention two of these that I have participated in, first, Tết, Vietnamese New Year Jan 28th, 2017 (I found Vietnamese Town and its culture another source of vibrant culture in Silicon Valley), and secondly, Iranian events at San Jose State University. As a former board member of San Jose State University's Persian Studies Center, in 2017, I have attended the San Jose State U. Iranian New Year (March 21) Concert and the Yalda event (December 21), both Iranian equinox celebrations. As a scholar of visual cultures, I attend Cinéquest Film Festival yearly. Additionally, I believe greater visibility in the arts, matching the technological innovation of the city, can complete the city's ambition of being on the forefront of setting standards for cities in the nation.
