SUBJECT: SIXTH AMENDMENT TO THE AGREEMENT WITH ARTHUR J. GALLAGHER AND CO. INSURANCE BROKERS OF CALIFORNIA, INC. FOR BROKERAGE SERVICES

RECOMMENDATION:

Adopt a resolution authorizing the City Manager to negotiate and execute the Sixth Amendment to the Agreement with Arthur J. Gallagher and Co. Insurance Brokers of California, Inc. (Gallagher) for ongoing insurance brokerage and property loss and loss control services to amend the term by adding one twelvementh option to extend the term for July 1, 2018 through June 30, 2019, for a not to exceed amount of \$88,500, and one twelve-month option to extend the term for July 1, 2019 through June 30, 2020, at an amount to be negotiated, subject to appropriation of funds.

Desired Outcome: Provide operational continuity of the existing insurance policies and upcoming annual placement and renewals.

BASIS FOR RECOMMENDATION:

The City of San José transfers exposure for catastrophic property losses through the purchase of insurance.

In 2013, Council approved the execution of an agreement with Arthur J. Gallagher for insurance brokerage services following a Request for Proposal (RFP) process. Under the agreement, Gallagher goes to market on the City's behalf to procure property and casualty, environmental, fiduciary, crime, auto, secondary law enforcement, and customs bond insurance. In addition, Gallagher provides account management, administration, and claim services to include review of property insurance market trends, past losses, insured assets, industry trends, and trending costs for local property values.

Approval of the above recommendations will ensure continued quality insurance and loss control brokerage services at competitive rates for the City and allow staff time to prepare and complete a new RFP for brokerage services.

Commission Requirements: This item does not have input from a board or commission.

This Council item is consistent with the City's 2018-2019 Proposed Operating Budget Strategic Support City Service Areas Mission Statement; "To effectively develop, manage, and safeguard the City's fiscal, physical, technological, and human resources to enable and enhance delivery of City services and projects."
