- Council District 3: Richard Wong and LaToya Fernandez
- Council District 5: Mimi Hernandez and Jewell Buchanan
- Council District 7: Jonathan Velazquez and Juan Quiñones
- Council District 9: Terry Martin and Michael Young

OUTCOME

Council consideration and approval of the completed Neighborhoods Commission 2018 caucus nominations will enable the City Council to fill vacancies in Council Districts 1, 3, 5, 7, and 9.

BACKGROUND

On April 10, 2018, the City Council approved the 2018 Neighborhoods Commission Caucus Process to fill vacancies in odd-numbered Council districts as outlined in Section 2.08.3450 of the San Jose Municipal Code. Per the Municipal Code, Commissioners serve for four years with the appointment of all odd-numbered district seats happening together and, two years later, all the even-numbered district seats coming up for appointment. The Neighborhoods Commissioner appointments follow the same calendar as the Council district elections. The Analysis section of this memorandum outlines the candidates nominated by the neighborhood groups to be considered for appointment by Council.

ANALYSIS

Recruitment for commission candidates for the vacancies was coordinated by City staff with the City Clerk's Office, Council Offices, and the Neighborhoods Commission. Recruitment and registration of neighborhood group members to act as voting delegates for the caucuses was facilitated by City staff and the Neighborhoods Commission. Any candidates for a caucus did not participate in the organization of their caucus nor in selecting the delegates for each neighborhood group. There were 27 applicants for the ten vacant commission seats.

City staff held Neighborhoods Commission caucuses in odd-numbered Council districts in April and May of this year:

- Council District 3: Wednesday evening April 18, at City Hall, Tower Conference Room 1753
- Council District 5: Wednesday evening April 25, at Alum Rock Branch Library
- Council District 9: Tuesday evening May 5, at Camden Community Center
- Council District 7: Thursday evening May 7, at Tully Community Center
- Council District 1: Saturday morning May 12, at West Valley Branch Library

As a result, residents participating in the Council district neighborhood caucuses nominated the following applicants for Council consideration and appointment to the Neighborhoods Commission:

- Council District 1: Gary Cunningham and Franklin Nguyen
- Council District 3: Richard Wong and LaToya Fernandez
- Council District 5: Mimi Hernandez and Jewell Buchanan
- Council District 7: Jonathan Velazquez and Juan Quiñones
- Council District 9: Terry Martin and Michael Young

The applications of all nominated candidates are attached. Memoranda from the City Manager's Office, Office of the City Attorney, Department of Planning, Building, and Code Enforcement regarding their conflicts of interest and code enforcement reviews are also included.

EVALUATION AND FOLLOW-UP

Caucuses will be held for even-numbered Council districts in the spring of 2020. Following Council direction from August 22, 2017, this caucus had considerably more seated Commissioner responsibilities regarding logistics and coordination as well as facilitation of the caucuses. Council staff helped to determine which Neighborhood Associations were active at the time and City Manager staff took notes and stepped in when there were concerns about electioneering happening during the caucus.

Since individuals attempted to campaign in 3 of the 5 caucuses and one caucus candidate was also a candidate in a Council election, staff is evaluating shifting the caucus process so that the caucus for each district are not happening in that same year as the Council Office elections. Staff will return with a recommendation in the winter of 2018.





BACKGROUND

This office routinely reviews applications to City Boards, Commissions, and Committees. Although these applications do not provide complete information, they occasionally disclose potential conflicts of interest or incompatible offices. This memorandum highlights major areas of potential conflict disclosed in the applications. However, this review is limited to the information provided, and is not intended to be a comprehensive investigation of potential conflicts involving the applicants.

COMMISSION DUTIES

The Neighborhoods Commission is an advisory body to the City Council. (SJMC §§ 2.08.3400 *et seq.*) It studies, reviews, evaluates, and makes recommendations to the City Council "regarding issues, policies, and programs affecting the quality of life in San José neighborhoods, focusing on neighborhood safety, transportation, and code enforcement." (SJMC § 2.08.3430.) In addition, it serves as a Citizens' Oversight Board that reports to the City Council about revenue expenditures generated from the November 2016 voter-approved sales tax. (Reso. No. 78016.)

COMMISSION MEMBERSHIP

The Commission is a 20-member body. Each member must reside within the boundaries of the council district for the seat to which he or she was appointed during the term of that seat. (SJMC §§ 2.08.3410, 2.08.3420.) If a member is no longer a resident of the council district, the seat will be deemed vacant.

Commissioners are appointed by the City Council after being nominated through a neighborhoods caucus process, which will occur in Spring 2018. (SJMC § 2.08.3440.A.)

LEGAL CONFLICTS THAT MAY PRECLUDE VOTE OR PARTICIPATION

Certain positions may preclude a commissioner from participating in a commission discussion or from voting on a matter if there is a conflict. While this list is not complete, conflicts generally fall within the following situations:

- An application shows entities that are "sources of income" to a potential commissioner within the 12 months preceding the start of the commission term, as defined under the Political Reform Act.
- An application shows sources of income to a spouse or Domestic Partner of a
 potential commissioner within the 12 months preceding the start of the
 commission term.
- An applicant or the spouse or Domestic Partner of an applicant, is an Officer
 or Board Member of an entity and it is foreseeable that the entity could be
