SUBJECT: RETROACTIVE APPROVAL OF THE CANADA DAY FLAG RAISING AND RECEPTION SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE **EVENT**

RECOMMENDATION

- 1. Retroactively approve the Canada Day Flag Raising and reception scheduled on Friday, June 22, 2018, as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Retroactively approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on June 26, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Canada Day Flag Raising will be held on June 22, 2018 in the San Jose City Hall West Plaza and sponsored by Councilmember Raul Peralez. This special event is to celebrate Canada Day. The event is free and open to the public.

The display of the Canadian Flag on June 22, 2018 is permitted under Council Policy 2-1, Section C.1 - Flags of Governments Recognized by the United States: "Flags of the governments recognized by the United States may be displayed upon the request of the Mayor, a member of the City Council or the City Manager" and C.2 - Flags Displayed in Conjunction With Official Ceremonial Items: "Other flags may be displayed in conjunction with official actions, ceremonial items, or proclamations of the City Council."
