RECOMMENDATION

- 1. Retroactively approve the Metzger Ranch Clean Up scheduled on June 9, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the June 26, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Metzger Ranch Clean Up was held on June 9, 2018 and sponsored by Councilmember Arenas. This special event brought the community together to clean up Metzger Ranch. The event was free and open to the public.

ANALYSIS

Retroactive approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events.
