These statements made to numerous media outlets contradict his video taped testimony at the May 22, 2018 City Council meeting and reinforce our contention that he lacks the integrity to remain in his current position.

First, it is important to note that our allegation of official misconduct does not rest solely upon the now infamous pages 35 and 36 of Mr. Zisser's initial 2017 Annual report where Mr. Zisser purposefully sought to sensationalize statistics centered on race and policing. Rather, pages 35-36 represent the most egregious examples of Mr. Zisser's cavalier behavior.

With regards to Mr. Zisser's use of data relative to disparities in the treatment of suspects by San Jose Police based on race, on June 25 Mr. Zisser stated the following to the San Jose Mercury News:

Zisser later clarified that the section was meant to demonstrate the usefulness and limitations of the dashboard, not to make a definitive statement about race and force.

"We were showing what was available on the dashboard," he said. "Could we have done it a bit better? Absolutely."

Mr. Zisser's excuse is absolutely untrue. A simple review of the initial (rejected) 2017 Annual Report or Mr. Zisser's presentation to the City Council on May 22, 2018 validates that Mr. Zisser <u>at no time</u> presented the "limitations" of the dashboard data based on the small number of incidents. Rather, Mr. Zisser stated that the "limitations" of the dashboard data were primarily the fact that the information is predominantly taken from police officer reports and that it only involves "reportable uses of force." Further, Mr. Zisser stated the limitations also included only "force" contacts vs. all "contacts." We include this slide from Zisser's presentation below:

Further, Mr. Zisser fails to disclose to the public, through his media interviews on June 25, that throughout his initial report he highlights "Key Statistics". These "Key Statistics" are explicitly separated and highlighted from all the other data presented in his initial report. Below is how Mr. Zisser chose to highlight this particular data from page 35-36 regarding disparate treatment based on race:

Key statistic
White suspects were reportedly more than 2.5 times
more likely than Latinos and 81% more likely than
Blacks to leave a use-of-force incident with "no
charges" referred.

#### ii. Officer-involved shootings

While we respond to the scene, participate in the 90-day review panels, and review other information about officer-involved shootings, the IPA office's insights into such incidents are limited. First, we receive very few citizen complaints regarding officer-involved shootings and therefore audit very few IA

investigations of such incidents. Second, Duty Manual section L 2646 mandates that the Chief of Police provide, on an annual basis, a public summary of the Panel's deliberations and recommendations to the Mayor and City Council.<sup>6</sup> These annual summaries have not been provided. We urge the Department to produce a summary reflecting panel reviews conducted in 2017 and to ensure that timely reports are made public each year. Chief Garcia has indicated that SJPD will issue these reports. 2017 saw a relatively high number of officer-involved shootings, though 2015 marked the

As you can see, this was not a simple stating of the alleged "facts" or a demonstration of the limitations of the dashboard. Mr. Zisser's key statistic is meant to draw the reader's attention to the percentages highlighted. We do not know who Mr. Zisser thinks he is kidding, but the intent behind the data is clear. Nowhere in highlighting this "key statistic" is information for the reader informing them that the data derives from three, just three cases where a suspect was sent to jail. In fact, to arrive at the statistics presented by Mr. Zisser here, he could not rely on the dashboard, he performed his own calculations to get at the "2.5 times more likely" and "81% more likely". His intent was to inflame the public and drive a wedge between people of color and police officers. It's shameful.

Further, Mr. Zisser stated the limitations also included only "force" contacts vs. all "contacts." We include this slide from Zisser's presentation below:

Further, Mr. Zisser fails to disclose to the public, through his media interviews on June 25, that throughout his initial report he highlights "Key Statistics". These "Key Statistics" are explicitly separated and highlighted from all the other data presented in his initial report. Below is how Mr. Zisser chose to highlight this particular data from page 35-36 regarding disparate treatment based on race:



#### ii. Officer-involved shootings

While we respond to the scene, participate in the 90-day review panels, and review other information about officer-involved shootings, the IPA office's insights into such incidents are limited. First, we receive very few citizen complaints regarding officer-involved shootings and therefore audit very few IA

investigations of such incidents. Second, Duty Manual section L 2646 mandates that the Chief of Police provide, on an annual basis, a public summary of the Panel's deliberations and recommendations to the Mayor and City Council. <sup>6</sup> These annual summaries have not been provided. We urge the Department to produce a summary reflecting panel reviews conducted in 2017 and to ensure that timely reports are made public each year. Chief Garcia has indicated that SJPD will issue these reports. 2017 saw a relatively high number of officer-involved shootings, though 2015 marked the

As you can see, this was not a simple stating of the alleged "facts" or a demonstration of the limitations of the dashboard. Mr. Zisser's key statistic is meant to draw the reader's attention to the percentages highlighted. We do not know who Mr. Zisser thinks he is kidding, but the intent behind the data is clear. Nowhere in highlighting this "key statistic" is information for the reader informing them that the data derives from three, just three cases where a suspect was sent to jail. In fact, to arrive at the statistics presented by Mr. Zisser here, he could not rely on the dashboard, he performed his own calculations to get at the "2.5 times more likely" and "81% more likely". His intent was to inflame the public and drive a wedge between people of color and police officers. It's shameful.

peak in recent years.

The question then becomes, did Mr. Zisser treat all statistical cases throughout his initial report in the same manner? No. As you can see from the presentation slide below, when presenting information on Use of Force: Officer-Involved Shootings and mentally ill suspects, he uses both the raw data and the percentage to provide perspective. Why the difference?



Mr. Zisser is now stating publicly to the media that "I immediately committed to making the changes and have done so... worked closely with the Chief and his office to understand the concerns, so our changes were responsive." As you

know, this is the exact opposite of what Mr. Zisser said and did at the May 22, 2018 City Council meeting. In fact, he in essence told you, his boss, to go pound salt.

Mr. Zisser's exact words on May 22, 2018 in rejecting the council's request to correct his admitted misleading report was the following: "I am very disinclined to modify the report" and while chuckling he said "I guarantee you Councilmember there are other inaccuracies in this report" and "We can not be perfect, we can not get it right.". He also stated: "I'm not comfortable taking out all of this data."

Mr. Zisser admits his report was misleading but is uncomfortable taking out the misleading data and replacing it with accurate data and context. Wow. Mr. Zisser's statement that he immediately committed to making changes is untrue, false, misleading, and continues a pattern of avoiding the truth. His defense of his shoddy initial report provides even more proof that he lacks the integrity, openness and objectivity to perform the job the City Council appointed him to.

Setting aside Mr. Zisser's attempt to rewrite history yesterday through a series of media interviews, a troubling practice for someone charged with ensuring police accountability, we direct you to Chief Eddie Garcia's presentation to the City Council rebutting Mr. Zisser's initial annual report. We have never witnessed a Chief of the San Jose Police Department forced to publicly correct the IPA's annual report in so many instances. It is because of Chief Garcia that we now know that Mr. Zisser's "Key Statistic" on racial disparity rested on just 3 incidents. Mr. Zisser hid that from the public.

It is because of Chief Garcia that the Council was able to learn that use of force complaints were down, making up only 5.25% of all use of force cases in 2017 vs. 9.39% in 2016 (That's a decrease of 178.9% in Zisserspeak). Mr. Zisser chose to characterize that same statistic as follows: "Complaints regarding force are down dramatically, though much of this decline may track the overall decline in use of force during the same general period of time." As Chief Garcia pointed out, total uses of force remained steady between 2016 (639 total cases) and 2017 (629 total cases). Uses of force went down by 1.56%, obviously not proportional to the 178.9% drop in the percentage of uses of force versus use of force complaints.

In order for police oversight to have legitimacy, it must be deemed fair and unbiased by the public and the police officers. The stakes are too high for us to simply chalk up Mr. Zisser's omissions, mistruths, and exploitations of data as "a rookie mistake." Mr. Zisser sold himself to the public and to the Council based on his extensive resume as a lead attorney with the Department of Justice with extensive experience in overseeing law enforcement related cases germane to the IPA's job.

We simply no longer trust Mr. Zisser's ability to carry out his duties in an impartial manner. We urge you to initiate the investigation we requested, just as would happen to any San Jose police officer accused of misconduct, incompetence, and including misleading information in an official city report.

Re: Formal Complaint of Alleged Misconduct by IPA Aaron Zisser

Dear Mayor Liccardo:

The undersigned members of the San Jose Police Department allege that San Jose Independent Police Auditor Aaron Zisser ("IPA") has committed official misconduct that warrants his removal from office.

The San Jose City Council is the only body with the power to watch over this rogue watchman, and it must hold him accountable for his clear dereliction of his official duty.

The decision to file this formal complaint was not taken lightly. The police officers that serve our city must adhere to the highest standards of ethics and conduct in the performance of their official duties and when they do not meet these standards, then they are held accountable. We, as well as yourself, the city council, and the residents of San Jose, should expect no less from the individual appointed to oversee the members of the police department.

## Jurisdiction and Request for Investigation

According to the City Attorney, the below charges, remedy requests, and demand that the City Council of San Jose undertake its investigative oversight function must be directed in the first instance to the Mayor. (See attached Letter from Rick Doyle, dated June 12, 2018.)

By this letter, the undersigned formally request that the Mayor and City Council investigate the actions, omissions and official misconduct of the IPA relating to the discharge of his official duties, specifically concerning the preparation and delivery of the 2017 IPA Year End Report for review by the City Council on May 22, 2018. To the extent such investigation substantiates the

below charges or uncovers additional misconduct, the undersigned request a vote by the City Council on the question of whether the IPA should be removed.

### Relevant Codes, Policies, and Oaths

The duties of the IPA are prescribed within the San Jose City Charter, Code of Ethics, Municipal Code, and Administrative Policy Manual.

### **City Charter**

The San Jose City Charter states: "City officers and employees must be independent, impartial and responsible in the performance of their duties and accountable to the members of the public." (Section 204 [emphasis added].) Section 607 of the San Jose City Charter complements this by requiring the City to adopt and maintain a Code of Ethics "to provide guidance to City officers and employees in their conduct while discharging their public responsibilities."

#### **Code of Ethics**

The purpose of the San Jose Code of Ethics is to charge "elected and appointed officials, and employees of the city" with the responsibility of "creat[ing] a City government that is responsible, fair, honest, and open." It was created to remind City officials and employees that they are "expected to demonstrate the highest standards of personal integrity, honesty and conduct in all activities in order to inspire public confidence and trust in City employees." [Emphasis added.]

The Code of Ethics requires City officials to be "impartial and responsible in the fulfillment of their duties." They must "maintain the highest standards of integrity and honesty, and they are expected to treat all members of the public and fellow City employees with respect, courtesy, concern and responsiveness. The conduct of City officials and employees in both their official and private affairs should be above reproach to assure that their City position is not used for personal gain." [Emphasis added.]

#### **Administrative Policy Manual: City Values**

The City also maintains a list of values that employees and City officers should seek to embody. (San Jose City Administrative Policy Manual 1.2.4.) These values are meant to "serve as a foundation for how the City operates," and include "integrity" and "respect." Integrity is defined to include "[u]phold[ing] the highest work ethic" and "[being] open[,] honest, and accountable," and respect is defined to include "[t]reat[ing] everyone fairly."

#### IPA-Specific Charter, Municipal Code, and Mission Statement

These standards are also embedded in the rules governing the IPA. Under City Charter section 809 and Municipal Code section 8.04.010(A), the IPA is responsible for reviewing police

professional standards and determining that investigations against officers are "complete, thorough, <u>objective</u>, <u>and fair</u>." [Emphasis added.] The IPA's own website acknowledges that its mission is to "instill confidence in the complaint process through objective review of police misconduct investigations." (<a href="https://www.sanjoseca.gov/ipa/">https://www.sanjoseca.gov/ipa/</a>.)

### Procedure for Removing the IPA

Section 900 of the City Charter defines the IPA as a City officer. By a vote of ten or more members, the City Council may remove the IPA for "misconduct, inefficiency, incompetence, inability or failure to perform the duties of such office or negligence in the performance of such duties, provided it first states in writing the reasons for such removal and gives the incumbent an opportunity to be heard before the Council in his or her own defense[.]" (City Charter, § 809.)

A violation of the City's Code of Ethics by a City official "constitutes official misconduct." (San Jose City Administrative Policy Manual 1.2.1.

### **Authority for Investigative Powers**

As the City Attorney has explained, the broad authority that the City Charter delegates to the City Council to review misconduct by the IPA brings along with it the power of investigative oversight, or at least the authority to have "misconduct, inefficiency, incompetence, inability or failure to perform the duties of such office or negligence in the performance of such duties" investigated. (City Charter, § 809; Doyle letter.)

#### IPA Zisser's 2017 Report and His Presentation of the Report

The IPA's 2017 Report - as submitted to the City Council for review - excluded raw data in a critical, highly sensitive section (relating to peace officers and the use of force against racial minorities). This omission misled the public about how robustly the Report's findings were supported. It effectively shaded the Report's conclusions to more closely align with the IPA's desired conclusions - confidence intervals and basic statistical competence be damned.

In the City Council's hearing on May 22, 2018, the IPA was present to discuss the 2017 Report. At that hearing, Mayor Liccardo said to the IPA: "I guess the problem is you're presenting statistics as if somehow or another we should draw an inference from the conclusion, when I know that if there was just any change in any variability of one person in one incident in any of those categories [it] would lead to a completely different conclusion."

The IPA then admitted: "I think the criticism is fair. I think the use of statistics or percentages rather than numbers - I can see now that that was misleading." Despite acknowledging that the Report was misleading, the IPA maintained that he was "very disinclined to modify the report." He "guarantee[d]" the Council that there were other inaccuracies in the report, and that his office "cannot be perfect."

But this is not about perfection. This is about competence, honesty and impartiality.

This point was underscored when the IPA attempted to mislead the Council about its own hearing. The Mayor had to interrupt to object to the IPA's characterization of his request. "Let me be really clear," the Mayor said, "I never asked you to take data out. What I asked you was to insert raw data - which is far more accurate and far less misleading."

As the Mayor then explained, the IPA's report and behavior evidenced a "cavalier attitude" about the importance of full disclosure concerning how robust his findings were.

#### **Analysis**

The IPA failed to discharge his responsibilities to comply with the letter or the spirit of the Code of Ethics and his charge under the City Charter. He was not "fair, honest, and open" and did not "demonstrate the highest standards of personal integrity, honesty and conduct." He was not "impartial" and brought "reproach" on the City in his public affairs.

The IPA cavalierly dismissed the importance of presenting an honest assessment of how robust his findings were.

A person charged with the responsibilities of the IPA should know, errors in official reports concerning race and police officers have real-world impacts.

We allow that the IPA was honest to the extent he admitted that humans are not perfect. But no one was expecting perfection. What we were expecting was professionalism, honesty, impartiality, openness, and a basic level of competence.

The report's blatant decision to ignore the concept of 'statistical significance' as taught in every introductory statistics class constitutes either astonishing incompetence or malice. Either one is misconduct in a report of this prominence on a question of this much importance.

If the City Council determines that the record does not already contain sufficient facts to support a finding of official misconduct, it is incumbent upon the City Council to initiate an investigation and oversight to determine more about the mental state of the IPA during the drafting, finalization, and presentation of the 2017 Report. Motive matters.

#### Remedy

Based on the above, the undersigned request that:

- 1) The City Council investigate the allegations herein and any other wrongdoing or improper acts that come to the attention of the City Council during the investigation; and
- 2) The City Council invoke the procedure outlined in City Charter section 809. The City Council should consider the results of the investigation into the IPA and then hold a vote on such removal after 1) stating in writing the reasons for such removal 2) giving the IPA an opportunity to be heard before the Council in his own defense; and

3) The City Council deliver any other sanction against the IPA or any other City employee or officer that it deems just and proper based on the results of its investigation.

Subject: Re: Police Auditor Aaron Zisser

Mayor Liccardo and All,

The SJSU HRI would like to echo the statements made by SV Debug and the SJ/SV NAACP on the critical role and commendable performance of the Independent Police Auditor, Aaron Zisser.

Further, we would like to introduce two related concerns:

1) If the SJPOA has methodological problems with the reporting of the IPA on (for example) use of force, the obvious solution would be to provide thorough, accurate, publicly transparent use of force data so that such investigations are not required. In fact, we hold the position that ALL law enforcement agencies should have to make their

data publicly available (including reports to the DOJ) such that local and national publics have immediate, accurate access to these statistics.

2) It would be a dangerous precedent for an IPA, who is already arguably hamstrung in their ability to hold law enforcement accountable, to be terminated because of a methodological dispute in a single study. First, methodological disputes should be settled by appropriate professionals, such as those at our Institute. Second, the message sent by termination would be that the IPA's office has little protection from the whims of the SJPOA, (and thus pointless).

We appreciate you taking these concerns into consideration. Thank you all for your time.
