### RECOMMENDATION

- 1. Approve the District 4 Dumpster Day at Vinci Park Elementary School on September 15, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the August 14, 2018 City Council Agenda for action.

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Vinci Park Elementary School Dumpster Day will be held on September 15, 2018 at Vinci Park Way, and is sponsored by Councilmember Lan Diep. This special event is aimed at stemming illegal dumping and informing residents about free junk pickup. The event is free and open to the public.

#### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Diep will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
