2. Monthly Report of Activities for February 2018. (City Auditor)

City Auditor Sharon W. Erickson provided overview of the report and responded to Committee questions and concerns.

<u>Action</u>: Upon motion by Councilmember Johnny Khamis, seconded by Councilmember Chappie Jones, the Committee accepted the Report. (4-0. Absent: Carrasco.)

3. Permanent Installation of Sonic Runway. (Liccardo/Peralez/Davis)

<u>Documents Filed</u>: Memorandum from Mayor Sam Liccardo, Councilmember Raul Peralez, and Councilmember Devora "Dev" Davis, dated March 8, 2018.

Councilmember Dev Davis provided overview of the closing down of the temporary Sonic Runway and the need to have it come back for a longer term or even as permanent installation.

Councilmember Peralez expressed support for a project that brought many activities and folks to City Hall, and urged the Committee to move forward and explore prospect for longevity.

Councilmember Jones sounded a cautionary note that certain projects sometimes become quickly obsolete after a year or two and cited issues around maintenance and upkeep and proposed a temporary status Sonic Runway that runs its course as a caveat, following which the City may decide it's something it wants permanent.

<u>Action</u>: Upon motion by Councilmember Dev Davis, seconded by Councilmember Johnny Khamis, the Committee approved the exploration of long-term or permanent installation of Sonic Runway at City Hall Plaza. (4-0. Absent: Carrasco.)

4. Responding to United States Department of Justice's Lawsuit Against California's Sanctuary State Policies. (Peralez)

Documents Filed: Memorandum from Councilmember Raul Peralez, dated March 7, 2018.

Councilmember Raul Peralez provided overview of the Lawsuit Against California's Sanctuary State Policies by United States Department of Justice and noted that what the State has been doing is completely legal.

Mayor Sam Liccardo and the Committee expressed a sentiment that they are supportive of the State's stance and recommended evaluating available amicus to decide which we want to join.

<u>Public Comments</u>: (1) Jeremy Barus expressed support for immigrants and urged the Rules Committee to join an amicus group, should one be provided. (2) Soledad Tellez implored the Committee to continue to support the immigrant community, and requested all Mayors in California to keep resisting the attacks on immigrant community. (3) Eunice Hernandez (representing Sacred Heart Communities Service), expressed support for Councilmember Peralez's memo. (4) Blair Beekman offered comments on ICE raids and the imperative to practice better civil rights, better civil protections, and the overall welfare of the community.

<u>Action</u>: Upon motion by Councilmember Johnny Khamis, seconded by Councilmember Dev Davis, the Committee accepted the recommendation to direct the City Attorney's office to cooperate with any amicus briefs the State of California or any other local municipalities may be developing to counter the U.S. Department of Justice's (DOJ) lawsuit against California's Sanctuary Policies (AB 450, AB 103 & SB 54) and directed City Staff to provide an update to the City Council on the "Coordinated Response to Immigrant Needs" that was approved by Council on January 10, 2017. (4-0. Absent: Carrasco.)
