As a resident of D2 living very near this intersection, I am deeply concerned about the growth in this area without any obvious concern about the poor condition of this intersection.

Just by driving by this area in the evening hours, you can see criminal and/or suspicious activity taking place most nights. During the day it is clear to see the garbage and decay of the shopping centers. Why 3 new businesses are currently being added to this corner in its current condition is beyond common sense. The prospect of adding the Charities Housing project at the ACO site, when the surrounding area is unsafe and unsightly, seems like a disaster to many residents.

Why not clean up and reclaim the 4 corner area PRIOR to bringing in any additional businesses or residences? Our laws must be enforced! Let's start with a clean slate as far as safety is concerned to give any new, incoming projects a chance at success and safety. Dear Gubernatorial Candidates,

As local government leaders who represent millions of Californians, we urge our future Governor to redirect work and funding from the costly twin tunnels to other projects that unite the state rather than divide it, and to projects that provide new, local water supplies.

Ensuring that more of California's residents and businesses have access to economical, clean and reliable water should be your priority. We request that you reject WaterFix as fiscally irresponsible, environmentally damaging, and divisive and focus instead on real water supply and reliability projects throughout our state, such as local recycling, storm water capture, conservation, and above or below ground storage.

Local projects will add water to the system and promote local jobs and local control. Current and potential future bond funds, along with other incentives, could fund many less controversial projects that will add water to the overall system and not cause harm to the Delta.

Given the significant levels of controversy and a growing litany of legal battles facing the project, it would be prudent for the State to re-evaluate the proposed WaterFix project, in favor of other projects. This includes discretionary administrative decisions associated with WaterFix that this and future Administrations will face, including the State's role in a multi-billion-dollar bond sale to finance the project.

and also decide to blend HSR into CalTrain at Gilroy, then the HSR service would follow the current at-grade tracks. While the current pair of tracks (one for freight, one for both north and southbound passengers) may be adequate for present-day usage, they would need to be significantly improved to handle the increased HSR traffic. This would require at least one additional track (and also the possible realignment to smooth out some of the curves), which would take backyards from many residents, diminish or destroy Fuller Park, and probably require the severing of several neighborhood access ways (Virginia St. and Auzerais Ave.) and the further isolating of communities and limited access to new and planned high-density developments.

For years, HSR has been working with the local communities on the preferred “elevated alternative” – the dotted blue line in the graphic. I too support this alignment: it stays within freeway right-of-ways for much of way, thereby reducing the land impacts and limiting the noise impacts (thanks to the existing sound walls). To minimize construction costs, freight could continue to use the current tracks so that the elevated structure could be engineered for the lighter and more agile passenger trains. (This would also allow for a steeper grade which would enable the tracks north of Diridon to descend quickly and touch down at the Maintenance Yard before Taylor St.)

Additional considerations:

- The HSR tracks will cross a number of existing and planned off-road trails (in green in the graphic: the Los Gatos, Guadalupe, Fwy-87, and Three Creeks Trails). These trails are and will be important transportation corridors to provide access to the Diridon Station. They will need to be accommodated in the construction plans.
- Diridon will become a major transportation node, combining CalTrain and HSR in with other regional services (Amtrak, Capitol Corridor, and Altamont Corridor Express – ACE), VTA Light Rail, bus, future BART, and freight service. The station serves event-goers at the nearby SAP Arena, and commuters both now and soon to the planned Google Village. The Station will need to be sized to serve all, and there may not be the real estate available to accommodate HSR service at-grade: you may need to “build up” – which would pair well with an elevated electrified CalTrain line.
- With elevated tracks at Diridon, it’s important to the northern neighbors that the tracks descend back to grade before reaching the residential communities: choose the “quick descent” alternative and touch down at the CalTrain Central Equipment Maintenance and Operations Facility (CEMOF) rather than the “long descent” alternative that had proposed to first touch down in the city of Santa Clara.
- The aesthetic design of the elevated structure will be critical. San Jose already feels “divided” by the downtown earthen bulwarks of Fwy 87 and the existing CalTrain and freight tracks: an elevated HSR must not further divide the city, either physically by restricting access or visually with ugly or bulky structures.
- And in southern San Jose: be aware that the tracks pass across a sensitive wildlife corridor by Tulare Hill (near Metcalf Road), north of Morgan Hill. This is nature’s passageway between the Santa Cruz Mountains and the Diablo Range: it helps keep the wildlife populations from becoming isolated and in-bred. As you make needed improvements in the tracks, be aware of the need to accommodate these wildlife crossings, either by providing adequate undercrossing or overcrossings. Do not build an at-grade intrusion barrier between the tracks.

My recommendation:

Proceed with the 2018 Business Plan for CalTrain electrification and the blending of High Speed Rail at Gilroy, but only if the Plan includes the timely construction of the elevated structure within the Freeway 87/280 Right-of-Way between Tamien and Diridon for both electrified CalTrain and the future HSR service, and only if adequate measures are taken to protect adjacent neighborhoods, crossing trails, and wildlife corridors.

**NOTIFICATION OF APPLICATION FILED BY GREAT OAKS WATER COMPANY
FOR A RATE INCREASE APPLICATION NO. 18-07-002**

On July 2, 2018, Great Oaks Water Company (Great Oaks) filed an application (A.18-07-002) with the California Public Utilities Commission (CPUC) to increase rates for providing water service. To justify this increase for the years 2019-2022, Great Oaks has presented an estimate of its costs in a formal CPUC proceeding called a General Rate Case (GRC) application. The CPUC requires water companies to submit a GRC application every three years to ensure their water rates accurately reflect the cost of providing water. For Great Oaks a rate year is July 1 through June 30 of the following year. The requested increase in the revenue requirement under A.18-07-002, if authorized, would take effect on July 1, 2019.

Customer Impact

Great Oaks filed a GRC application requesting authority for increases in revenues of \$3,480,305 (18.18%) in 2019, \$1,689,521 (7.47%) in 2020, and \$1,576,419 (6.48%) in 2018. Actual rate increases for 2020/2021 and 2021/2022 will be determined through escalation factors.

Great Oaks has also proposed a new rate design that would include all fixed costs in the monthly service charge and all variable costs in the quantity charge. At present, only fifty percent of fixed costs are recovered through the monthly service charge, and all other costs are recovered through the quantity charge.

Proposed meter service and quantity charges for all three years are shown in the table below.

The proposed increase for customer bills, based upon an average use of 11 ccf of water usage per month by a single-family residential customer with a 5/8 x 3/4-inch meter is \$15.82 for 2019/2020, \$7.79 for 2020/2021, and \$7.26 for 2021/2022. Percentages and a comparison of a typical single-family residential customer bill under current rates and rates projected for each of the three years included in Great Oaks' GRC, is shown below. **The impact on any particular customer's bill will depend upon the customer's actual water usage and meter size as well as any other rate changes or surcharges/surcredits in effect at the time.**

Reasons for Request

The requested increase will enable Great Oaks to pay all projected operating and capital projects expenses during the rate years listed above. Certain operating expenses for existing operations have increased and other operating expenses will be incurred as a result of changes in existing operations or because of proposed new operations, all as detailed in the application and its accompanying supporting exhibits.

The CPUC's Process

This application will be assigned to an Administrative Law Judge (Judge) who will determine how to receive evidence and other related documents, necessary for the CPUC to establish a record upon which to base its decision. Evidentiary Hearings (EHs) may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These EHs are open to the public, but only those who are parties of record can participate. After considering all proposals and all evidence presented during the formal hearing process, the assigned Judge will issue a proposed decision determining whether to adopt all or part of Great Oaks request, modify it, or deny it. The CPUC Commissioners may sponsor an alternate decision and the issue will be decided at a scheduled Commission Voting Meeting.

As a party of record, the Office of Ratepayer Advocates (ORA) will review this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering. Other parties of record may also participate in the CPUC's proceeding to consider this application. Dear city govt. of San Jose,

I first sent something of this letter, below, Monday July 2, 2018. I feel I should send it again, as reminder of what I find important, at this time.

It was described at city council, Tuesday June 26, 2018, by city attorney R. Doyle, that federal govt. laws, can take clear precedents, over local laws, in many legal areas.

This includes federal govt. precedence, with telecommunication questions, and with the future issues, of small cells in San Jose.

But I feel, at the local level, there can be plenty of legal examples, where the health and welfare, of a local community, and its people, and its day to day needs, must sometimes take a legal precedence, if needed.

As an example, the Washington D.C area, is often considered, a federal area of jurisdiction, that can include, a wide area around it, to be federally protected, in its national security and other needs.

But the city and people, of Baltimore MD, and other cities, around the Washington D.C. area, after unrest, protests, demands, and with the bad habits of fifteen years of war, were still having a difficult time, being allowed a certain accountability, at the local level.

For their own community well-being, they are now learning, how to ask, simple, legal questions, for better communication and understandings, from state and federal authorities, when needed.

I think state and federal authorities, are responding well to this thinking, from the local level.

This can make for important lessons, in many projects, of the San Jose city govt, at this time. And, offers important ideas, in how to re- build, and better respect the concepts, of local democracy, community sustainability, and the term, we are all san jose.

The city of San Jose Airport Big Belly, probably has many, county, state and federal authorities, to answer to.

The VTA, has continually tried to offer, a simple, legal position, they have minimal use of tech., with their VTA Big Belly Project.

And, what could be, a more intense amplitude, or exponentially doubling the number of, RF radio waves, using Broadband Stationpoint Wi-Fi.

Stationpoint RF tech., and how it may be different than simple, RF Wi-Fi, is a subject, I would like to learn, how to talk about, more, with yourselves.

The VTA has hired a private consultant. With local cities, and other govt. agencies, they plan together, what tech and apps. would be applicable, for the Big Belly.

Who pays for these tech apps, and do local cities, go through a public process, first I hope you are learning, how to safely admit, there can at least be, small amounts of tech. within some of the Big Belly's, at the VTA Transit Centers, and the city of San Jose, airport.

If nothing else, this should be a time, to learn not be fearful, in how to talk about, helpful, good, or new organizational examples, in ideas of accountability and sustainability.

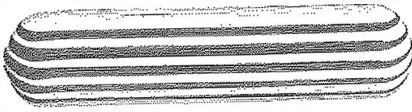

Summary

On June 1, 2018, Pacific Gas and Electric Company (PG&E) filed its 2019 Energy Resource Recovery Account (ERRA) Forecast Application with the California Public Utilities Commission (CPUC) requesting approval to change rates for the following:

- Recovery of \$2.7 billion in costs related to the fuel needed to produce electricity as well as costs of buying energy from third parties
- Setting certain charges for departing load customers, including the Power Charge Indifference Adjustment (PCIA), Ongoing Competition Transition Charge (CTC) and Cost Allocation Mechanism (CAM)
- Return of \$314 million to eligible customers for the sale of GHG emission allowances (including the California Climate Credit for residential customers)

Exact amounts are subject to change and CPUC regulatory approval. PG&E will provide the CPUC with updated amounts later in the year to ensure the most current information is used to set customer rates.

Background

The ERRA is used to record fuel and purchased power costs which can be recovered in rates. While this may result in a change in rates, PG&E recovers these costs with no mark up for return or profit. The purpose of this application is to forecast costs of obtaining energy for customers and also to approve the amount to be returned to customers from the sale of GHG emission allowances for the calendar year of 2019. If the CPUC approves this application, PG&E will begin to recover its costs in electric rates effective January 1, 2019. At the end of 2019, PG&E will compare actual costs to the amounts forecasted in this application and will incorporate any differences in next year's application.

How will PG&E's Application affect me?

Most customers receive bundled electric service from PG&E, meaning they receive electric generation, transmission and distribution services. A summary of the rate impact by customer class was provided in the original bill insert sent to customers in June and July.

Based on rates currently in effect, the bill for a typical residential Non-CARE customer using 500 kWh per month would decrease from \$111.59 to \$106.43 or 4.6 percent. Actual impacts will vary depending on energy usage. Twice a year, in April and October, eligible residential customers will also receive a California Climate Credit in the amount of approximately \$29.15. The annual credit amount will be approximately \$58.30.

How will PG&E's Application affect non-bundled customers?

Direct Access (DA) and Community Choice Aggregation (CCA) customers only receive electric transmission and distribution services from PG&E. PG&E does not purchase energy for these customers. However, this application addresses the cost of transporting energy for these customers through PG&E's electrical system using the PCIA, CTC and CAM. Residential DA/CCA customers also receive the benefit of the California Climate Credit. In addition, eligible non-residential DA and CCA customers receive the benefit of the GHG allowance returns. The impact of PG&E's application on these customers is an average increase of 2.0 percent.

Another category of non-bundled customers is Departing Load. These customers do not receive electric generation, transmission or distribution services from PG&E. However, these customers are required to pay certain charges by law or CPUC decision, including the PCIA, CTC and CAM. The impact of PG&E's application on these customers is an average decrease of 2.3 percent.

Summary

On July 11, 2018, Pacific Gas and Electric Company (PG&E) filed its Residential Rate Reform Memorandum Account (RRRMA) proposal with the California Public Utilities Commission (CPUC). The proposal requests approval to increase rates for the following activities related to residential rate reform:

- Simplification of rate structure
- Offering new Time-of-Use Rate plan options and conducting a pilot
- Increase minimum bill amounts in order to reduce bill volatility
- Enhanced communications to customers about rate plan changes and options

In order to implement these residential rate reforms required by a CPUC decision, PG&E is requesting \$20.5 million to be collected from customers in rates starting early in 2019 or shortly thereafter depending on the schedule for this proposal.

Background

In 2015, the CPUC launched its residential rate reform efforts to address concerns about customer bill impacts and volatility caused by the five-tiered rate structure that was put into place after the California Energy Crisis. As part of this effort, the CPUC directed utilities to implement rate design reforms, including Time-of-Use pilots and studies, marketing, education and outreach, IT, data analysis and other reasonable costs required to implement the decision. The CPUC also ordered each utility to create a Residential Rate Reform Memorandum Account to be used for tracking these costs. This proposal requests recovery of the costs included in the RRRMA in 2015 and 2016.

How will PG&E's proposal affect me?

Most customers receive bundled electric service from PG&E, meaning they receive electric generation, transmission and distribution services. Based on rates currently in effect, the bill for a typical residential NonCARE customer using 500 kWh per month would increase from \$111.59 to \$111.78, or 0.2 percent. Actual impacts will vary depending on energy usage.

How will PG&E's proposal affect nonbundled customers?

Direct Access and Community Choice Aggregation customers only receive electric transmission and distribution services from PG&E. The impact of PG&E's proposal on these customers is an average increase of 0.2 percent.

Another category of nonbundled customers is Departing Load. These customers do not receive electric generation, transmission or distribution services from PG&E. However, these customers are required to pay certain charges by law or CPUC decision. The impact of PG&E's proposal on these customers is an average increase of 0.07 percent.

Pursuant to Rule 2.6 of the Rules of Practice and Procedure (“Rules”) of the California Public Utilities Commission (“Commission”), FlixBus, Inc. (“FlixBus”) submits the following Reply to the Response of the San Francisco Municipal Transportation Agency on Application No. A.18-02-001 (“Response”) filed by The San Francisco Municipal Transportation Agency (“SFMTA”).

I. SUMMARY

FlixBus is committed to working with local public transit agencies and this Commission to preserve the integrity and efficiency of local public transit operations. FlixBus is also committed to maintaining safe, inviting, and unencumbered flows for pedestrians, bicyclists, and vehicles. To that end, FlixBus welcomes the Response of the San Francisco Municipal Transportation Agency (“SFMTA”) and appreciates the opportunity to learn more about SFMTA’s specific concerns it raises. FlixBus is confident that SFMTA’s Response resonates with the commitments to safety, transparency, and collaboration that FlixBus made in its original Application, and looks forward to the opportunity to reiterate and collaboratively address some of those commitments in this Reply, and its implementation of bus service in San Francisco and California more broadly.

As the public transit operator for the City and County of San Francisco (“City”), SFMTA wishes to ensure that public transit service operated by the SFMTA can continue to operate safely and unimpeded by the operations of FlixBus and its Bus Partners. Thus, in its Response, the SFMTA requests that any certification issued to FlixBus by the Commission include the following conditions:

- (1) that FlixBus vehicles operating in San Francisco stop only in safe and legal locations when loading or unloading passengers;
- (2) that FlixBus vehicles in San Francisco be required to comply with the street restrictions established under San Francisco Transportation Code Sections 501 and 503; and
- (3) that FlixBus drivers driving on routes that operate on San Francisco streets view the SFMTA’s Large Vehicle Urban Driving Safety Video.

Given FlixBus’s commitment to safety and collaboration with local public transit operators, FlixBus has already been in contact with SFMTA staff prior to the submission of its Application and is committed to addressing all of the concerns raised by SFMTA, as well as

building and maintaining a collaborative and productive working relationship. It is our hope that SFMTA and FlixBus can work together to serve the needs of the City and its residents and visitors by providing affordable, clean, efficient, and environmentally-friendly transportation service to San Francisco and beyond.

II. FLIXBUS REPLY

a. Stop Locations

Through on-going communication with SFMTA's Sustainable Streets Planning Division, FlixBus has been advised to apply for a stop on the south side of Townsend St. between 5th St and 6th St. This location was identified as one where the flow of public transit vehicles, bicyclists, pedestrians, and other vehicles would not be negatively impacted by FlixBus or its Bus Partners. Additionally, the immediately adjacent curb area is already used for the loading and unloading of passengers by several similar intercity bus operators. FlixBus has submitted an application for a tour bus-only white zone at this location, which is precisely located at the south side of Townsend from 8 to 66 feet east of 5th Street (service request #8720008). FlixBus does not anticipate that its vehicles will make other stops within the City, and it will seek approval from SFMTA or the relevant authority prior to establishing alternative stops.

b. Restricted Streets

It is the intent of FlixBus to comply fully with the street restrictions established under San Francisco Transportation Code Sections 501 and 503. In order to achieve this, FlixBus, Inc. will plan its vehicle routing to avoid these streets with "Street Restrictions", as expressed in Sections 501 and 503 of the City's Transportation code. The GPS guiding devices aboard all concerned buses will be manually updated to expressly forbid the concerned areas.

Moreover, the applicant will enforce this through GPS tracking of every bus on its network through on-board GPS hardware, which is monitored by a dedicated team in FlixBus's Traffic Control department with real-time traffic monitoring and dispatch functions.

c. Safety Training

FlixBus, Inc. will incorporate SFMTA's Large Vehicle Urban Driving Safety Video into the training program for drivers operating on routes using San Francisco streets.

FlixBus and its Bus Partners are fully committed to safety. FlixBus has an outstanding record in matters of safety. This begins with rigorous vetting and auditing of its Bus Partners' processes as well as in-person, unscheduled controls and inspections of all driving equipment on a very regular basis. Well-rested and alert drivers are the strongest pre-requisite for safety. FlixBus views this not merely as legal compliance, but central to its mission and successful delivery of customer. To this end, FlixBus has imposed internal best practices, which go above and beyond state and federal requirements. One example of where FlixBus, Inc. sets itself apart is that all overnight buses are required to be staffed with 2 drivers. (See also, Application, parts 12-13 and Exhibit H.)

FlixBus, Inc.'s buses feature the latest electronic driver assistance systems to ensure passenger safety. Features such as electronic stability control, emergency brake assistance, lane assistance, adaptive cruise control, ambient light sensors, clearance lights and more are standard safety features on FlixBus buses. FlixBus and its Bus Partners' drivers will be certified for the safety technology used on board its buses.

In order to qualify to drive on a FlixBus route, drivers will need to hold a valid Class B Commercial Driver's License (CDL), complete a dedicated FlixBus safety training, and have driven a minimum amount of 6,500 miles on same or similar vehicles. As part of its commitment to safety, FlixBus, Inc. ensures that drivers are continually informed of changes and updates to best safety practices. Additionally, drivers are required to periodically participate in a behind-the-wheel safer drivers course, driver training on a bus simulator, as well as in-classroom safe driving theory courses. FlixBus appreciates the opportunity to now also incorporate SFMTA's Large Vehicle Urban Driving Safety Video into the training program for drivers operating on routes using San Francisco streets.


III. CONCLUSION

FlixBus looks forward to serving in the City and working collaboratively with SFMTA to ensure that FlixBus and its Bus Partners fully meet the conditions specified in SFMTA's comments on our Application. Namely, (1) that FlixBus vehicles operating in San Francisco stop only in safe and legal locations when loading or unloading passengers; (2) that FlixBus vehicles in San Francisco be required to comply with the street restrictions established under San Francisco Transportation Code Sections 501 and 503; and (3) that FlixBus drivers on routes that operate on San Francisco streets view the SFMTA's Large Vehicle Urban Driving Safety Video.

Additionally, FlixBus always aims to inform its passengers about the public transit at their disposals near the stops operated by the company. As part of FlixBus's commitment to the environment, it is our strong intent to encourage whenever and wherever possible its passengers to seek to complete its trip by using public transit, and avoiding a car, thus reducing congestion and supporting access to economic and sustainable means of urban transportation.
