**A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN JOSE APPROVING THE RENAMING OF ALL
PROGRAMMABLE DRIVE, A PRIVATE STREET
EXTENDING APPROXIMATELY 1,000 FEET WEST OF
ITS INTERSECTION WITH UNION AVENUE, TO LOGIC
DRIVE**

WHEREAS, the applicant, Xilinx, Inc., has submitted an application with the Department of Planning, Building and Code Enforcement requesting to rename All Programmable Drive, a private street extending approximately 1,000 feet west of its intersection with Union Avenue, to Logic Drive; and

WHEREAS, a map depicting the approximately 1,000-foot long private Street, All Programmable Drive, located west of Union Avenue, is attached hereto as Exhibit "A" and incorporated fully herein by this reference; and

WHEREAS, pursuant to City Council Policy 6-5 entitled "Street Naming and Renaming" ("Council Policy 6-5"), the City Council is responsible for the naming and renaming of public streets, boulevards, avenues, drives, courts, circles, and other public and private rights-of-way; and

WHEREAS, All Programmable Drive is an existing private street extending 1,000 feet west of Union Avenue; and

WHEREAS, on August 22, 2017, the City Council adopted Resolution No. 78319 approving the renaming of Logic Drive to All Programmable Drive, as requested by Xilinx, Inc., based on the reason that the company was the single occupant and the owner of all parcels currently accessed from Logic Drive, that Xilinx, Inc. uses the street

name, "All Programmable Drive" at its other corporate campuses, and that no other property owners or tenants were affected by the name change and there was no through traffic or access from adjacent properties; and

WHEREAS, Xilinx, Inc., is still the owner of all parcels that are currently accessed from All Programmable Drive, there is still no through traffic or access from adjacent properties, but Xilinx, Inc., is no longer the single occupant; and

WHEREAS, pursuant to Council Policy 6-5, the Department of Planning, Building and Code Enforcement determined the proposed renaming of All Programmable Drive to Logic Drive is a renaming of a minor private street and therefore, subject to a more streamlined process since not more than twenty (20) occupied parcels are affected by the proposed renaming; and

WHEREAS, pursuant to the Council Policy on Public Outreach 6-30, Xilinx, Inc., posted a sign at the site notifying the public of the proposed street renaming and identifying how to obtain additional information or submit comments, and received no public comments; and

WHEREAS, pursuant to and in accordance with Chapter 20.100 of Title 20 of the San José Municipal Code, this City Council conducted a hearing on said application, notice of which was duly given; and

WHEREAS, as said hearing this City Council gave all persons full opportunity to be heard and to present evidence and testimony respecting said matter; and

WHEREAS, as said hearing, this City Council received and considered all of the comments, reports and recommendations of the City's Director of Planning, Building and Code Enforcement; and

WHEREAS, pursuant to provisions of Section 15061(b)(3) Review for Exemption of the State Guidelines for Implementation of the California Environmental Quality Act of 1970 (CEQA), this project is found to be exempt from the environmental review requirements of Title 21 of the San José Municipal Code, implementing CEQA, as amended;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1: Pursuant to the provisions of Section 34091.1 of the Government Code of the State of California and Council Policy 6-5, this Council does hereby find and determine that the approximately 1,000-foot private street, All Programmable Drive, as indicated on Exhibit "A" hereto, shall be renamed from "All Programmable Drive" to "Logic Drive" located in the City of San José, and that said City Council does hereby rename said street upon the date of adoption of this Resolution.

SECTION 2: The City Clerk is hereby directed to deliver a copy of this resolution to the Board of Supervisors of the County of Santa Clara.
